The Receivership Proceedings:

- (a) on February 25, 2016, the Company became subject to these receivership proceedings pursuant to an Order granted by the Honourable Mr. Justice B.J. Scherman (the "Receivership Order");
- (b) pursuant to the Receivership Order, the Receiver was authorized to, *inter alia*, market any or all of the Property (as defined in the Receivership Order), sell the Property or any parts thereof, and apply for any vesting order necessary to convey the Property or any parts thereof, free and clear of any liens or encumbrances;
- (c) on May 2, 2016, the Receiver obtained court approval of the sales procedures (the "Sales Procedures") set out in the First Report of the Receiver filed April 11, 2016 (the "First Report");
- (d) since receiving the Court's approval of the sales procedures, the Receiver has conducted an extensive marketing process, as described in detail in the Second

Report, in order to sell the business of the Company on a basis which maximizes any proceeds of sale;

The MLD Agreement:

- (e) PDI and Med-Life Discoveries LP by its general partner Med-Life Discoveries GP Inc. ("MLD") entered into the MLD Agreement made effective June 30, 2015;
