AFFIDAVIT OF DAPHNE MACKENZIE

I, Daphne MacKenzie, of the City of Toronto, in the Province of Ontario,
MAKE OATH AND SAY

1. I am a Partner in the law firm of Stikeman Elliott LLP ("**Stikeman Elliott**"), solicitors for FTI Consulting Inc. ("**FTI**"), in its capacity as the court appointed monitor of Canwest Global Communications Corp. ("**Canwest Global**"), and, as such, I have knowledge of the matters to which I hereinafter depose.

2. Canwest Global and certain of its subsidiaries listed in Schedule "A" hereto (collectively the "**Applicants**") obtained protection from their creditors under the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "**CCAA**"). The Initial Order also granted relief in respect of certain affiliated partnerships of the Applicants listed in Schedule "B" hereto (collectively, the "**Partnerships**", and together with the Applicants, the "**CMI Entities**") and appointed FTI as monitor (the "**Monitor**") of the CMI Entities. The proceedings commenced by the CMI Entities under the CCAA will be referred to herein as the "**CCAA Proceedings**".

3. This affidavit is made in support of a motion for, *inter alia*, the approval of the fees and disbursements the Monitor and its legal counsel Stikeman Elliott for the period from October 6, 2009 to December 31, 2009.

4. During the period from October 6, 2009 to December 31, 2009 Stikeman Elliott docketed 1,096.25 hours in respect of the CCAA Proceedings, amounting to legal fees in the amount of \$596,255.05 and disbursements and other charges in the amount of \$21,186.89 plus Goods and Services Tax ("GST") of \$30,831.28. Attached and marked collectively as **Exhibit "A"** to this affidavit are true copies of the accounts rendered by Stikeman Elliott to the Monitor in connection with the CCAA Proceedings for the period from October 6, 2009 to December 31, 2009, redacted for confidential information.


