LOCATION OF HEARING: Calgary, Alberta

UPON the application of Ridley Terminals Inc. ("**RTI**"), filed May 21, 2021, and the related application of Coalspur Mines (Operations) Ltd. ("**Coalspur**"), filed May 25, 2021 (the "**Applications**"); **AND UPON** Coalspur and RTI requesting this Court's direction regarding a schedule for the Applications; **AND UPON** hearing from counsel for RTI, Coalspur and FTI Consulting Canada Inc., in its capacity as Court-appointed Monitor of Coalspur (the "**Monitor**"); **IT IS HEREBY ORDERED THAT:**

1. The Applications will be heard by this Honourable Court on July 9, 2021 commencing at 10:00 a.m MDT.
2. The following litigation schedule is established with respect to the Applications:
 - (a) Messrs. Dixon and Booker shall be questioned on their respective Affidavits sworn in the within proceedings on June 3, 2021 commencing at 10:00 a.m. MDT by videoconference;
 - (b) Coalspur shall serve the Service List established in these proceedings with the evidence on which it intends to rely at the hearing of the Applications on or before June 8, 2021;
 - (c) Questioning, if any, on the evidence filed by Coalspur shall take place on June 17, 2021 by videoconference commencing at a time to be agreed upon by Coalspur and RTI; and
 - (d) All Briefs of Argument shall be filed concurrently at or before 4:30 p.m. MDT on July 2, 2021.
3. Coalspur and RTI may, on notice to the other party and the Monitor, request further advice or direction from this Court regarding any issues which may arise with respect to the filing of additional evidence or the completion of further questioning apart from that provided in paragraph 2 above.
4. Coalspur has leave to file a further application for an extension of the Stay Period (as defined in the Amended and Restated Initial Order granted May 6, 2021) and such further and other relief as Coalspur deems necessary to advance these CCAA proceedings, which application shall be heard by this Honourable Court concurrent with the Applications on July 9, 2021. Such application and any supporting evidence shall be filed and served in accordance with Q.B. Commercial Practice Note No. 1.
