FIRST REPORT TO THE COURT SUBMITTED BY FTI CONSULTING CANADA INC. IN ITS CAPACITY AS TRUSTEE

INTRODUCTION

1. On September 14, 2016, Golf Town Canada Holdings Inc. ("GT Holdings"), Golf Town Canada Inc. ("GT Canada") and Golf Town GP II Inc. ("GT GP") (collectively, the "CCAA Applicants") made an application under the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the "CCAA"), and an initial order (as amended, the "Initial Order") was made by the Honourable Mr. Justice Newbould of the Ontario Superior Court of Justice (Commercial List) (the "Court") granting, among other things, a stay of proceedings against the CCAA Applicants (the "Stay of Proceedings") and appointing FTI Consulting Canada Inc. ("FTI") as monitor (the "Monitor"). The benefit of the protections and authorizations provided by the Initial Order were also extended to Golf Town Operating Limited Partnership ("GTOLP") and Golfsmith International Holdings LP ("GS LP" and, together with the CCAA Applicants and GTOLP, the "CCAA Entities"). The proceedings commenced by the CCAA Applicants under the CCAA are referred to herein as the "CCAA Proceedings".

- 2. On September 30, 2016, the Court granted an Approval and Vesting Order approving the sale of the CCAA Entities' business (the "Golf Town Transaction") pursuant to the terms of a Purchase Agreement dated September 14, 2016 (the "Purchase Agreement") among GT Canada and GTOLP, as sellers (collectively, the "Vendors"), and Golf Town Limited (formerly 9918167 Canada Inc.) (the "Purchaser"), an entity owned by Fairfax Financial Holdings Limited and certain investment funds managed by CI Investments Inc., as purchaser.
- 3. In accordance with the Purchase Agreement, on October 31, 2016, the Golf Town Transaction was successfully completed and the Monitor delivered the Monitor's Certificate confirming that the Golf Town Transaction had closed.
- 4. Over the course of the CCAA Proceedings, the Stay of Proceedings was extended a number of times. Most recently, pursuant to an order of the Court dated March 29, 2018 (the "CCAA Termination Order"), the Stay of Proceedings was extended to the earlier of the following: (i) the filing of a certificate by the Monitor confirming that all matters and proceedings in respect of the CCAA Entities had been completed (the "CCAA Termination Date"); and ii) May 31, 2018. Please refer to Appendix A for a copy of the CCAA Termination Order and Appendix B for the Eighth Report of the Monitor dated March 22, 2018 (the "Eighth Report of the Monitor"), which was issued in support of, among other things, the CCAA Termination Order
- 5. The CCAA Termination Order provided for the following:
 - a. authorized and directed the Monitor to hold a reserve of funds from the proceeds of the CCAA Entities' estate (the "Reserve") in an amount determined by the Monitor, which, among other things, shall be appropriate in the circumstances to ensure the availability of sufficient funds to undertake and complete an orderly wind-down of the CCAA Entities and the CCAA Proceedings and all ancillary activities in connection therewith including any assignments in bankruptcy in respect of the CCAA Entities pursuant to the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the "BIA");
 - b. authorized and directed the Monitor to distribute the remaining proceeds of the Golf Town Entities' estate to BNY Trust Company of Canada, in its capacity as Canadian cotrustee under the indenture (the "Secured Notes Indenture") pursuant to which the

Company's 10.50% senior secured second lien notes maturing on July 24, 2018 (the "Secured Notes") were issued;

- c. authorized: (i) the CCAA Entities, in their discretion or at the discretion of the Monitor, to make an assignment in bankruptcy pursuant to the BIA on or after the CCAA Termination Date; and (ii) the Monitor to file any such assignment in bankruptcy for an on behalf of the CCAA Entities and to take any steps reasonably incidental thereto; and,
- d. authorized FTI to act as trustee in bankruptcy in respect of any of the CCAA Entities that makes an assignment in bankruptcy pursuant to the BIA.
- 6. As of the date of this First Report to the Court (the "**First Report**"), the Reserve contained approximately \$0.65 million.
- 7. As described in the Eighth Report of the Monitor, the noteholders holding the Secured Notes face a significant deficiency on their claims and are projected to receive an aggregate recovery of approximately 13% of the principal amount of the Secured Notes. As of the CCAA Termination Date, approximately \$109 million remained outstanding under the Secured Notes Indenture.
- 8. Each of the CCAA Entities filed an assignment in bankruptcy on one of the following dates:
 - a. May 31, 2018 GT Canada, GT Holdings, and GT GP; and,
 - b. June 4, 2018 GTOLP and GS LP.
- 9. In addition to the CCAA Entities, Golfsmith International Holdings GP Inc. ("GS Holdings" and together with the with the CCAA Entities, the "Golf Town Entities") filed an assignment in bankruptcy on May 31, 2018). GS Holdings is the general partner of GS LP, which holds, directly or indirectly, all of the beneficial ownership interest in the CCAA Entities. As a result of the financial circumstances of its direct and indirect subsidiaries, including the absence of any assets or source of funding, GS Holdings is experiencing financial difficulties and is no longer able to meet its obligations as they generally become due. On May 29, 2018, a resolution of the board of directors of GS Holdings authorized and directed a voluntary assignment in bankruptcy

- pursuant to the BIA, and approved FTI Consulting Canada Inc. ("FTI") to act as trustee in connection with the voluntary assignment in bankruptcy, subject to approval by its creditors.
- 10. FTI was appointed as trustee in bankruptcy (the "**Trustee**") of each of the Golf Town Entities pursuant to certificates of appointment issued by the Office of the Superintendent of Bankruptcy Canada on May 31, 2018, and June 4, 2018, respectively. Please refer to Appendix C for a copy of each of the certificates of appointment.
- 11. The First Report is filed to provide the Court with additional information regarding the Golf Town Entities and to support the Trustee's motion for an order (the "**Procedural Consolidation Order**") providing for the following:
 - a. a procedural consolidation of the bankrupt estates of the Golf Town Entities; and,
 - b. approval to use funds in the Reserve established by the Monitor in the CCAA Proceedings to undertake and complete the orderly wind-down of GS Holdings and its bankruptcy proceeding.
- 12. In preparing this First Report, the Trustee has relied upon audited and unaudited financial information of the Golf Town Entities, the Golf Town Entities' books and records, certain financial information and forecasts prepared by the Golf Town Entities, and advisors to the Golf Town Entities (collectively, the "Information"). To the extent necessary and appropriate, the Trustee has also reviewed audited and unaudited financial information and forecasts of the Golf Town Entities' U.S. affiliate, Golfsmith International Holdings, Inc. and its wholly-owned subsidiaries and Golf Town USA, L.L.C.
- 13. The Trustee has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information. Accordingly, the Trustee expresses no opinion or other form of assurance on the Information contained in this First Report or relied on in its preparation. Future-oriented financial information reported or relied on in preparing this First Report is based on the Company's assumptions regarding future events; actual results may vary from the forecast and such variations may be material.
- 14. All references to monetary amounts in this report are in Canadian dollars unless otherwise noted.



A. BACKGROUND

- 15. A simplified corporate organization chart (the "Corporate Chart") indicating the corporate structure of the Golf Town Entities is attached as Appendix D.
- 16. All of the beneficial interest in the CCAA Entities are held, directly or indirectly, by GS LP, a Canadian Limited Partnership. The general partner of GS LP is GS Holdings, a corporation incorporated under the laws of Ontario.
- 17. GS LP owns 100% of the beneficial interest in GT Holdings, a corporation incorporated under the laws of Ontario, which in turn owns 100% of the issued shares of GT Canada. GT Canada is incorporated under the laws of Canada and is the Canadian issuer of the Secured Notes.
- 18. The primary operating entity of the Golf Town Entities was GTOLP, an Ontario limited partnership. The limited partner of GTOLP is GT Canada. The general partner of GTOLP is GT GP, which is incorporated under the laws of Ontario and is a wholly-owned subsidiary of GT Canada.

B. PROCEDURAL CONSOLIDATION OF PROCEEDINGS

- 19. There are no assets in any of the bankrupt estates of the Golf Town Entities, and therefore, there are insufficient assets available to satisfy the claims of the Golf Town Entities' general unsecured creditors. To the extent possible, the Trustee is seeking to minimize the cost of administering the bankrupt estates. The first meeting of creditors for each of the bankrupt estates has been set for June 18, 2018.
- 20. To that effect, the Trustee is requesting that the Court grant a procedural consolidation of the Golf Town Entities' bankrupt estates to avoid performing, *inter alia*, the following actions in respect of each of the bankrupts:
 - a. convening and conducting six separate first meetings of creditors;
 - b. appointing six separate groups of inspectors;
 - c. issuing six separate reports in respect of the Golf Town Entities' bankrupt estates; and

- d. making, filing, advertising and distributing any required materials or forms under the BIA going-forward in relation to all six entities separately.
- 21. Subsection 43(16) of the BIA provides for the possibility of consolidation of bankruptcy proceedings against different partners in the same partnership. While there is no specific provision in the BIA addressing procedural consolidation of other types of estates, the Court has granted procedural consolidation of other types of estates in the past pursuant to its inherent equitable jurisdiction where there is no prejudice to creditors.
- 22. A procedural consolidation of the Golf Town Entities' bankrupt estates will enable the Trustee to administer the estates as one and to take the actions described in the paragraph above only once, significantly reducing the costs of administration.
- 23. A procedural consolidation will not result in prejudice to the Golf Town Entities' creditors, and creditors will be asked to specify a particular entity or entities against which their claim will be filed in their proofs of claim.

C. FUNDING FOR THE GS HOLDINGS BANKRUPTCY

- 24. Although GS Holdings was not one of the CCAA Applicants s, GS Holdings, via its board of directors, continued to govern and oversee the Golf Town Entities during the CCAA Proceedings,¹ and its involvement assisted with the successful completion of the Golf Town Transaction. As a result, the CCAA Entities received a significant benefit during the CCAA Proceedings from their relationship with GS Holdings.
- 25. The CCAA Termination Order permits the Reserve to be used to undertake and complete the orderly wind-down of the CCAA Entities and the CC, including any assignments in bankruptcy. However, given that GS Holdings was not one of the CCAA Entities, it currently does not have access to the Reserve in order to facilitate its orderly wind-down.
- 26. The Trustee is requesting that the Court authorize the Monitor to utilize the Reserve, if required, to fund the administration of the bankrupt estate of GS Holdings. Given that GS

¹ As of the date of bankruptcy, there were no directors or officers of any of the Golf Town Entities, including GS Holdings, as a result of their resignation immediately prior to the filing of the Golf Town Entities' bankruptcies.

Holdings is a holding company with no assets and no material obligations, the cost of

administering its estate is expected to be nominal.

27. The ability of the Monitor to use the Reserve for this purpose is consistent with the establishment

of the Reserve under the CCAA Termination Order, which provides that the Reserve may be

used to complete the orderly wind-down of the Golf Town CCAA Proceedings and all ancillary

activities in connection therewith.

D. RECOMMENDATIONS OF THE TRUSTEE

28. For the reasons set out above, the Trustee is of the view that the relief requested is reasonable

and respectfully requests that this Court grant the Procedural Consolidation Order.

The Trustee respectfully submits this First Report to the Court.

CCAA TERMINATION ORDER

THIS MOTION made by Golf Town Canada Holdings Inc., Golf Town Canada Inc. ("GT Canada"), Golf Town GP II Inc., Golfsmith International Holdings LP and Golf Town Operating Limited Partnership (collectively, the "Golf Town Entities"), pursuant to the Companies' Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended (the "CCAA"), was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the affidavit of Brian Cejka (the "CRO") sworn March 22, 2018, the Eighth Report of FTI Consulting Canada Inc. ("FTI") as the Court-appointed Monitor of the Golf Town Entities (the "Monitor") dated March 22, 2018 (the "Eighth Report") and the affidavits sworn in support of the approval of the fees and disbursements of the Monitor and its counsel, and on hearing the submissions of counsel for each of the Golf Town Entities, the Monitor and such other counsel as were present and wished to be heard, and on reading the affidavit of service, filed:

DEFINED TERMS

1. **THIS COURT ORDERS** that capitalized terms used and not otherwise defined herein shall have the meanings given to them in the Initial Order of this Court dated September 14, 2016 (as amended, the "Initial Order").

DISTRIBUTION OF FUNDS

- 2. **THIS COURT ORDERS** that the Monitor is authorized and directed to hold a reserve of funds from proceeds of the Golf Town Entities (the "**Reserve**") from time to time in an amount determined by the Monitor, in consultation with counsel to the Golf Town Entities, which Reserve shall be sufficient for the payment of:
 - (a) any claim secured by the Charges granted by this Court pursuant to the Initial Order;
 - (b) any expense or obligation incurred by the Golf Town Entities that relates to the period from and after the date of the Initial Order or is otherwise payable pursuant to the Initial Order; and
 - (c) any other amounts appropriate in the circumstances to ensure the availability of sufficient funds to undertake and complete the orderly wind-down of the Golf Town Entities and these proceedings and all ancillary activities in connection therewith, including any assignments in bankruptcy in respect of the Golf Town Entities pursuant to the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**").
- 3. **THIS COURT ORDERS** that, notwithstanding anything to the contrary in any other Order of this Court, the Monitor is hereby authorized and directed, subject to the prior written consent of the CRO, to distribute to BNY Trust Company of Canada, in its capacity as Canadian co-trustee (the "**Trustee**") under the Secured Notes Indenture (as defined below), in one or more distributions (each a "**Distribution**" and, collectively, the "**Distributions**"), all funds or proceeds in respect of the Golf Town Entities held by the Monitor in excess of the amount of the Reserve determined at the time of such Distribution, provided that, for greater certainty, the aggregate amount of all Distributions made to the Trustee on behalf of the Golf Town Entities shall not

exceed the aggregate obligations owing by the Golf Town Entities pursuant to the indenture dated as of July 24, 2012, as amended (the "Secured Notes Indenture"), pursuant to which GT Canada and Golfsmith International Holdings, Inc. (collectively with their affiliates, the "Company") issued the 10.50% senior second lien notes due 2018 (the "Secured Notes"). For greater certainty, this paragraph shall apply to all funds or proceeds in respect of the Golf Town Entities that are held by or come into the possession of the Monitor following the CCAA Termination Date (as defined below) (the "Post-Termination Proceeds").

4. **THIS COURT ORDERS** that, notwithstanding:

- (a) the pendency of these proceedings;
- (b) the assignment in bankruptcy or any petition for a bankruptcy order now or hereafter issued pursuant to the BIA and any order issued pursuant to such petition; or
- (c) any provisions of any federal or provincial legislation,

the Distributions shall be binding on any trustee in bankruptcy or receiver that may be appointed and shall not be void or voidable nor deemed to be a preference, assignment, fraudulent conveyance, transfer at undervalue or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall they constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

APPROVAL OF MONITOR'S ACTIVITIES

- 5. **THIS COURT ORDERS** that the activities and conduct of the Monitor prior to or on the date hereof in relation to the Golf Town Entities and these proceedings are hereby ratified and approved.
- 6. **THIS COURT ORDERS** that the reports of the Monitor filed to date in these proceedings (including the Eighth Report), and the activities and conduct of the Monitor described in each of such reports, are hereby approved.

APPROVAL OF FEES AND DISBURSEMENTS OF THE MONITOR

- 7. **THIS COURT ORDERS** that the fees and disbursements of the Monitor for the period from September 14, 2016 to February 28, 2018, and its fees and disbursements, estimated not to exceed \$60,000, for the completion of remaining activities in connection with these proceedings, all as set out in the affidavit of Paul Bishop sworn March 21, 2018, are hereby approved.
- 8. **THIS COURT ORDERS** that the fees and disbursements of Osler, Hoskin & Harcourt LLP, in its capacity as counsel to the Monitor, for the period from September 1, 2016 to February 28, 2018, and its fees and disbursements, estimated not to exceed \$50,000, for the completion of remaining activities in connection with these proceedings, all as set out in the affidavit of Tracy Sandler sworn March 22, 2018, are hereby approved.

TERMINATION OF CCAA PROCEEDINGS

- 9. THIS COURT ORDERS that upon the filing of a certificate of the Monitor in substantially the form attached hereto as Schedule "A" (the "Monitor's Certificate") confirming that all matters to be attended to in connection with the Golf Town Entities and proceedings in respect of the Company have been completed, the proceedings shall be terminated without any further act or formality (the "CCAA Termination Date"). For greater certainty, the Monitor's Certificate may be filed and the CCAA Termination Date may occur notwithstanding one or more Distributions are expected to occur following the CCAA Termination Date.
- 10. **THIS COURT ORDERS** that the Charges shall be and are hereby terminated, released and discharged as of the CCAA Termination Date. Notwithstanding the foregoing, where the Monitor continues to hold a Reserve at the CCAA Termination Date with respect to a Charge, such Charge, in an amount equal to the corresponding Reserve amount held by the Monitor, shall not be terminated, released or discharged until such time as the corresponding Reserve amount is distributed or released pursuant to the terms of this Order.
- 11. **THIS COURT ORDERS** that each of the Golf Town Entities shall be authorized, in its discretion or at the discretion of the Monitor, to make an assignment in bankruptcy pursuant to the BIA on or after the CCAA Termination Date, and the Monitor is hereby authorized to file any such assignment in bankruptcy for and on behalf of any Golf Town Entity and to take any

steps reasonably incidental thereto. FTI is hereby authorized to act as trustee in bankruptcy in respect of any Golf Town Entity that makes an assignment in bankruptcy pursuant to the BIA.

DISCHARGE OF THE MONITOR

- 12. THIS COURT ORDERS AND DECLARES that effective on the CCAA Termination Date, the Monitor shall be and is hereby discharged as Monitor and shall have no further duties, obligations or responsibilities as Monitor from and after the CCAA Termination Date, provided that, notwithstanding its discharge herein, the Monitor shall remain Monitor for the performance of such incidental or ancillary duties as may be required to complete the administration of the Golf Town Entities' estate or these proceedings following the CCAA Termination Date, including the duty to effect a Distribution of any Post-Termination Proceeds pursuant to the terms of this Order and the discretion to authorize an assignment in bankruptcy pursuant to paragraph 11 hereof.
- 13. THIS COURT ORDERS that, notwithstanding any provision of this Order, the termination of these proceedings or the discharge of the Monitor, nothing herein shall affect, vary, derogate from, limit or amend, and the Monitor shall continue to have the benefit of, any of the rights, approvals and protections in favour of the Monitor at law or pursuant to the CCAA, the Initial Order, any other Order of this Court in these proceedings or otherwise, all of which are expressly continued and confirmed following the CCAA Termination Date, including in connection with any actions taken by FTI following the CCAA Termination Date with respect to the Golf Town Entities or these proceedings.

RELEASE

14. **THIS COURT ORDERS** that (i) the present and former direct and indirect shareholders, directors, officers, employees, legal counsel and advisors of the Golf Town Entities (or any of them) or Golfsmith International Holdings GP Inc., and (ii) the Monitor and its legal counsel (the persons listed in clauses (i) and (ii) being collectively, the "**Released Parties**") are hereby forever irrevocably released and discharged from any and all present and future claims (including, without limitation, claims for contribution or indemnity), liabilities, indebtedness, demands, actions, causes of action, counterclaims, suits, damages, judgments, executions, recoupments, debts, sums of money, expenses, accounts, liens, recoveries, and obligations of

whatever nature or kind whatsoever (whether direct or indirect, known or unknown, absolute or contingent, accrued or unaccrued, liquidated or unliquidated, matured or unmatured or due or not yet due, in law or equity and whether based in statute or otherwise) based in whole or in part on any act or omission, transaction, dealing or other occurrence existing or taking place prior to the CCAA Termination Date or completed pursuant to the terms of this Order in respect of the Company, the business, operations, assets, property and affairs of the Company wherever or however conducted or governed, the administration and/or management of the Company, the Secured Notes Indenture, the Secured Notes and these proceedings (collectively, the "Released Claims"), which Released Claims are hereby fully, finally, irrevocably and forever waived, discharged, released, cancelled and barred as against the Released Parties, provided that nothing in this paragraph 14 shall waive, discharge, release, cancel or bar any claim against the Directors and Officers that is not permitted to be released pursuant to section 5.1(2) of the CCAA.

EXTENSION OF THE STAY OF PROCEEDINGS

15. **THIS COURT ORDERS** that the Stay Period (as defined in and used throughout the Initial Order) be and is hereby extended to and including the earlier of (i) the CCAA Termination Date, and (ii) May 31, 2018.

GENERAL

- 16. **THIS COURT ORDERS** that the Golf Town Entities or the Monitor may apply to the Court as necessary to seek further orders and directions to give effect to this Order.
- 17. **THIS COURT ORDERS** that this Order shall have full force and effect in all provinces and territories in Canada.
- 18. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, the United States, or in any other foreign jurisdiction, to give effect to this Order and to assist the Golf Town Entities and the Monitor and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Golf Town Entities and the Monitor and their respective agents

as may be necessary or desirable to give effect to this Order, or to assist the Golf Town Entities and the Monitor and their respective agents in carrying out the terms of this Order.

EIGHTH REPORT TO THE COURT SUBMITTED BY FTI CONSULTING CANADA INC. IN ITS CAPACITY AS MONITOR

INTRODUCTION

- 1. On September 14, 2016 (the "Filing Date"), Golf Town Canada Holdings Inc., Golf Town Canada Inc. ("GT Canada") and Golf Town GP II Inc. (collectively, the "Applicants") made an application under the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the "CCAA"), and an initial order (as amended, the "Initial Order") was made by the Honourable Mr. Justice Newbould of the Ontario Superior Court of Justice (Commercial List) (the "Court") granting, among other things, a stay of proceedings against the Applicants until October 14, 2016 (the "Stay of Proceedings") and appointing FTI Consulting Canada Inc. as monitor (the "Monitor"). The benefits of the protections and authorizations provided by the Initial Order were also extended to Golf Town Operating Limited Partnership ("Golf Town LP") and Golfsmith International Holdings L.P. ("Holdings LP" and, together with the Applicants and Golf Town LP, the "Golf Town Entities"). The proceedings commenced by the Applicants under the CCAA are referred to herein as the "CCAA Proceedings".
- 2. On September 30, 2016, the Court granted an Approval and Vesting Order (the "Approval and Vesting Order") approving the sale of the Golf Town Entities' business (the "Golf Town Transaction") pursuant to the terms of a Purchase Agreement dated September 14, 2016 (the "Purchase Agreement") among GT Canada and Golf Town LP, as sellers (collectively, the "Vendors"), and Golf Town Limited (formerly 9918167 Canada Inc.)

- (the "Purchaser"), an entity owned by Fairfax Financial Holdings Limited and certain investment funds managed by CI Investments Inc., as purchaser.
- 3. In accordance with the Purchase Agreement, on October 31, 2016, the Golf Town Transaction was successfully completed and the Monitor delivered the Monitor's Certificate confirming that the Golf Town Transaction had closed.
- 4. Over the course of the CCAA Proceedings, the Stay of Proceedings has been extended a number of times. Most recently, on December 12, 2017, the Stay of Proceedings was extended to March 30, 2018 (the "**Stay Period**").
- 5. The purpose of this, the Monitor's Eighth Report (the "**Eighth Report**"), is to provide the Court with information regarding:
 - (a) the Golf Town Entities' and the Monitor's activities since the Monitor's Seventh Report dated December 8, 2017 (the "Seventh Report");
 - (b) the status of the Chapter 11 proceedings (the "Chapter 11 Proceedings") initiated by the Golf Town Entities' U.S. affiliate, Golfsmith International Holdings, Inc. ("Golfsmith International") and its wholly-owned subsidiaries and Golf Town USA, L.L.C. (collectively, the "Golfsmith Entities", and together with the Golf Town Entities, the "Company");
 - (c) the Golf Town Entities' request for an order (the "CCAA Termination Order"):
 - (i) authorizing and directing the Monitor to hold a reserve of funds from the proceeds of the Golf Town Entities' estate (the "Reserve") to provide for the payment of certain amounts in connection with the completion of wind-down matters in connection with the CCAA Proceedings;
 - (ii) authorizing and directing the Monitor to distribute the remaining proceeds of the Golf Town Entities' estate to BNY Trust Company of Canada, in its capacity as Canadian co-trustee (the "Canadian")

Indenture Trustee") under the indenture (the "Secured Notes Indenture") pursuant to which the Company's 10.50% senior secured second lien notes maturing on July 24, 2018 (the "Secured Notes") were issued;

- (iii) providing for the termination of the CCAA Proceedings and the discharge of the Monitor on the date on which the Monitor files a certificate confirming that all matters to be attended to in connection with the Golf Town Entities and the proceedings in respect of the Company have been completed (the "CCAA Termination Date");
- (iv) approving the activities of the Monitor and the fees and disbursements of the Monitor and its counsel, Osler, Hoskin & Harcourt LLP (the "Monitor's Counsel");
- (v) releasing: (i) all current and former direct and indirect shareholders, directors, officers, employees, legal counsel and advisors of the Golf Town Entities and Golfsmith International Holdings GP Inc.; and (ii) the Monitor and the Monitor's Counsel (the persons listed in clauses (i) and (ii) being collectively, the "Released Parties") from all present and future claims and obligations based on any act, omission, transaction, dealing or other occurrence taking place prior to the CCAA Termination Date or completed pursuant to the CCAA Termination Order (the "CCAA Release");
- (vi) extending the Stay of Proceedings to the earlier of: (i) the CCAA Termination Date; and (ii) May 31, 2018; and
- (d) the financial status of the Golf Town Entities.
- 6. In preparing this Eighth Report, the Monitor has relied upon audited and unaudited financial information of the Golf Town Entities, the Golf Town Entities' books and records, certain financial information and forecasts prepared by the Golf Town Entities,

and discussions with various parties, including the Company's chief restructuring officer (the "CRO") and advisors to the Company (collectively, the "Information"). To the extent necessary and appropriate, the Monitor has also reviewed audited and unaudited financial information and forecasts of the Golfsmith Entities.

- 7. The Monitor has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information. Accordingly, the Monitor expresses no opinion or other form of assurance on the Information contained in this Eighth Report or relied on in its preparation. Future-oriented financial information reported or relied on in preparing this Eighth Report is based on the Company's assumptions regarding future events; actual results may vary from the forecast and such variations may be material.
- 8. Capitalized terms not otherwise defined herein have the meanings given to them in the Initial Order or previous reports filed by the Monitor.

A. UPDATE ON THE GOLF TOWN ENTITIES' AND THE MONITOR'S RECENT ACTIVITIES

- 9. Since the date of the Seventh Report, the Monitor has continued to monitor the Golf Town Entities' wind-down, cash receipts and disbursements, and streamlined the Company's cash management system when possible to reduce costs.
- 10. The Monitor has worked closely with the CRO and Alvarez & Marsal North America LLC and Alvarez & Marsal Canada ULC (collectively, "A&M"), the Company's financial advisor, to address various wind-down matters that have arisen in the CCAA Proceedings since the completion of the Golf Town Transaction.
- 11. Pursuant to the Stay Extension Order dated December 12, 2017, the Monitor was granted expanded powers to take such actions, execute such documents and enter into such arrangements, in the name and on behalf of the Golf Town Entities, as the Monitor, in consultation with counsel to the Golf Town Entities and the CRO, considered necessary or desirable to facilitate the administration and wind-down of the Golf Town Entities' estate and the CCAA Proceedings. Tasks completed to date include the on-going

preparation of certain indirect tax returns and discussions with vendors of the Golf Town Entities regarding certain disputed charges.

B. STATUS OF THE CHAPTER 11 PROCEEDINGS

- 12. As detailed in the Affidavit of Brian Cejka sworn March 22, 2018 (the "Cejka Affidavit"), the Golfsmith Entities continue to undertake certain wind-down activities and are close to finalizing their exit from the Chapter 11 Proceedings in conjunction with the completion of the CCAA Proceedings.¹
- In the Seventh Report, the Monitor reported that the Golfsmith Entities and certain of their stakeholders had reached an agreement in principle on a consensual global settlement (the "Global Settlement") that would resolve a dispute with respect to the payment of certain administrative priority claims and facilitate a dismissal of the Chapter 11 Proceedings. Since the date of the Seventh Report, the Global Settlement has been finalized with the Unsecured Creditors' Committee appointed in the Chapter 11 Proceedings (the "Creditors' Committee") and the U.S. co-trustee under the Secured Notes Indenture (the "U.S. Indenture Trustee").
- 14. The Global Settlement provides for, among other things:
- (a) the resolution of a dispute with respect to the payment of claims asserted against the Golfsmith Entities in respect of stub period rent and goods supplied to the Golfsmith Entities in the 20 days prior to their Chapter 11 filing for which priority was asserted pursuant to Section 503(b)(9) of the US Bankruptcy Code (the "503(b)(9) Claims");
- (b) the calculation and distribution of remaining funds to the Secured Noteholders; and

- (c) the dismissal of the Chapter 11 Proceedings with the support of key stakeholders of the Golfsmith Entities.
- 15. On January 23, 2018, the US Bankruptcy Court approved the Global Settlement and granted: (i) an order approving procedures for the allowance, settlement and payment of the 503(b)(9) Claims (the "503(b)(9) Procedures Order") and (ii) an order authorizing the dismissal of the Chapter 11 Proceedings upon the completion of remaining wind-down activities (the "Dismissal Authorization Order"). A copy of the Dismissal Authorization Order is attached as Exhibit "A" to the Cejka Affidavit.
- 16. The Dismissal Authorization Order:
- (a) approved an initial distribution of US\$5,315,000 to the U.S. Indenture Trustee (together with the Canadian Indenture Trustee, the "Indenture Trustee") for the benefit of the Secured Noteholders, which was subsequently processed and released to the Secured Noteholders during the week of February 19, 2018;
- (b) directed that all remaining funds of the Golfsmith Entities, after the satisfaction of administrative expenses (including those in connection with the Global Settlement) and other wind-down obligations, are to be distributed to the Indenture Trustee for the benefit of the Secured Noteholders; and
- (c) approved a form of order (the "**Dismissal Order**") that dismisses the Chapter 11 Proceedings upon certification of the Golfsmith Entities' counsel that all preconditions to dismissal have been completed and all administrative expenses have been settled.
- 17. The Monitor understands that the proposed Dismissal Order includes a comprehensive release by the "Releasing Parties" that becomes effective upon the entry of the Dismissal Order (the "Chapter 11 Release"). Pursuant to the Chapter 11 Release, the Releasing Parties include: (i) the Company and its directors and officers; (ii) the Creditors' Committee; (iii) the Indenture Trustee; (iv) the Second Lien Parties; (v) each holder of a stub rent claim that is paid after December 22, 2017 and who enters into a stipulation with

- the Golfsmith Entities regarding the allowance of its stub rent claim; and (vi) each holder of an allowed 503(b)(9) Claim that enters into a settlement agreement with the Company.
- 18. Pursuant to the Chapter 11 Release, the Releasing Parties grant a full and complete release of each other Releasing Party from any and all claims, liabilities or debts relating in any way to, or arising from any transaction with or in connection to, the Company or its estates of whatever kind or nature, except for each Releasing Party's obligations under the Dismissal Order, the Dismissal Authorization Order, the 503(b)(9) Procedures Order and/or any related stipulation.
- 19. The Monitor understands that notice of the Global Settlement, the proposed Chapter 11 Release and the other consensual relief sought by the Golfsmith Entities pursuant to the 503(b)(9) Procedures Order, the Dismissal Authorization Order and the Dismissal Order was provided to stakeholders of the Golfsmith Entities in the Chapter 11 Proceedings. Further, the notice provided in the Chapter 11 Proceedings included reference to the fact that the CCAA Release would be sought in the CCAA Proceedings. In light of the nature of the Global Settlement and the Chapter 11 Release, the Indenture Trustee provided all Secured Noteholders with advance notice of the hearing and the opportunity to object to the relief sought by the Golfsmith Entities.

C. THE PROPOSED CCAA TERMINATION ORDER

- (i) <u>Distribution and Reserves</u>
- 20. The CCAA Termination Order authorizes the Monitor to distribute the Golf Town Entities' remaining proceeds to the Canadian Indenture Trustee, subject to the prior written consent of the CRO and the holdback of any Reserve determined at the time of such distribution to ensure the availability of sufficient funds for the payment of: (i) any claim secured by a Court-ordered Charge (including the fees and disbursements of the Monitor and the Monitor's Counsel); (ii) post-filing obligations and other amounts payable pursuant to the Initial Order; and (iii) other amounts in connection with the wind-down of the Golf Town Entities and the CCAA Proceedings, including amounts in respect of a potential formal bankruptcy filing of all or certain of the Golf Town Entities.

- 21. In accordance with court orders made in the CCAA Proceedings and the Chapter 11 Proceedings, the Company has repaid in full the obligations owing under the DIP Agreement and the pre-filing first lien Credit Agreement. As set out in the Cejka Affidavit, the Secured Notes have an aggregate principal amount of \$125 million and were issued by GT Canada, as Canadian issuer, and Golfsmith International, as U.S. issuer. The Secured Notes are secured by all material entities in the Golf Town and Golfsmith corporate groups.
- 22. As set out in the First Report of the Monitor dated September 27, 2016, the Monitor's Counsel conducted a review of the security granted by the Golf Town Entities in its personal property to secured obligations owing under the first lien Credit Agreement and the amounts owing to the Secured Noteholders under the Secured Notes Indentures. The First Report provided the results of the security opinions and stated that, subject to the assumptions and qualifications contained therein, the personal property granted in favour of the Second Lien Agent as agent for the Secured Noteholders under the Secured Notes Indenture is valid and enforceable and creates valid security interests in substantially all of the personal property of the Golf Town Entities pursuant to personal property security legislation in each of the provinces where the Golf Town Entities carried on business.
- 23. As set out in the Cejka Affidavit, it is projected that the Secured Noteholders will face a significant deficiency on their claims and will receive an aggregate recovery of approximately 13% of the principal amount of the Secured Notes. As such, and as advised in previous reports of the Monitor, there will be no recovery for general unsecured creditors of the Golf Town Entities. The Monitor therefore supports the distribution of the remaining proceeds of the Golf Town Entities (subject to the Reserve) to the Canadian Indenture Trustee on behalf of the Secured Noteholders.
- 24. The CCAA Termination Order authorizes the Monitor to distribute the remaining proceeds to the Canadian Indenture Trustee in one or more distributions (including the disbursement of funds or proceeds that are held by or come into the possession of the Monitor following the CCAA Termination Date), in an aggregate amount up to the total obligations of the Golf Town Entities pursuant to the Secured Notes Indenture. The

Monitor is of the view that this approach provides it with the flexibility to ensure that the maintenance of any Reserve necessary to fund remaining wind-down matters will not prevent the Monitor from distributing the majority of the Golf Town Entities' proceeds to the Canadian Indenture Trustee in the near term and prior to or on the termination of the CCAA Proceedings.

- 25. Based on current estimates of the Reserve, the Monitor currently intends to make an initial distribution of approximately \$8.2 million to the Canadian Indenture Trustee on or prior to the CCAA Termination Date.
- (ii) <u>Termination of the CCAA Proceedings and Discharge of the Monitor</u>
- 26. The CCAA Termination Order provides that the CCAA Proceedings shall be terminated upon the filing by the Monitor of a certificate confirming that all matters to be attended to in connection with the Golf Town Entities and proceedings in respect of the Company have been completed. The Monitor's certificate may be filed and the CCAA Termination Date may occur notwithstanding further distributions to the Canadian Indenture Trustee are expected to occur following the CCAA Termination Date. The Monitor shall be discharged as Monitor effective on the CCAA Termination Date, provided that, notwithstanding the discharge, it shall remain Monitor for the performance of incidental or ancillary duties as may be required to complete the administration of the Golf Town Entities' estate or the CCAA Proceedings, including effecting further distributions, following the CCAA Termination Date.
- 27. The Golf Town Entities have advised the Monitor that remaining wind-down matters in the CCAA Proceedings and the Chapter 11 Proceedings are expected to be completed by April 30, 2018.
- 28. As noted above, the Monitor understands that, upon completion of the CCAA Proceedings, all or certain of the Golf Town Entities may pursue formal bankruptcy as part of the final wind-down of their estate. The proposed CCAA Termination Order authorizes (but does not require) a bankruptcy assignment in respect of each of the Golf Town Entities.

- (iii) Fees and Disbursements of the Monitor and the Monitor's Counsel
- 29. The CCAA Termination Order provides for Court approval of the Reports of the Monitor (including this Eighth Report) and the actions, conduct and activities of FTI Consulting Canada Inc. (in its capacity as proposed monitor) and the Monitor as described therein.
- 30. The Monitor respectfully submits that the activities it has undertaken in the CCAA Proceedings have been carried out in good faith and in accordance with the provisions of the Orders issued in the CCAA Proceedings and should therefore be approved.
- 31. Pursuant to paragraphs 36 and 37 of the Initial Order, the Monitor and the Monitor's Counsel are to: (i) be paid their reasonable fees and disbursements, in each case at their standard rates and charges, whether incurred prior to or subsequent to the date of the Initial Order, by the Golf Town Entities as part of the costs of the CCAA Proceedings; and (ii) pass their accounts from time to time before this Court.
- 32. Throughout the CCAA Proceedings and pursuant to the Initial Order, the fees and disbursements of the Monitor and the Monitor's Counsel have been paid from time to time as part of the costs of the CCAA Proceedings. The Monitor and the Monitor's Counsel have each maintained detailed records of their time and disbursements with respect to these CCAA Proceedings.
- 33. Included in Exhibit "A" to the Affidavit of Paul Bishop sworn March 21, 2018 that is attached as Appendix "A" to this Eighth Report (the "Bishop Affidavit") are copies of the invoices rendered by the Monitor in respect of these CCAA Proceedings that have been redacted to protect certain privileged information. For the period from September 14, 2016 to February 28, 2018, the Monitor's accounts total \$1,004,032.50 in fees, \$73,774.30 in disbursements and \$140,114.90 in HST for a total amount of \$1,217,921.70. Exhibit "B" to the Bishop Affidavit contains a summary of the personnel, hours and hourly rates charged by the Monitor in respect of these proceedings.
- 34. Included in Exhibit "A" to the Affidavit of Tracy Sandler sworn March 22, 2018 that is attached as Appendix "B" to this Eighth Report (the "Sandler Affidavit") are copies of

that have been redacted to protect certain privileged information. For the period from September 1, 2016 to February 28, 2018, the Monitor's accounts total \$697,075.60 in fees, \$31,828.85 in disbursements and \$94,750.47 in HST for a total amount of \$823,654.92. Exhibit "B" to the Sandler Affidavit contains a summary of the personnel, hours and hourly rates charged by the Monitor's Counsel in respect of these proceedings. The Sandler Affidavit and the Bishop Affidavit are collectively referred to herein as the ("Fee Affidavits").

- As set out in the Fee Affidavits, the Monitor and the Monitor's Counsel also estimate that their fees and disbursements until the completion of these CCAA Proceedings will not be greater than approximately \$60,000 for the Monitor and approximately \$50,000 for the Monitor's Counsel, in each case exclusive of HST (collectively, the "Completion Estimates"). The Completion Estimates include amounts for preparation for a potential formal bankruptcy filing in respect of certain of the Golf Town Entities, should it be prudent to do so to finalize the wind-down of the Golf Town Entities.
- 36. Each of the reports submitted by the Monitor in these proceedings have included a detailed description of the Monitor's activities in these CCAA Proceedings as required by the Initial Order, other orders of the Court and the CCAA. The Monitor has played a significant role in these proceedings which resulted in the sale of the vast majority of the Golf Town Business to the Purchaser as a going concern. In summary, the significant activities undertaken by the Monitor have included:
- (a) monitoring the Golf Town Entities' receipts and disbursements and assisting the Company with its cash management;
- (b) communicating with various suppliers, creditors and other stakeholders of the Golf Town Entities to inform them of various matters in CCAA Proceedings;

- engaging with the Company's CRO and financial advisor on various matters in the CCAA Proceedings, and as necessary to facilitate the Chapter 11 Proceedings for the Golfsmith Entities;
- (d) placing representatives on-site at the Company's former head office in Austin, Texas for a number of months to address various issues that arose in the CCAA Proceedings;
- (e) assisting the Golf Town Entities with various human resources matters, including statutory remittances and corresponding with various provincial ministries of labour;
- (f) engaging with past management of the Golf Town Entities with respect to various issues in the CCAA Proceedings, including store closures and employee terminations;
- assisting with the implementation of the Golf Town Transaction, including: (i) the completion of a Transition Services Agreement (the "TSA") between the Vendors and the Purchaser; (ii) establishing and administering various reserves and acting as escrow agent in connection with the Purchase Escrow Agreement and TSA Escrow Agreement; and (iii) the completion of an Employee Services Agreement pursuant to which former employees of the Golf Town Entities now employed by the Purchaser assisted the Vendors and the Monitor with the transition and wind-down of Golf Town Entities' business; and
- (h) overseeing the orderly wind-down of the Golf Town Entities' estate.
- 37. The Monitor respectfully submits that the fees and disbursements incurred by the Monitor and the Monitor's Counsel, as set out in the Fee Affidavits, are reasonable in the circumstances and have been validly incurred in accordance with the provisions of the Orders issued in the CCAA Proceedings, and that the Completion Estimates are also reasonable in the circumstances. Accordingly, the Monitor respectfully requests the approval of the fees and disbursements of the Monitor and the Monitor's Counsel, as set out in the Fee Affidavits, including the Completion Estimates.

(iv) <u>CCAA Release</u>



- 38. The CCAA Termination Order provides for the release of the Released Parties (as defined above) for all present and future claims and obligations in respect of the Released Parties based on any act, omission, transaction, dealing or other occurrence taking place prior to the CCAA Termination Date or done pursuant to the CCAA Termination Order (the "Released Claims"). The CCAA Release does not release any claim against the directors and officers of the Company that is not permitted to be released pursuant to section 5.1(2) of the CCAA.
- 39. The Monitor understands that the purpose of the CCAA Release is to achieve certainty and finality for the Released Parties in the most efficient and appropriate manner given the Golf Town Entities' current circumstances.
- 40. The Monitor is of the view that the time and expense associated with undertaking a claims procedure is not in the best interests of the Golf Town Entities or its stakeholders, given that the Secured Noteholders will suffer a substantial deficiency on the amounts owed to them and there is no value for unsecured creditors.
- 41. The Monitor is of the view that the CCAA Release will facilitate the distribution of the Golf Town Entities' remaining assets and the completion of the CCAA Proceedings in the near term without the need to expend estate resources in connection with the development and implementation of a plan of compromise or arrangement and the completion of related procedural steps.
- 42. The Released Parties, including the directors and officers of the Golf Town Entities, have made significant contributions to the restructuring efforts and to achieving a positive outcome for the CCAA Proceedings. Court approval of the CCAA Release will facilitate the timely distribution of the Golf Town Entities remaining assets to the Secured Noteholders, including through the release of the portion of reserves currently securing the Directors' Charges.
- 43. The Monitor understands that the Golf Town Entities' motion for the CCAA Termination Order will be provided to the service list maintained by the Monitor in the CCAA

- Proceedings and certain other interested parties. A copy of this Eighth Report will also be served by the Monitor on such parties.
- 44. In the circumstances, the Monitor believes the CCAA Release is reasonable and appropriate in the circumstances and will facilitate the completion of the CCAA Proceedings in an efficient and orderly manner.

D. FINANCIAL STATUS OF THE GOLF TOWN ENTITIES

- (i) Receipts & Disbursements for the 15 Week Period Ending March 10, 2018
- 45. The Golf Town Entities' actual net cash flow on a consolidated basis for the 15 week period ending March 10, 2018 was approximately CAD\$(0.14) million compared to a forecast amount of CAD\$(0.37) million as noted in the December 17 Cash Flow Forecast filed as Appendix "B" to the Seventh Report, resulting in a positive variance of approximately CAD\$0.23 million as summarized below:

- 46. Explanations for the material variances in actual receipts and disbursements for the 15 week period ending March 10, 2018 are summarized below:
- (a) Total receipts were CAD\$0.03 million compared to a forecast amount of CAD\$0.01 million, resulting in a positive variance of CAD\$0.02 million. The positive variance is primarily due to higher than expected interest earned on funds held in trust by the Monitor and the receipt of other miscellaneous amounts.
- (b) Total operating disbursements were nil compared to a forecast amount of CAD\$0.08 million, which resulted in a positive variance of CAD\$0.08 million. The positive variance is attributable to the timing of certain miscellaneous operating disbursements and anticipated costs associated with completion of the wind-down of the Golf Town Entities.

(c) Total non-operating disbursements consisted of Professional Fees which were CAD\$0.17 million compared to a forecast amount of CAD\$0.30 million, which resulted in a positive variance of CAD\$0.13 million. This variance is expected to reverse in the future as invoices for outstanding professional fees are received and paid.

(ii) <u>Reserve Established by the Monitor for the Initial Distribution to the Secured</u> Noteholders

- 47. As of the week ending March 10, 2018, the total amount held in trust by the Monitor was CAD\$8.88 million.
- 48. As set out above, the CCAA Termination Order, should it be approved by the Court, authorizes the Monitor to distribute the Golf Town Entities' remaining funds to the Canadian Indenture Trustee, subject to the holdback of any Reserve determined at the time of such distribution to ensure the availability of sufficient funds for the payment of the following:
 - (i) any claim secured by a Court-ordered priority Charge (including the fees and disbursements of the Monitor and the Monitor's Counsel);
 - (ii) post-filing obligations and other amounts payable pursuant to the Initial Order; and,
 - (iii) any other amounts in connection with the orderly wind-down of the Golf Town Entities and the CCAA proceedings, including amounts in respect of a potential formal bankruptcy filing of certain of the Golf Town Entities.
- 49. The summary below provides an overview of the total funds held in trust by the Monitor as of the week ending March 10, 2018, projected reserves and other holdbacks, and the amount available for immediate distribution to the Secured Noteholders.

50. After establishing the Reserve, the Monitor intends to distribute approximately CAD\$8.2 million to the Canadian Indenture Trustee. As shown above, the balance of funds, CAD\$0.7 million would be held by the Monitor in respect of the Reserve.

E. EXTENSION OF THE STAY PERIOD

- 51. As noted above, the current stay of proceedings in respect of the Golf Town Entities expires on March 30, 2018. The CCAA Termination Order provides for an extension of the Stay Period to and including the earlier of: (i) the CCAA Termination Date; and (ii) May 31, 2018.
- 52. An extension of the Stay Period is necessary in order to complete an orderly wind-down of the Golf Town Entities, coordinate the termination of the CCAA Proceedings and the Chapter 11 Proceedings and make distributions to the Canadian Indenture Trustee for the benefit of the Secured Noteholders.
- 53. The Golf Town Entities have advised the Monitor that they expect to be in a position to terminate the CCAA Proceedings prior to May 31, 2018, but are requesting an extension of the Stay Period until that outside date in order to avoid incurring the expense of bringing another motion in these CCAA Proceedings in the event that remaining matters cannot be completed prior to the end of the proposed extended Stay Period.

54. The Monitor is of the view that the Reserve is sufficient to provide the Golf Town Entities with the liquidity required to fund the remaining wind-down activities and the CCAA Proceedings until the CCAA Termination Date.

55. Based on the information presently available, the Monitor believes that creditors of the Golf Town Entities will not be materially prejudiced by the proposed extension of the Stay Period.

56. The Monitor is not aware of any non-compliance by the Golf Town Entities with requirements under the CCAA or pursuant to any Order issued by this Court in the CCAA Proceedings. The Monitor believes that the Golf Town Entities have acted, and are continuing to act, in good faith and with due diligence and that circumstances exist that make an extension of the Stay Period to the earlier of the CCAA Termination Date and May 31, 2018 is appropriate.

F. MONITOR'S RECOMMENDATIONS

57. For the reasons set out above, the Monitor is of the view that the relief requested by the Golf Town Entities is reasonable and respectfully recommends that this Court grant the proposed CCAA Termination Order, including the approval the fees and disbursements of the Monitor and the Monitor's Counsel.

The Monitor respectfully submits this Eighth Report to the Court.

- 1. I am a Senior Managing Director with FTI Consulting Canada Inc., which was appointed as the monitor (the "Monitor") in these proceedings and as such have knowledge of the matters hereinafter deposed. Where I have indicated that I have obtained facts from other sources, I believe those facts to be true.¹
- 2. I make this affidavit in support of a motion by the Applicants for, among other things, approval of the fees and expenses of the Monitor.

¹ Capitalized terms used and not otherwise defined in this affidavit have the meanings given to them in the Eighth Report of the Monitor (the "Eighth Report").

Fees Incurred between September 14, 2016 and February 28, 2018

- Attached hereto as Exhibit "A" are true copies of the invoices prepared by the Monitor for the fees and expenses incurred by the Monitor in connection with these proceedings for the period between September 14, 2016 and February 28, 2018. These invoices have been redacted to address matters of privilege and confidentiality. I confirm that these accounts accurately reflect the services provided by the Monitor in this matter for this period and the fees and expenses claimed by it for the period.
- 4. Attached hereto as Exhibit "B" is a schedule listing the fees, expenses, HST and total fees charged for each invoice in Exhibit "A".
- 5. Attached hereto as Exhibit "C" is a schedule summarizing the billing rates and total amounts billed with respect to each representative of the Monitor that rendered services in connection with these proceedings and the blended rate for the period between September 14, 2016 and February 28, 2018.

Fees to be Incurred Following February 28, 2018

As part of the CCAA Termination Order and as described in more detail in the Eighth Report, the Monitor is also seeking approval of its estimated fees and expenses to be incurred in connection with the completion of various wind-down matters in respect of the Applicants between the period of March 1, 2018 and the earlier of the: (i) CCAA Termination Date; and (ii) May 31, 2018 (the "Completion Period"). The accounts have been redacted to address matters of confidentiality or privilege. I confirm that these accounts accurately reflect the services provided by Osler in this matter for this period and the fees and disbursements claimed by it for the period.
- 4. Attached hereto as Exhibit "B" is a schedule summarizing the accounts of Osler rendered to the Monitor for the fees and disbursements incurred by Osler in connection with these proceedings for the period between September 1, 2016 and February 28, 2018.
- 5. Attached hereto as Exhibit "C" is a schedule summarizing the respective years of call and billing rates of each of the professionals at Osler that rendered services to the Monitor, the hours worked by each such individual and a blended hourly rate for the file.

Fees to be Incurred Following February 28, 2018

The Completion Estimate includes amounts that may be incurred in respect of preparations for a potential formal bankruptcy filing in respect of certain of the Golf Town Entities.

7. To the best of my knowledge, the rates charged by Osler throughout the course of these proceedings are comparable to the rates charged by other law firms in the Toronto market for the provision of similar services. I believe that the total hours, fees and disbursements already incurred by Osler on this matter and to be incurred during the Completion Period are reasonable and appropriate in the circumstances.


