ON THE APPLICATION of FTI Consulting Canada Inc. in its capacity as Court-Appointed Receiver (the "Receiver") of all of the assets, undertakings and properties of the Respondent, Superior Glass Canada Inc., coming on for hearing at 800 Smithe Street, Vancouver, British Columbia on 26/Mar/2019 and on hearing Scott M. Boucher, counsel for the Receiver, AND UPON READING the material filed, including the First Report of the Receiver dated December 5, 2017 (the "First Report"), and the Second Report of the Receiver dated February 12, 2019 (the "Second Report"); *AND NO ONE ELSE Appearing though Any served;*

THIS COURT ORDERS that:

1. The activities of the Receiver, as set out in the Second Report, are hereby approved.
2. The fees and disbursements of the Receiver and its counsel, as set out in Affidavit #1 of Craig Munro and Affidavit #2 of Krystal Shayler, filed herein, are hereby approved.
3. After payment of the fees and disbursements of the Receiver and its counsel as herein approved, the Receiver shall pay all funds remaining in its hands to the Receiver General.

4. Upon payment of the amounts set out in paragraph 3 hereof, the Receiver shall be discharged as Receiver of the assets, undertakings and properties of the Respondent, Superior Glass Canada Inc., provided that notwithstanding its discharge herein: (a) the Receiver shall remain Receiver for the performance of such incidental duties as may be required to complete the administration of the receivership herein; and (b) the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of FTI Consulting Canada Inc. in its capacity as Receiver.


