#### **NOTICE AND STATEMENT OF THE RECEIVER**

(subsections 245(1) and 246(1) of the *Bankruptcy and Insolvency Act*)

The receiver gives notice and declares that:

1. On September 16, 2024, FTI Consulting Canada inc. (the "**Receiver**") became the receiver in respect of the universality of the properties (the "**Property**"), as defined in Appendix A of the Court Order, of Bois BSL Inc./BSL Wood Products Inc. ("**BSL**").
2. As of the date of this notice, the Property of BSL includes the following, but is not limited to and for which the value remains to be determined:
  - Accounts receivable;
  - Raw materials and Finished goods;
  - Equipment and Rolling Stock;
  - Real Estate Assets (Buildings and Land);
  - Trademarks and Intellectual Property Rights; and,
  - Tax Credits Receivable.
3. The Receiver was appointed by virtue of a Court Order rendered on September 16, 2024 by the registrar Mr. Vincent-Michel Aubé pursuant to section 243 of the *Bankruptcy and Insolvency Act* ("**Court Order**").
4. The Receiver took possession of the Property on September 16, 2024.

5. The following information relates to the receivership:

- a) The head office and the place of business of de Bois BSL inc./BSL Wood Products inc. are located at 1081, Industrielle Street, Mont-Joli, Quebec, G5H 3K8.

  - Petition the Court for the issuance of a vesting order to convey the Property free and clear of any liens or encumbrances affecting such Property;
  - Retain whatever services required, in the opinion of the Receiver acting reasonably, to fulfill its mandate.


