#### **AFFIDAVIT**

- I, YANG YANG, senior investment manager, of 22 Floor, Shougang International Building, North Street No. 60, Xizhimen, Haidian District, Beijing, People's Republic of China, AFFIRM THAT:
- 1. I am the senior investment manager of China Shougang International Trade & Engineering Corporation ("Shougang"), a creditor in this proceeding (the "CCAA Proceeding"), and as such I have personal knowledge of the facts and matters deposed to herein, except where stated to be based upon information and belief, and where so stated I verily believe the same to be true.
- 2. I am also a director of Shougang International (Canada) Investment Ltd. ("Shougang Canada"), which is the sole Canadian subsidiary of Shougang, and as such I also have personal knowledge of the facts and matters deposed to herein with respect to Shougang Canada, except where stated to be based upon information and belief, and where so stated I verily believe the same to be true.
- 3. Shougang is also the applicant in the application for bankruptcy order with respect to Canadian Dehua International Mines Group Inc. ("CDI"), filed in the Supreme Court of British Columbia, Vancouver Registry, Court Number B-220142, Estate Number 11-254383 (the "Bankruptcy Application").
- 4. I am approved by Shougang and Shougang Canada to make this affidavit on their behalf.

5. This affidavit is further to my first affidavit made March 30, 2022, and filed in support of the Bankruptcy Application, and my first affidavit made June 8, 2022 (the "First CCAA Affidavit") in the CCAA Proceeding.

### **Shougang**

- As stated in the First CCAA Affidavit:
  - (a) Shougang is a limited liability company incorporated in Beijing, People's Republic of China, having an address for service in this proceeding care of its solicitors, Dentons Canada LLP, 20th Floor, 250 Howe Street, Vancouver, British Columbia, V6C 3R8.
  - (b) Shougang is a subsidiary of Shougang Group. Shougang Group is wholly-owned by the Beijing State-owned Assets Supervision and Administration Commission (the "Beijing Commission").
  - (c) To the best of my information and belief, Canada Zhonghe Investment Ltd. ("Zhonghe"), also a creditor of CDI, is indirectly State-owned. However, to the best of my information and belief, Zhonghe is a subsidiary of the Kailuan Group, which is under the Hebei Commission (Hebei is a different Province in People's Republic of China). Zhonghe is not owned or controlled by the Beijing Commission.
- 7. Shougang owns 100% of the shares of Shougang Canada.
- 8. Shougang Canada is a company incorporated under the laws of British Columbia. Now shown to me and attached hereto as Exhibit "A" is a copy of a BC Company search of Shougang Canada dated January 16, 2025.
- Shougang Canada was incorporated on August 23, 2010.
- 10. Shougang does not have any other Canadian subsidiaries or affiliates.

# **Funding Source for Offers**

- 11. I have reviewed the first affidavit of Ronald Willson ("Chief Willson") filed on January 7, 2025 (the "First Willson Affidavit") in the CCAA Proceeding. At paragraph 22, Chief Willson deposes that West Moberly First Nations' source of funds for its offers in the CCAA Proceeding is a "wholly Canadian source under an agreement which requires West Moberly to maintain confidentiality".
- 12. I have also reviewed the application response of Qu Bo Liu ("Ms. Liu") filed on January 9, 2025 (the "Liu Response") in the CCAA Proceeding. At paragraph 16 in the Liu Response,

Ms. Liu speculates that the funding source referenced by Chief Willson in the First Willson Affidavit could be Zhonghe or Shougang.

- I have also reviewed the second affidavit of Chief Willson filed on January 10, 2025 13. (the "Second Willson Affidavit") in the CCAA Proceeding. At paragraph 5, in response to the speculation in the Liu Response, Chief Willson further deposes that "the source of funds for the West Moberly First Nations bids is not connected to any of those entities", which is referring to the entities from the list of proofs of claim set out in the Seventh Report of the Monitor dated September 7, 2023 (the "Seventh Report"). The list in the Seventh Report includes Shougang.
- In addition to the evidence of Chief Willson, I further confirm that: 14.
  - neither Shougang nor Shougang Canada has provided, or agreed to provide, any (a) funding to any party, including West Moberly First Nations or Ms. Liu, with respect to any offer made in this CCAA Proceeding, including the offers currently being considered with respect to the Wapiti and Bullmoose assets; and
  - (b) neither Shougang nor Shougang Canada has directed any related or affiliated company or entity formed outside of Canada to contribute any funding to any party, including West Moberly First Nations or Ms. Liu, with respect to any offer made in this CCAA Proceeding, including the offers currently being considered with respect to the Wapiti and Bullmoose assets.
