PLEASE TAKE FURTHER NOTICE THAT on July 12, 2012, the Ontario Superior Court of Justice (the "Canadian Court") entered the *Approval and Vesting Order* (the "Canadian Sale Order") (Dkt. 57) which approved the sale of substantially all of the property and assets used in connection with the business carried on by the Debtors in North America.

PLEASE TAKE FURTHER NOTICE THAT that on July 25, 2012, the Bankruptcy Court entered the Order (I) Recognizing the Canadian Sale Order, (II) Authorizing and Approving the Sale Free and Clear of All Liens, Claims, Encumbrances, and Other Interests, (III) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, and (IV) Granting Related Relief (the "Sale Order") (Dkt. 98) which authorized the Debtors to sell certain of their assets located within the territorial jurisdiction of the United States (the "Sale") pursuant to the terms and conditions set forth in that certain Asset Purchase
