DECLARATION OF PAUL BISHOP IN SUPPORT OF MONITOR'S SECOND STATUS REPORT

I, Paul Bishop, pursuant to 28 U.S.C. § 1746, hereby declare under penalty of perjury as follows:

1. I hereby submit this declaration (the "<u>Declaration</u>"), made in my capacity as a Senior Managing Director of FTI Consulting Canada Inc., the authorized foreign representative of Imperial Tobacco Canada Limited (the "<u>Debtor</u>") and the Court appointed monitor (the "<u>Monitor</u>") of the Debtor and Imperial Tobacco Company Limited ("<u>ITCO</u>") in a proceeding (the "<u>Canadian Proceeding</u>") under Canada's *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended, pending before the Ontario Superior Court of Justice (Commercial List) in Toronto, Ontario (the "<u>Canadian Court</u>"), to apprise the Court of recent, notable developments in the Canadian Proceeding since the filing of the Monitor's first status report on April 8, 2020 (the "<u>First Status Report</u>") [Docket No. 64] and in support of the *Second Status*

Report filed contemporaneously herewith (the "<u>Second Status Report</u>"). A complete list of the orders issued to date in the Canadian Proceeding is attached hereto as Exhibit A.

- 2. On April 8, 2020, the Monitor reported to the Court, among other things, that the Canadian Court extended the Stay² to September 30, 2020 and appointed the Mediator and the Representative Counsel for the TRW Claimants, and that the Mediation was continuing constructively. *See* Docket Nos. 64 and 65.
- 3. On September 29, 2020, the Canadian Court extended the Stay to March 31, 2021 as the parties continued to engage in meaningful discussions at the Mediation. *See* Endorsement of March 2021 Stay Extension Order at 2.
- 4. On March 30, 2021, the Canadian Court extended the Stay to September 30, 2021 as, *inter alia*, progress has been made in the Mediation and the Debtor, along with its affiliate ITCO, had sufficient liquidity to operate within the extended Stay period. *See* Endorsement of September 2021 Stay Extension Order at 2. Copies of the September 2021 Stay Extension Order, the Endorsement of September 2021 Stay Extension Order, and the Ninth Report of the Monitor filed in support of the March 19, 2021 motion to extend the Stay are attached hereto as Exhibit B.
- 5. Although the Mediation is confidential, the Monitor can report that the parties are continuing to advance the Mediation with a view to facilitating a pan-Canadian global settlement of the Tobacco Claims.
- 6. The Debtor's operations have continued, but as with most companies, they have been impacted by the global COVID-19 pandemic. As set forth in the Second Status Report, the Debtor experienced supply chain disruptions predominately as a result of its affiliate BAT MX having to temporarily shutdown its Mexico manufacturing facility in the spring of 2020 in light

of local lockdown orders and COVID-19 restrictions in Mexico which caused supply shortages in Canada. To address these issues, the Debtor contracted with affiliates in Brazil and Chile to temporarily produce tobacco products for sale in Canada. The Debtor has also increased inventory levels in and outside of Canada and taken additional steps to ensure that alternative production sources exist in the event of further shutdowns.

- 7. Despite these challenges and attendant additional costs, the Debtor's cash position remained stable as sales outpaced projections due, in large part, to a contraction in the illicit market for tobacco products resulting from Canada's local shutdown orders and other COVID-19 related restrictions.
- 8. In accordance with 11 U.S.C. § 1518, the Monitor will continue to keep the Court apprised of substantial developments in the Canadian Proceeding. The Monitor is also available for a telephonic status conference at the Court's convenience.

A. GENERAL

1. In this Report, unless otherwise defined, all capitalized terms shall have the respective meanings specified in the glossary attached to this Report as Appendix "A". The first instance of each capitalized term, if defined in the glossary, is hyperlinked to the glossary.

B. INTRODUCTION

- 2. The principal purpose of these CCAA Proceedings, and the related Chapter 15 Proceedings, is to restructure and compromise Imperial's liabilities, specifically the liabilities arising from the Tobacco Claims, including the Quebec Appeal Judgment.
- 3. The Initial Order in these CCAA Proceedings was issued by this Court on March 12, 2019, as amended and restated as of April 5, 2019, further amended and restated as of April 25, 2019, and updated by written endorsement on March 6, 2020.



4. A list of the orders issued by this Court and the US Bankruptcy Court in these CCAA Proceedings can be found in Appendix "B" to this Report.

C. BACKGROUND

- 5. Imperial is the largest distributor of Tobacco Products in Canada and operates two businesses: tobacco and logistics. The tobacco business includes the marketing and sale of Tobacco Products as well as Vapour Products. The logistics business distributes Tobacco Products and Vapour Products for tobacco manufacturers, as well as certain non-tobacco products and services.
- 6. Imperial is highly integrated with BAT and its affiliates. Imperial benefits from a wide range of services, licences and rights provided by certain of BAT's affiliates. These services and functions have been and continue to be vital for preserving Imperial's business and value.
- 7. Further information regarding these CCAA Proceedings and Imperial's background is provided in the previous Monitor's Reports.
- 8. All Court materials filed and orders issued in these CCAA Proceedings and the related Chapter 15 Proceedings are available on the Monitor's website at: http://cfcanada.fticonsulting.com/imperialtobacco.

D. TERMS OF REFERENCE AND DISCLAIMER

9. In preparing this Report, the Monitor has relied upon certain financial information and forecasts prepared by Imperial, and discussions and correspondence with, among others, the senior management and advisors to Imperial. The Monitor has not audited or otherwise attempted to verify the accuracy or completeness of this information. Accordingly, the Monitor expresses no opinion or other form of assurance on the information contained in this Report or relied on in its preparation. Future oriented financial information reported or relied on in preparing this Report is based on Imperial management's assumptions regarding future events; actual results may vary from the forecast and such variations may be material.

- 10. Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian Dollars.
- 11. This Report should be read in conjunction with the March 2021 Thauvette Affidavit which can be found here.

E. PURPOSE OF THIS REPORT

- 12. The purpose of this Report is to provide this Court with information regarding:
 - i. an update on the Court and US Bankruptcy Court proceedings;
 - ii. an update on the Mediation;
 - iii. an update on the continued impact of the COVID-19 Pandemic on Imperial's business;
 - iv. Imperial's business activities, industry developments and trends impacting Imperial's business and Imperial's related business contingency plan;
 - v. Imperial's budget to actual cash flow results for the 26-week period ending March 7, 2021;
 - vi. the Cash Flow Forecast for the 30-week period commencing the week of March 8, 2021 through the week of September 27, 2021;
 - vii. the new Tobacco Regulations coming into force and regulations governing Vapour Products;
 - viii. the status of Imperial's payment obligations to BAT Mexico in connection with the BAT MX Agreement;
 - ix. the activities of the Monitor and its counsel since September 22, 2020, the date of the Eighth Report;

- x. Imperial's request for an order extending the Stay of Proceedings to September 30, 2021; and
- xi. the Monitor's comments and recommendations in respect of the foregoing matters.

F. UPDATE ON COURT PROCEEDINGS

- 13. On September 29, 2020, this Court heard a motion seeking the extension of the Stay of Proceedings and issued the March 2021 Stay Extension Order which extended the Stay Period to March 31, 2021. A copy of the March 2021 Stay Extension Order can be found here.
- 14. There have been no material updates in the Chapter 15 Proceedings since April 8, 2020, the date the Status Update and Declaration was filed by US Counsel in the US Bankruptcy Court. The Monitor and its counsel intend to prepare and file a further status update with the US Bankruptcy Court following the hearing on this motion.
- 15. Due to the continued impact of the COVID-19 Pandemic, this hearing on the motion to extend the Stay of Proceedings will proceed by Zoom Video Conference according to the protocol developed by counsel to the Tobacco Monitors. The general public will have access to the hearing via secure, dedicated YouTube livestream. This protocol has been re-served on the consolidated service list, remains posted to the Monitor's website and can be found at Appendix "C" to this Report.

G. UPDATE ON THE MEDIATION

16. The Monitor continues to work with Imperial to populate the Imperial Data Room with financial and other information relevant to these CCAA Proceedings and to respond to information requests. The Imperial Data Room is accessible only to those advisors of Mediation Participants who have executed NDAs.

17. Since the date of the Eighth Report, the Court-Appointed Mediator, with the assistance of the Tobacco Monitors, has continued to conduct the Mediation and engage in meaningful discussions with the Applicants and stakeholders. Although the Mediation is confidential, the Monitor can report that the parties are continuing to advance the Mediation with a view to facilitating a pan-Canadian global settlement of the Tobacco Claims.

H. COVID-19 PANDEMIC IMPACT

- 18. As discussed in the Eighth Report, the BAT Mexico facility was temporarily shut down on April 2, 2020, as a result of a government ordered lockdown due to the COVID-19 Pandemic. The Mexican government began to relax lockdown measures on June 1, 2020, following which the BAT Mexico facility returned to normal operations.
- 19. Imperial continues to engage in further contingency planning to prevent or mitigate supply chain disruptions and resultant costs and losses in the event of a COVID-19 resurgence or other unanticipated event.
- 20. As noted in paragraph 30 of the Eighth Report, in May 2020 the Monitor posted in the Imperial Data Room an analysis of the estimated financial impact of the COVID-19 Pandemic on ITCAN's business. In February 2021, the Monitor posted an updated analysis of the COVID-19 Pandemic impact to the Imperial Data Room. The updated analysis shows that the COVID-19 Pandemic had a negative short-term impact on the ITCAN business as additional logistics and transportation costs were partially offset by short term sales increases. ITCAN continues to actively monitor potential COVID-19 Pandemic related supply issues and may take further actions to offset the financial impact of the COVID-19 Pandemic.

I. IMPERIAL'S BUSINESS ACTIVITIES, INDUSTRY DEVELOPMENTS AND TRENDS IMPACTING IMPERIAL'S BUSINESS

Receipts and Disbursements

21. While the COVID-19 Pandemic has continued to impact the timing of receipts and disbursements, including (i) tax payment deferrals as part of certain government support programs, (ii) working capital impact due to increased inventory levels, and (iii) a short-term increase in sales of Tobacco Products as a result of the temporary contraction of the illicit market due to lockdown measures, recent trends continue to indicate that the market for Tobacco Products appears to be returning to prepandemic levels.

Updated Five-Year Financial Forecast

- 22. As discussed in the Sixth Report, Imperial, with the assistance of the Monitor, prepared a five-year financial forecast which was made available in the Imperial Data Room, and thus to Mediation Participants, in November 2019.
- 23. Imperial, with further assistance of the Monitor, has prepared an update to the five-year financial forecast following changes to the underlying assumptions caused by the COVID-19 Pandemic and other factors. This updated five-year forecast was made available in the Imperial Data Room in February 2021.

Supplier Dispute Update

24. As noted in paragraph 41 of the Eighth Report, ITCAN was engaged with a supplier that purported to terminate its distribution agreement with ITCAN. This dispute has been resolved. Prior to settling the dispute, Imperial consulted with the Monitor, who concurred with the terms of the settlement.

Customs Programs Memberships

25. On January 12, 2021, the CBSA delivered a letter to ITCAN indicating that Imperial's customs self-assessment authorization and membership in the Partners

- in Protection program would be suspended due to ITCAN's insolvency, effective February 19, 2021.
- 26. The customs self-assessment authorization and Partners in Protection program are designed to facilitate more efficient importation, border crossing and customs clearing for certain trusted companies. In the absence of both programs, ITCAN's ability to import products into Canada would likely be materially negatively impacted.
- 27. Counsel to ITCAN delivered a response on January 27, 2021 requesting that the CBSA reconsider the suspensions as ITCAN's insolvency poses no financial risk to the CBSA and suggesting that the Department of Justice be involved in any further discussions relating to the suspensions.
- 28. Following the delivery of this letter and certain other discussions between the parties, the Monitor and its counsel, the CBSA agreed to delay the suspensions until further notice. Imperial continues to keep the Monitor and its counsel apprised of the negotiations with the CBSA.

Cash Management

29. As part of its efforts to manage financial institution risk, Imperial maintains cash balances in multiple financial institutions in Canada. In addition, Imperial has invested a portion of its reported cash balance in short-term government bonds with a maturity of six months or less to further reduce its financial institution risk exposure.

Nicoventures IP Assignment

30. On November 9, 2020, ITCAN advised the Monitor that, pursuant to a Supply of Marketing Services Agreement between ITCAN and Nicoventures (a member of the BAT Group), ITCAN intended to assign its rights to an invention related to Vapour Products developed jointly by an ITCAN employee and Nicoventures.

Pursuant to the agreement, any intellectual property developed in connection with the provision of Nicoventures' services immediately vests in and is owned by Nicoventures.

- 31. The Monitor and its counsel reviewed the various underlying agreements and proposed assignment documents and on November 12, 2020 advised ITCAN that, based on the facts and information provided by ITCAN, the Monitor did not have an objection to ITCAN complying with its contractual obligations pursuant to the Supply of Marketing Services Agreement.
- 32. The various assignment documents were executed shortly thereafter.

J. RECEIPTS AND DISBURSEMENTS FOR THE 26-WEEK PERIOD ENDING MARCH 7, 2021

- 33. Imperial's cash balance as of the week ended March 7, 2021 was \$1,868 million, a decrease over the 26-week period from the beginning cash balance of \$1,921 million as of September 6, 2020. As noted in paragraph 29 above, a portion of this cash balance is invested in short-term government bonds.
- 34. Imperial's actual net cash inflow for the 26-week period ending March 7, 2021 was approximately \$53 million, as compared to the forecasted net cash outflow of \$429 million, resulting in a positive variance of \$376 million, as summarized below:

- 35. The significant budget to actual variances and corresponding explanations are as follows:
 - i. *trade receipts*: positive permanent variance of \$252 million, or 12% against the forecast, primarily driven by higher-than-forecast sales as a result of the temporary contraction of the illicit market during the second wave of the COVID-19 Pandemic due to lockdown restrictions;
 - ii. *taxes and levies*: positive permanent variance of \$27 million, primarily driven by lower-than-forecast corporate income tax payments for fiscal 2020;
 - iii. operating disbursements: positive variance of \$91 million, primarily driven by a positive permanent variance of \$57 million as a result of

higher-than-forecast reimbursement of expenses relating to the Vapour Products business and a positive timing variance of \$34 million that is expected to reverse in the future reporting period. The higher-than-forecast reimbursement relating to the Vapour Products business is the result of the 2020 year-end accounting true up, driven by the reconciliation of the actual operating profit for the Vapour Products business against the target operating profit based on the limited risk distribution (LRD) model; and

iv. *professional fees*: positive variance of \$4.8 million that consists of a positive permanent variance of \$4.3 million and a positive timing variance of \$0.5 million that is expected to reverse in the future reporting period.

K. CASH FLOW FORECAST

- 36. Imperial, with the assistance of the Monitor, has prepared a Cash Flow Forecast for the 30-week period ending the week of September 27, 2021. The Cash Flow Forecast is attached as Appendix "D" to this Report.
- 37. During the Forecast Period, total operating receipts are forecast to be approximately \$2,886 million and total operating disbursements are forecast to be approximately \$2,665 million, resulting in a net positive operating cash flow of approximately \$221 million. In addition, Imperial forecasts interest income of approximately \$7 million in respect of cash balances on deposit in Canada and professional fee disbursements of approximately \$7 million, such that net cash inflow is forecast to be approximately \$221 million.
- 38. Although net cash flows are positive during the Forecast Period, there are 7 weeks within this period which are forecasted to have negative operating cash flows. These are largely driven by the timing of the payment of taxes and government levies due at the end of each month. Cash flows in the weeks that fall on or around

month-end tax payments are expected to be negative and then offset by the receipt of the positive cash flows during the remainder of the month.

- 39. The Monitor has reviewed the Cash Flow Forecast to the standard required of a Court-appointed monitor by Section 23(1)(b) of the CCAA. Section 23(1)(b) requires a monitor to review the debtor's cash flow statement as to its reasonableness and to file a report with the court on the monitor's findings. The Canadian Association of Insolvency and Restructuring Professionals' Standards of Professional Practice include a standard for a monitor fulfilling its statutory responsibilities under the CCAA in respect of its report on the Cash Flow Forecast.
- 40. In accordance with the standard, the Monitor's review of the Cash Flow Forecast consisted of inquiries, analytical procedures and discussions related to the Cash Flow Forecast and its underlying assumptions. The Monitor's procedures with respect to the assumptions were limited to evaluating whether they were consistent with the purpose of the Cash Flow Forecast. The Monitor also reviewed the support provided by Imperial's management for the assumptions and the preparation and presentation of the Cash Flow Forecast.
- 41. Based on the Monitor's review, nothing has come to its attention that causes it to believe, in all material aspects, that:
 - i. the assumptions are not consistent with the purpose of the Cash Flow Forecast;
 - ii. as at the date of this Report, the assumptions are not suitably supported and consistent with the plans of Imperial or do not provide a reasonable basis for the Cash Flow Forecast; or
 - iii. the Cash Flow Forecast does not reflect the assumptions.
- 42. As described in the Terms of Reference above, since the Cash Flow Forecast is based on assumptions regarding future events, actual results will vary from the

information presented even if the assumptions occur, and the variations could be material. Accordingly, the Monitor expresses no assurance as to whether the Cash Flow Forecast will be achieved. In addition, the Monitor expresses no opinion or other form of assurance with respect to the accuracy of the financial information presented in the Cash Flow Forecast or relied upon by the Monitor in preparing this Report.

43. The Cash Flow Forecast has been prepared solely for the purposes described above, and readers are cautioned that it may not be appropriate for other purposes.

L. NEW TOBACCO AND VAPOUR REGULATIONS

The Tobacco Regulations

44. As noted in previous Monitor's Reports, the majority of the Tobacco Regulations came into force on November 9, 2019. These regulations, *inter alia*, require manufacturers of Tobacco Products to use plain, unbranded packaging. The remaining Tobacco Regulations scheduled to come into force on November 9, 2021, are (i) the slide and shell packaging requirements, which require manufacturers of cigarettes to package such products using a slide and shell package of certain prescribed dimensions, and (ii) the appearance and filter requirements in respect of Tobacco Products that are made in whole or in part of tobacco and intended for use with a device. The Monitor continues to review the operational changes and related expenditures that may be required to meet such requirements.

The Regulation of Vapour Products

45. Vapour Products continue to come under increased global scrutiny resulting in stringent regulation and, in some cases, bans. As noted in previous Monitor's Reports, the Monitor has been advised by Imperial that, due to the new vaping regulations, health concerns and the increased scrutiny of Vapour Products

- globally, there continues to be a high level of uncertainty surrounding the consumer demand for Vapour Products.
- 46. Appendix "E" to this Report summarizes the various regulatory changes related to Vapour Products that have been considered and implemented across Canada since the date of the Eighth Report.

M. UPDATE ON PROPOSED BAT MEXICO PAYMENTS

- 47. As described in previous Monitor's Reports, the Monitor has been advised by Imperial that BAT Mexico will be required to write off the undepreciated cost of certain manufacturing equipment used to package and wrap Tobacco Products for Imperial and the cost of certain wrapping materials and finished goods, all of which have been rendered obsolete by the Tobacco Regulations.
- 48. The total estimated payment amount of \$55 million was anticipated to be billed by BAT Mexico to ITCAN at the end of 2019 pursuant to the terms of the BAT MX Agreement and was reflected in the cash flow forecast in the Seventh Report. ITCAN's payment of the same was disputed by the Quebec Litigation Plaintiffs. Pursuant to the October Endorsement, if the parties cannot resolve this dispute it will return to the Court. Pending a return to the Court, ITCAN has undertaken not to make the payments.
- 49. As of December 14, 2020, BAT Mexico delivered a notice to ITCAN reiterating BAT Mexico's position that ITCAN was obliged to compensate BAT Mexico for the full cost of the obsolete wrapping materials and finished goods pursuant to the terms of the BAT MX Agreement.
- 50. The notice also provided that the above-noted payment would not be made until all the conditions precedent set forth in the Second Amended and Restated Initial Order and the October Endorsement had been satisfied by ITCAN.

No payment has been made to date and the Monitor continues to work with Imperial to review these proposed payments and the underlying documents.

N. OVERVIEW OF THE MONITOR'S ACTIVITIES

- 52. Since the date of the Eighth Report, the Monitor and its counsel have held numerous meetings and/or discussions with Imperial and its counsel to:
 - i. monitor Imperial's business activities;
 - ii. monitor Imperial's receipts and disbursements;
 - iii. assist in the preparation of the Cash Flow Forecast;
 - iv. assist in the preparation of an updated five-year financial forecast;
 - v. prepare monthly professional fee disclosures;
 - vi. gather and review Information to be included in the Imperial Data Room;
 - vii. address vendor and stakeholder inquiries;
 - viii. review proposed capital expenditures; and
 - ix. further their understanding of Imperial's business environment and the factors expected to impact its future business prospects.
- 53. The Monitor has continued to engage with Imperial to understand the supply chain disruptions to its operations as a result of the COVID-19 Pandemic, to review Imperial's business contingency plan and to provide the updated analysis of the actual financial impact of the COVID-19 Pandemic on Imperial's business.
- 54. The Monitor has also regularly attended meetings with the Court-Appointed Mediator and stakeholders and has provided the Court-Appointed Mediator with information necessary to advance the Mediation.

55. The Tobacco Monitors and their counsel have met regularly to discuss ongoing matters including the Mediation, reviewing Information to be included in the data rooms of the Applicants, procedural aspects of these CCAA Proceedings and the relief sought herein.

Litigation Update

- On October 23, 2020, counsel to the Monitor delivered notices to the courts in which actions had been brought against the Applicants prior to their CCAA filings, informing such courts of the extension of the Stay Period pursuant to the March 2021 Stay Extension Order.
- 57. The Monitor is also aware of and has been monitoring various ancillary litigation matters involving, and information requests posed to, Imperial following the initiation of the CCAA Proceedings and the implementation of the Stay of Proceedings. The Monitor believes Imperial has been acting in good faith with respect to such matters, addressing each on a case-by-case basis and apprising the Monitor of the action it intends to take ahead of time. The amounts at issue have been largely immaterial.

Professional Fee Disclosure

58. Pursuant to the Professional Fee Disclosure Order, the Monitor continues to provide to the Quebec Litigation Plaintiffs and other parties who requested such information, a summary, by firm, of the restructuring fees incurred on or after March 12, 2019 and paid to the CCAA Professionals each month.

O. STAY OF PROCEEDINGS

59. Imperial is seeking an extension of the Stay Period to September 30, 2021. The Monitor understands that such extension is necessary for Imperial to operate the business in the ordinary course as it continues to engage in the Mediation conducted by the Court-Appointed Mediator and to work towards developing a plan of

compromise or arrangement for a pan-Canadian global settlement of the Tobacco Claims.

- 60. The Monitor supports an extension of the Stay of Proceedings for the following reasons:
 - (a) Imperial is acting in good faith and with due diligence;
 - (b) Imperial is continuing to engage meaningfully in the Mediation with the Court-Appointed Mediator in an effort to reach a pan-Canadian global settlement of the Tobacco Claims; and
 - (c) the Cash Flow Forecast reflects that Imperial is projected to have sufficient funding to continue to operate in the normal course through the proposed extension to the Stay of Proceedings.

The Monitor respectfully submits this Report.

PROTOCOL FOR MOTION BY ZOOM VIDEO CONFERENCE

Scheduling and Specific Requirements

- 1. Any person on the Service List that wishes to appear virtually on the motion, ("Participants") must register by 4:00 p.m. three (3) business days in advance of the hearing (Thursday, March 25, 2021 for the motion scheduled Tuesday, March 30, 2021), by emailing Veritext Litigation Solutions Canada, Inc. (scheduling@neesonsreporting.com) and copying each Monitor's counsel (mpercy@dwpv.com, msassi@casselsbrock.com, nancy.thompson@blakes.com) and also advise if they intend to make submissions. All Participants will provide contact information, including a name, who they are acting for, an email address and phone number for the counsel slip.
- 2. Subject to the Court's overriding discretion over all matters, Monitors' counsel will coordinate with Participants and the Court to develop an agenda for the hearing.
- 3. Participants will appear by video. Monitors' counsel will distribute the Zoom link and the sync.com link to Participants. Participants are not permitted to forward or share either the Zoom link or the sync.com link. No person should have access to the hearing on Zoom other than Participants. If a Participant is unable to attend by video, they should contact Monitors' counsel.
- 4. Counsel is not required to gown for the hearing. Instead, business attire is required for all Participants appearing by video.
- 5. For access by the general public, a YouTube link will be posted on each of the Monitors' websites by 10:00 a.m. not less than two (2) business days prior to the hearing. The YouTube link will allow the general public to view a livestream of the hearing, but not participate in the hearing. For greater clarity, individuals viewing the livestream via YouTube will not be heard or seen by the Court, Judge or Participants.
- 6. No recording of any part of the hearing (including audio) may be made unless authorized in advance by the Court.
- 7. For greater certainty, notice and service requirements are set out in the Rules of Civil Procedure, and the various orders and endorsements in the proceedings. For ease of reference, we have included paragraphs 58-63 of the Second Amended and Restated Initial Order dated March 8, 2019 in the JTIM proceedings, attached as Appendix "A". It should be noted that similar notice and service requirements have been set out in various orders and endorsements in the

parallel proceedings of Imperial and RBH. Nothing in this protocol modifies or amends Orders of the Court related to service requirements, the Rules of Civil Procedure, any Commercial List Practice Direction or other applicable rules.

- 58. **THIS COURT ORDERS** that, subject to paragraph 59, all motions in this proceeding are to be brought on not less than seven (7) calendar days' notice to all persons on the Service List. Each Notice of Motion shall specify a date (the **"Return Date"**) and time for the hearing.
- 59. **THIS COURT ORDERS** that motions for relief on an urgent basis need not comply with the notice protocol described herein.
- 60. **THIS COURT ORDERS** that any interested Person wishing to object to the relief sought in a motion must serve responding motion material or, if they do not intend to file material, a notice in all cases stating the objection to the motion and the grounds for such objection in writing (the **"Responding Material"**) to the moving party, the Applicant and the Monitor, with a copy to all Persons on the Service List, no later than 5 p.m. on the date that is four (4) calendar days prior to the Return Date (the **"Objection Deadline"**).
- 61. **THIS COURT ORDERS** that, if no Responding Materials are served by the Objection Deadline, the judge having carriage of the motion (the "**Presiding Judge**") may determine:
 - (a) whether a hearing is necessary;
 - (b) whether such hearing will be in person, by telephone or by written submissions only; and
- (c) the parties from whom submissions are required(collectively, the "Hearing Details"). In the absence of any such determination, a hearing will be held in the ordinary course.
- 62. **THIS COURT ORDERS** that, if no Responding Materials are served by the Objection Deadline, the Monitor shall communicate with the Presiding Judge regarding whether a determination has been made by the Presiding Judge concerning the Hearing Details. The Monitor shall thereafter advise the Service List of the Hearing Details and the Monitor shall report

63. THIS COURT ORDERS that if any party objects to the motion proceeding on the Return Date or believes that the Objection Deadline does not provide sufficient time to respond to the motion, such objecting party shall, promptly upon receipt of the Notice of Motion and in any event prior to the Objection Deadline, contact the moving party and the Monitor (together with the objecting party and any other party who has served Responding Materials, the "Interested Parties") to advise of such objection and the reasons therefor. If the Interested Parties are unable to resolve the objection to the timing and schedule for the motion following good faith consultations, the Interested Parties may seek a scheduling appointment before the Presiding Judge to be held prior to the Return Date or on such other date as may be mutually agreed by the Interested Parties or as directed by the Presiding Judge to establish a schedule for the motion. At the scheduling appointment, the Presiding Judge may provide directions including a schedule for the delivery of any further materials and the hearing of the contested motion, and may address such other matters, including interim relief, as the Court may see fit. Notwithstanding the foregoing, the Presiding Judge may require the Interested Parties to proceed with the contested motion on the Return Date or on any other date as may be directed by the Presiding Judge or as may be mutually agreed by the Interested Parties, if otherwise satisfactory to the Presiding Judge.

APPENDIX "B"

- 1. All Participants will have their microphones muted and may only unmute their own microphones when they are addressing the Court. When parties are not muted, they must avoid making extraneous noise (including for example, typing and shuffling papers) as these noises may interfere with the hearing.

APPENDIX "E" REGULATION OF VAPOUR PRODUCTS

Please see below for a summary of the vaping regulations that are being considered and implemented across Canada since the date of the Eighth Report.

- 1. Federal On December 19, 2020, Health Canada published a regulatory impact analysis statement on high-nicotine concentration Vapour Products and proposed for consultation the Concentration of Nicotine in Vaping Products Regulations, which would (i) establish a maximum nicotine concentration of 20 mg/mL for Vapour Products manufactured or imported for sale in Canada, (ii) prohibit the packaging and sale of Vapour Products if the nicotine concentration displayed on the package exceeds 20 mg/mL and (iii) amend the Vaping Products Labelling and Packaging Regulations to align this limit for Vapour Products intended for the domestic market, while continuing to prohibit a nicotine concentration of 66 mg/mL or more in Vapour Products intended for export. The consultation period for these proposed regulations closes on March 4, 2021.
- 2. Alberta On June 26, 2020, Alberta passed Bill 19, which amended Alberta's existing tobacco legislation to add vapour products to its purview. Vapour products will be regulated in essentially the same way as Tobacco Products with respect to public use, sale to youth, display and promotion. Since the date of the Eighth Report, this legislation has not yet been proclaimed into force.
- 3. Quebec On December 9, 2020, in response to the recommendations set out in a report of the National Director of Public Health, the Minister of Health and Social Services announced that Quebec would implement regulations to restrict the sale of flavoured Vapour Products and limit the maximum nicotine concentration of all Vapour Products to 20 mg/mL, as well as limit the capacity of tanks and the maximum volume of bottles of liquid to be vaped. As of the date of this Report, the government of Quebec has not published or enacted such regulations.

4. *Prince Edward Island* – On March 1, 2021, Prince Edward Island's regulations banning the sale of flavoured vaping products, other than tobacco flavoured products, came into force.
