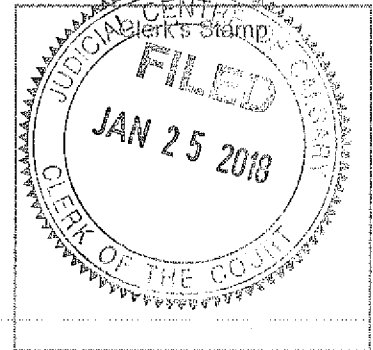

**UPON THE APPLICATION** of counsel for the Applicants, Manitok Energy Inc. (“**Manitok**”), Raimount Energy Corp. (“**Raimount**”) and Corinthian Oil Corp. (“**Corinthian**” together with Manitok and Raimount, the “**Applicants**”); **AND UPON** reading the Affidavit of Massimo Geremia sworn January 19, 2018; **AND UPON** hearing the submission of the Applicant’s counsel and any other counsel present; **AND UPON NOTING** the consent of counsel to National Bank of Canada and FTI Consulting Canada Inc. in its capacity as Proposal Trustee;

**IT IS HEREBY ORDERED THAT:**

1. The time for service of the Notice of Application for this Order is dispensed with and this Application is properly returnable today.
2. The time within which a proposal must be filed by each of Manitok and Raimount with the Official Receiver pursuant to section 62(1) of the *Bankruptcy and Insolvency Act* R.S.C., 1985, c. B-3, and the stay of proceedings in favor of each of Manitok and Raimount, be and is hereby extended to 11:59 p.m. Mountain Standard Time on February 14, 2018.
3. For clarification, the Sealing Order, granted on January 12, 2018 in these proceedings by the Honourable Madam Justice K.M. Horner applies only the Confidential Exhibits “I”, “J”, “AA”, “DD”, “EE”, and “FF” to the affidavit of Audrey Ng, sworn January 11, 2018 in these proceedings. Such Sealing Order does not apply to the entirety of these proceedings, and in particular, does not apply to the transcripts of the Application heard before the Honourable Madam Justice K.M. Horner on January 12, 2018 at 2:00 p.m. at the Calgary Courts Centre.
4. There shall be no costs awarded to any party with respect to this Application.
