AFFIDAVIT OF BARRY BRIDGES

I, **BARRY BRIDGES**, of the City of Estevan, in the Province of Saskatchewan, Lawyer, **MAKE OATH AND SAY AS FOLLOWS THAT:**

1. I and my wife, Bonnie Bridges, are shareholders in Phenomenome Discoveries Inc. ("PDI") and limited partners in Tancho Capital (I) Limited Partnership, which is itself a shareholder of PDI, such that I have personal knowledge of the facts and matters hereinafter deposed to, except where stated to be based upon information and belief, and where so stated, I believe the same to be true.
2. In 2010, when my wife and I invested in PDI, we were told that the plan was to develop the diagnostic and therapeutic assets of PDI to the point where they could be sold and the shareholders could exit PDI with a profit in five years.
3. On Thursday, November 12, 2015, I received e-mail correspondence from Dr. Dayan Goodenowe, the President and Chief Executive Officer of PDI, in which he stated, *inter alia*, that he had terminated John Hyshka's employment by PDI and he that was changing the business plan into one where PDI would make an initial public offering of shares.
4. As a result of receiving this e-mail correspondence from Dr. Goodenowe, I spoke with other shareholders of PDI and we were all alarmed by this unilateral change of course for PDI, especially when we knew that some drug companies were interested in buying PDI's assets.
5. My wife and I have lost confidence in Dr. Dayan Goodenowe continuing to be the CEO and President of PDI and other shareholders and investors in PDI have expressed similar concerns to me.

6. I make this Affidavit in support of an application by Golden Opportunities Fund Inc. for an Order appointing a receiver of the property, assets and undertaking of PDI.
