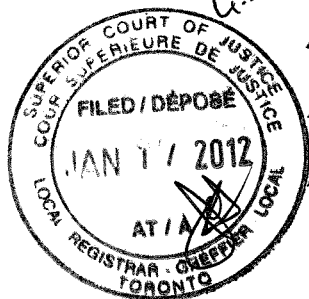

Pursuant to the Sanction Order, the Court ordered that upon the filing of the Discharge Certificate by the Monitor certifying that the matters set out in paragraph 19 of the Sanction Order are completed to the best of the Monitor's knowledge, FTI Consulting Canada Inc. shall be discharged from its duties and obligations as Monitor of the Applicants pursuant to the Plan and all Orders made in these proceedings.
- D. Unless otherwise defined herein, capitalized terms shall have the meaning set out in the Sanction Order.
