ENDORSEMENT OF MADAM JUSTICE J. DIETRICH:

- [1] On June 19, 2025, I made an endorsement, among other things, scheduling a motion by the Monitor for an order amongst other things, declaring that Mr. Timothy Shaw is in breach of the Property Preservation Order made by me in these proceedings on May 30, 2025 (the "Contempt Motion").
- [2] On July 18, 2025, counsel advised that the Contempt Motion was substantially settled, subject to certain documentation that was expected to be exchanged and accordingly, I converted today's hearing to a case conference.
- [3] Counsel has now advised the only outstanding matter with respect of the Contempt Motion is one of costs. Mr. Shaw's counsel advises that in order to properly respond to costs submissions by the Monitor it may be necessary for him to first file a responding affidavit. Accordingly, the following schedule is established for costs submissions on the Contempt Motion: (i) Mr. Shaw to deliver a responding affidavit, if necessary by August 5, 2025; (ii) the Monitor to deliver a responding report, if necessary, and cost submissions by August 19, 2025; and (iii) Mr. Shaw to deliver cost submissions by September 5, 2025. Costs submissions should be no more than five pages and should be emailed to the Commercial List Office.
- [4] Separately, on June 19, 2025, I also booked the hearing of a motion (the "TUV Motion") for October 17, 2025. Counsel advise that they need more time to properly prepare for that hearing. Accordingly, October 17, 2025 is vacated and the TUV Motion is scheduled to be heard for one full day on December 4, 2025.
