ENDORSEMENT OF JUSTICE J. DIETRICH:

[1] This is the third case conference that has been held because Mr. Shaw has failed to deliver documents to the Monitor. The first was on January 27, 2026 and the second was on February 2, 2026. It is now February 10, 2026.

[2] Counsel for Global Holdings and Mr. Shaw has not advised of any substantive issues with the relevant documents. He advises certain documents were submitted to be apostatized on February 4, 2026 and other documents have now been signed and should be delivered to the Monitor today.

[3] Repeated case conferences of this type should not be necessary. If all documents are not completed and returned to the Monitor by the end of this week a further case conference can be booked before me next week. As discussed at today's hearing, that should not be necessary. If it is, Mr. Shaw should expect cost consequences.
