**IN THE MATTER OF THE NOTICE OF INTENTION TO MAKE A PROPOSAL OF
SHAW-ALMEX INDUSTRIES LIMITED**

TO THE CREDITORS OF SHAW-ALMEX INDUSTRIES LIMITED:

On March 29, 2025, Shaw-Almex Industries Limited (the “**Company**”) filed a Notice of Intention to Make a Proposal (“**NOI**”) pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act (Canada)*, R.S.C. 1985, c. B-3 (the “**BIA**”) and FTI Consulting Canada Inc. (“**FTI**”) was appointed as Proposal Trustee of the Company (the “**Proposal Trustee**”). A copy of the NOI, together with the list of creditors, are enclosed herewith.

Please be advised that the Company is not bankrupt, rather it has availed itself of a procedure whereby a company, with creditor and Court approval, restructures its financial affairs. Shaw-Almex Industries Limited commenced the NOI proceedings to create a stabilized environment in order to allow the Company the opportunity to evaluate its strategic alternatives. At present, creditors are not required to file a proof of claim. The Trustee will provide you with further information and a proof of claim form, if necessary, at a later date.

During these NOI proceedings:

- Pursuant to section 65.1 (1) of the BIA, no person may terminate or amend any agreement with the Company, or claim an accelerated payment, or a forfeiture of the term, under any agreement with Company, by reason only that the Company is insolvent or by reason of filing of the Notice of Intention;
- Pursuant to section 69.1 (1) of the BIA, no creditor has any remedy against the Company or its property, or shall commence or continue any action, or other proceedings against the Company;
- Pursuant to section 69.31 (2), no person may commence or continue any action against a director of the corporation on any claim against directors that arose before the commencement of these NOI proceedings and that relates to obligations of the corporation where directors are under any law liable in their capacity as directors for the payment of such obligations; and
- Suppliers should discuss directly with their usual Company contact the terms of payment for goods and/or services that they provide to the Company.

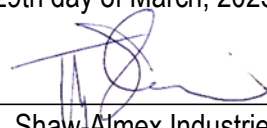
