ENDORSEMENT OF JUSTICE KIMMEL:

1. The parties are working under a compressed timetable to return to address the contested issues. In the meantime, those directly engaged in this dispute have agreed that they require some more time and have proposed, in the meantime, an order extending the stay and adjourning the come-back hearing, which is not opposed by any party and is supported by the proposed Monitor.
2. On that basis, I have signed the requested stay extension order, which shall have immediate effect without the necessity of formal issuance and entry.
3. The parties engaged in the matters in dispute have agreed to the following timetable for matters to be completed in advance of the come-back hearing now scheduled before me on October 24, 2023 commencing at 10:00 a.m.:
 - a. AHG delivers Notice of Motion and preliminary list of witnesses (39.03 and affiants) by noon on Friday, October 13.
 - b. Tacora files any additional material by end of day Sunday, October 15.
 - c. AHG files responding motion material by end of day Monday, October 16.
 - d. Tacora files any reply material by end of day Tuesday, October 17.
 - e. Examinations on Wednesday, October 18 and Thursday, October 19.
 - f. Exchange of facta by 5:00pm on Sunday, October 22.
 - g. Exchange of any reply facta (limited to five pages) by 2:00pm on Monday, October 23.
 - h. Hearing on Tuesday, October 24, scheduled for ½ day before Justice Kimmel.
4. The previously scheduled come-back hearing date of October 19, 2023 at noon has been vacated.
5. Given the compressed timetable and limited time for witness examinations, counsel should work co-operatively, provide information about the intended examinations in a timely manner and shall try to schedule them with a view to efficiency but first and foremost, so as to accommodate the witnesses' availability.
