SUPPLEMENTARY AFFIDAVIT OF WESTIN LOVY SWORN DECEMBER 8, 2023

- I, **Westin Lovy**, of the City of Stamford, in the State of Connecticut, MAKE OATH AND SAY:
- 1. I, Westin Lovy, am a Managing Director of Post Road Group LP ("**PRG**"), which is the parent company to the Applicant, MBL Administrative Agent II LLC ("**MBL**" or the "**Applicant**"). As such, I have personal knowledge of the matters deposed to herein.

- 2. As described in my first Affidavit dated December 4, 2023, as part of the Security in favour of MBL, the Borrowers, TX Canada, Techlantic and Tradexpress have entered into blocked accounts agreements with Royal Bank of Canada ("RBC") and deposit account control agreements with Silicon Valley Bank ("SVB") in favour of MBL (the "DACAs").1
- 3. MBL does not have DACAs over <u>all</u> of the Respondents' bank accounts. I am aware of at least two of the Respondents' bank accounts with RBC and at least five of the Respondents' bank accounts with SVB that MBL does not have DACAs over.
- 4. Since October 2023, MBL has made efforts to work with both RBC and SVB to gain control over these accounts but continues to be unsuccessful because both RBC and SVB require the account holders to consent, which the Respondents refuse to provide. Despite acknowledging that all of the Respondents' inbound funds must be placed into accounts over which MBL has DACAs in order to satisfy the Indebtedness, the Respondents continue to place funds into their other accounts to be used to pay for their business operations, including their payroll and suppliers, and continue to avoid signing amended agreements that would allow MBL to sweep the Respondents' funds. Attached as **Exhibit "A"** is email correspondence that I had with Holland & Knight LLP², RBC and Techlantic in which Techlantic refused to sign an amended blocked account agreement with RBC in favour of MBL.

Capitalized terms used in this Affidavit but not defined herein have the meanings ascribed to them in my Affidavit sworn December 4, 2023.

Thank you Ece for the explanation.

Wes, Joe and others.

I am open for suggestions on how to best organize to make sure PRG is confident that all inbound funds are directed to PRG after covering critical expenses. Techlantic is already doing this and will continue. If you prefer Michelle to transfer funds to the blocked account instead of sending repayments to PRG directly that can be coordinated but I don't see the benefit personally.

Below are the main expenses that we plan to pay for to continue to keep the Techlantic team compensated, and the business properly insured while the team continues to focus on the collection efforts with TRADE X. Below is lower than what was communicated in a previous budget. If there are other expenses, it will be in line with what is already communicated and in line with the common goal of effectively liquidating all assets of Techlantic and TRADE X. We will of course keep it very well communicated.

Key main expenses for operation:

- 1. ADP = \$40,604.56 this is based on last payroll. The amount will vary slightly depending on the ADP calculations and Techlantic obligations to maintain payroll.
- 2. Canada Life = \$4,342.47 this is based on a quote of \$4,020.81 plus PST.
 - a. Nov/23's premium was just automatically withdrawn today and was lower than this value.
- 3. Cowan Insurance = \$4,604.46 automatically withdrawn 1st of the month.
- 4. Marine insurance = $^{\sim}$ \$10,000 one time expense to keep policy in good standing as Techlantic has stopped shipping vehicles so there are no expenses on this policy expected in the future.
- 5. Rent = ~\$1500/month between the office and storage facility for files.
- 6. IT = ~\$2000/month In order of importance and coincidently cost: cloud server for accounting to coordinate, Microsoft licensing, Phone system, Adobe and Zoho licensing

7. Logistics – Invoices required to release vehicles that are being collected on. Currently Techlantic is up to date but there are still some invoices that are required to pay in the future that is already budgeted for in the transactions. We will of course continue to communicate each one and why it is important.

Also, I wanted to let you know that there is an inbound HST return on Monday which I believe exceeds the HST amount pledged to PRG so there is excess funds that we plan to use to cover next weeks payroll. This will allow Techlantic to continue to stay on track to exceed the planned repayment schedule from Techlantic for another couple weeks.

I have connected to Eric and discussed the details of the current blocked accounts and non-blocked account; regarding the request to add the non-blocked accounts under the existing Blocked Account Agreement.

Based on our discussion and the Blocked Account Procedure, I have listed below the operational details of the blocked and non-blocked accounts;

- 1. All accounts will remain open as they are and no new amendments to be done to the list of the blocked accounts in the BAA.
- 2. Client (TECHLANTIC LTD) must receive all incoming funds into the two activated blocked accounts ending with 5037 and 7100. These funds will then be swept to the secured party via daily wire sweeps. Client must ensure all payments are directed to these blocked accounts and must communicate accordingly to its customers as required.
- 3. The two accounts ending in 4050 and 1392 (non-blocked accounts) must only be used for outgoing payments. These accounts will be funded by the secured party based on the expenses of the business. Client and secured party will have to work together to manage that.
- 4. The two accounts that the parties are looking to add into the blocked accounts list in BAA contain disbursements (including payroll) and products that are not allowed on blocked accounts as per the Blocked Account Policy.
- 5. Client to provide instructions to the Bank to transfer all the funds in the accounts 4050 and 1392 to 5037 and 7100 (blocked accounts) and the funds can be swept to the secured party. We will complete the transfer of these funds based on client's instructions. Secured party cannot provide instructions for the non-blocked accounts.
