- 1. Accede Energy Services Ltd. (the "Company") was subject to a Receivership proceeding prior to the Bankruptcy. All of the Company's assets sold during the Receivership proceeding and were encumbered by a secured creditor claim .Accordingly, there were no assets available for the Trustee to realize on.
- 2. The Receiver has guaranteed all expenses in the Bankruptcy including the Trustee's fees and disbursements.
- 3. The Receiver has made the following payments on behalf of the Trustee in order to administer the Bankruptcy estate:
- Costs for posting advertisements in local newspaper
- Costs relating to sending notice of bankruptcy and first meeting of creditors
- 4. The Trustee expects its total fees to be \$5,305.00 before taxes and has included a WIP Summary with the SRD.
- 5. The first meeting of creditors was not attended

by any creditors, therefore there were no instructions given to the Trustee. As the bankrupt estate has no assets and the Trustee has no further tasks relating to the administering the estate of the bankrupt the Trustee intends to proceed with finalizing the SRD and proceeding to seeking its discharge.
