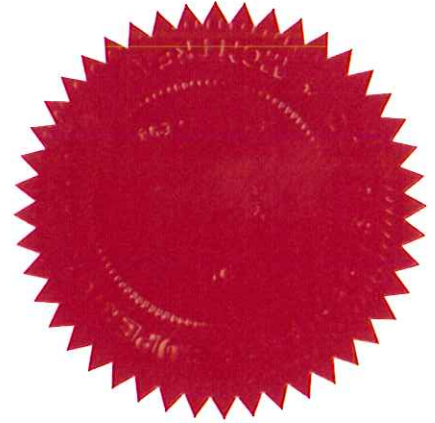

ORDER TEMPORARILY LIFTING THE STAY OF PROCEEDINGS
(Section 11.02 of the *Companies Creditors Arrangement Act*)

- [1] **ON READING** the Creditor / Petitioner's Motion entitled *Requête pour lever temporairement la suspension des procédures* pursuant to Section 11.02 of the *Companies Creditors Arrangement Act* (the "CCAA"), corresponding to entry number 26 on the Court record print-out (the "Motion"), the affidavit and the exhibits in support thereof;
- [2] **CONSIDERING** the Motion, the affidavit and exhibits in support thereof;
- [3] **CONSIDERING** the absence of contestation by either the Petitioners / Respondents or the Monitor;
- [4] **CONSIDERING** paragraph 56 of the Order issued by the Honourable Justice Martin Castonguay, J.S.C. on January 27, 2015, as amended on February 20, 2015 (the "Initial Order");

WHEREFORE THE COURT:

- [5] **GRANTS** Petitioner's Motion entitled *Requête pour lever temporairement la suspension des procédures*;
- [6] **DECLARES** the stay of proceedings provided for in the Initial Order lifted on a *nunc pro tunc* basis, for the sole purpose of allowing the service and registration of the notice of legal hypothec registered on January 27, 2015, in the Land Registry for the Cadastral Division of Saguenay under number 21 318 279 (the "Gérald Leblond Legal Hypothec") as of that date;
- [7] **LIFTS** the stay of proceedings provided for in the Initial Order, for the sole purpose of allowing the service and registration of a prior notice of the exercise of a hypothecary right in respect of the Gérald Leblond Legal Hypothec;
- [8] **THE WHOLE** without costs.
