## MEMORANDUM

Re: **Mining Searches – Cliffs Québec Mine de Fer Limitée**

---

We have conducted the searches hereinafter described in respect of the mining titles listed under the heading "Mining Titles" in Appendix "A" hereto, which comprises 466 active map designated claims (the "Claims").

For the purposes hereof, we have conducted the searches hereinafter described in respect of the Claims. In conducting our searches, we have assumed the accuracy of the mining title identification numbers of the Claims. We have not conducted any investigations as to the accuracy of the mining titles identification numbers of the Claims, nor conducted any searches other than those identified in this opinion.

### I. Public register of real and immovable mining rights

We have reviewed the computerized printouts (fiches) of mining titles obtained electronically on January 14, 2015 at 8:48 p.m. (the "PRRIMR Effective Date") from the on-line public register of real and immovable mining rights granted under the Mining Act (as defined below) (the "PRRIMR") (via the Gestim Plus title management system) in respect of the Claims (the "PRRIMR Records"). The PRRIMR is maintained by the Ministère de l'Énergie et des Ressources naturelles (Québec) (the Quebec Ministry of Energy and Natural Resources) ("**MERN**") pursuant to the *Mining Act* (Quebec) (R.S.Q. c M-13.1) (the "**Mining Act**") to record the mining titles issued pursuant to the Mining Act. For greater certainty, we have not reviewed any maps or NTS sheets or any other information available in the GESTIM Plus in respect of the Claims other than the PRRIMR Records and the deeds, agreements and instruments specifically referred to under the heading "Transfers" and "Instruments or Other Related Documents" in such PPRIMR Records.

We have obtained the PRRIMR Records by conducting a search under the name "**Cliffs Québec Mine de Fé<sup>r</sup> Limitée**" for "active", "suspended", "pending renewal" and "proposed" mining titles only. Such search revealed the Claims, consisting of 466 active map designated claims as set out in Appendix "A" hereto.

On January 19, 2015 at 9:00 a.m. we have also conducted a search at the PRRIMR under the names "Consolidated Thompson Iron Mines Limited" and "Les mines de fer consolidées Thompson Limitée", which

names are the prior names of Cliffs Québec Mine de Fer Limitée, for "active", "suspended", "pending renewal" and "proposed" mining titles only. Such search did not disclose any "active", "suspended", "pending renewal" and "proposed" mining titles registered under the foregoing names.

On December 22, 2014 at 10:29 a.m., we have also conducted a search at the PRRIMR under the following names of companies that amalgamated to form "Consolidated Thompson Iron Mines Limited":

Consolidated Thompson Lundmark Gold Mines Limited  
Thompson-Lundmark Gold Mines Limited  
Hoffman Exploration and Minerals Limited  
166739 Canada Inc.  
(collectively, the "**Pre-Amalgamation Names**")

The search against the Pre-Amalgamation Names did not disclose any "active", "suspended", "pending renewal" and "proposed" mining titles registered under the Pre-Amalgamation Names.

The PRRIMR Records reveal, in particular, the following, as of the PRRIMR Effective Date:

1. **Cliffs Québec Mine de Fer Limitée (titleholder No. 88332)** is shown in the PRRIMR as registered holder of 1% interest in 272 of the Claims defined as "**QMC/CQIM Claims**" in Appendix "C" hereof. **Quinto Mining Corporation (titleholder No. 95800)** is shown in the PRRIMR as the holder of the remaining 99% interest in the QMC/CQIM Claims.

The QMC/CQIM Claims the have been the subject of the transfers identified in Appendix "C".

**Note:** The most recent corporate change that appears in the PRRIMR records for the QMC/CQIM Claims in respect of Cliffs Québec Mine de Fer Limitée is the name change on September 1, 2011 from Consolidated Thompson Iron Mines Limited Les mines de fer consolidées Thompson Limitée to Cliffs Quebec Iron Mining Limited Cliffs Québec Mine de Fer Limitée, as certified by Certificate of Amendment issued by Industry Canada on September 1, 2011.

**The following corporate changes are not recorded in the PRRIMR:**

- (a) Amalgamation on January 1, 2012 pursuant to the *Canada Business Corporations Act* of Cliffs Quebec Iron Mining Limited Cliffs Québec Mine de Fer Limitée ("**Pre-Amalgamation CQIM**") with Cliffs Canada Inc. and continuation as Cliffs Quebec Iron Mining Limited Cliffs Quebec Mine de Fer Limitee.

**Note:** Pursuant to a transfer of mining rights dated March 18, 2014 and registered in the PRRIMR under number 55524 on March 24, 2014, Quinto Mining Corporation transferred 1% of its rights in the QMC/CQIM Claims to Cliffs Québec Mine de Fer Limitée (titleholder Number 88332). Given that the amalgamation on January 1, 2012 is not reflected in the PRRIMR, the

transfer, as far as the opposability to the State (Quebec Government) is concerned, was made to Pre-Amalgamation CQIM. It is not entirely clear how this deficiency can affect the title to CQIM's 1% interest in the QMC/CQIM Claims, given that MERN typically assigns new numbers to new titleholders and it is not clear if it would proceed in the same manner when an amalgamation without a change of name occurs. The Mining Act requires the holder of a mining right or, as the case may be, the operator to notify the Minister in writing within 15 days of any change of operator or of firm name or address. It is recommended to file the documents concerning the foregoing amalgamation with PRRIMR in order that MERN is advised of the proper entity that holds the QMC/CQIM Claims and in order to prevent any title qualifications in respect of the QMC/CQIM Claims.

- (b) Continuation of Cliffs Quebec Iron Mining Limited Cliffs Quebec Mine de Fer Limitee into British Columbia under the *Business Corporations Act* (British Columbia) on April 17, 2014 as Cliffs Quebec Iron Mining Limited Cliffs Quebec Mine de Fer Limitee; and
- (c) Conversion of Cliffs Quebec Iron Mining Limited Cliffs Quebec Mine de Fer Limitee into a British Columbia Unlimited Liability Company on December 4, 2014 pursuant to the *Business Corporations Act* (British Columbia) and change of name to Cliffs Quebec Iron Mining ULC Cliffs Quebec Mine de Fer ULC.

**Note:** The Mining Act requires the holder of a mining right or, as the case may be, the operator to notify the Minister in writing within 15 days of any change of operator or of firm name or address. We recommend the recording of the corporative changes under (b) and (c) above with the PRRIMR in order to comply with the Mining Act, that MERN is advised of the proper entity that holds the QMC/CQIM Claims and in order to prevent any title qualifications in respect of the QMC/CQIM Claims. Without such changes, the recorded holder of the QMC/CQIM Claims is Cliffs Québec Mine de Fer Limitée, a CBCA company.

2. **Cliffs Québec Mine de Fer Limitée (titleholder No. 88332)** is shown as registered holder of 100% interest in 194 Claims defined as "CQIM Claims" in Appendix "C" hereof.

The CQIM Claims the have been the subject of the transfers identified in Appendix "C".

**Note:** Please refer to the notes in section 1 above regarding the corporate changes with respect to CQIM, which apply mutatis mutandis to the CQIM Claims.

3. All Claims have active status.

4. The expiry date of each Claim is set out in the column "Expiry Date" in Appendix "A", and the earliest expiry date is **March 26, 2015**. The term of the Claims may be renewed, prior to the expiry thereof, for periods of two years, subject to compliance with the provisions set forth in the Mining Act. Each Claim will automatically expire on the expiry date of such Claim set forth in Appendix "A", unless renewed prior to the expiry thereof in accordance with the Mining Act.
5. No "Instruments or Other Documents" (for example, hypothecs or other security documents, discharges, royalty and other commercial agreements) are registered in the PRRIMR in respect of the Claims that remain undischarged or not terminated.

In addition to the information summarised above, the PRRIMR Records contain information such as, but not limited to, the location of the claims, the surface area of the claims, the amount of work required for the renewal of the term of the claims and other information. For the purposes of this search report, we have not reviewed such information, but would be pleased to provide it upon request.

Please note that the recording of deeds in the PRRIMR is not necessarily up to date. Moreover, the GESTIM Plus title management system website does not indicate the date to which the recording of deeds thereon is current. According to information received recently from MERN, the current approximate processing time for registration in the PRRIMR of transfers, security and other instruments relating to mining titles is 21 days. Please also note that the PRRIMR does not disclose rights that have been received by MERN for registration in the PRRIMR but have not been processed yet.

## II. Land Register

The Register of Real Rights of State Resource Development is a sub-division of the Land Register. Please note that before December 10, 2013, pursuant to the *Mining Act* (Quebec), mining claims were exempt from registration in the Land Register, although claims could be registered at such register. Effective December 10, 2013 the foregoing exemption was abolished.

### 1. Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay

We have examined on January 15, 2015 the Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay for land files listed under the names "CONSOLIDATED THOMPSON IRON MINES LIMITED" and "QUINTO MINING CORPORATION/LA CORPORATION QUINTO MINING". Such search revealed the existence of the land files opened in respect of the Claims as set out in Appendix "B", namely 194 land files opened in respect of the CQIM Claims (such land files, the "**CQIM Claims Land Files**") and 272 land files opened in respect of the QMC/CQIM Claims (such land files, the "**QMC/CQIM Land Files**", and collectively with the CQIM Claims Land Files, the "**Land Files**").

**2. Register of Real Rights of State Resource Development for the Registration Division of Saguenay**

We have examined the online Land Files at the Register of Real Rights of State Resource Development for the Registration Division of Saguenay (the “**RRRSRD**”), current as to rights as at January 15, 2015, at 4:00 p.m. (the “**RRRSRD Effective Date**”), and current as to discharges as at January 6, 2015, at 4:00 p.m., for the period from January 26, 2010, being the date of the registration of the opening of the Land Files, to the RRRSRD Effective Date. Such searches revealed that, as of the RRRSRD Effective Date:

1. The CQIM Claims Land Files show Consolidated Thompson Iron Mines Limited as holder of the CQIM Claims.

**Note:** The change of name on September 1, 2011 from Consolidated Thompson Iron Mines Limited Les mines de fer consolidées Thompson Llmitée to Cliffs Quebec Iron Mining Limited Cliffs Québec Mine de Fer Limitée and all subsequent corporate changes regarding Cliffs Québec Mine de Fer Limitée identified in Section I.1. above are not reflected on the CQIM Claims Land Files. While it is not required by law to record such changes at the RRRSRD, it is generally recommended to record such changes to facilitate title review for opinion, sale, financing and other transaction purposes.

2. The QMC/CQIM Claims Land Files show Quinto Mining Corporation as sole holder of the QMC/CQIM Claims.

**Note:** The transfer to Cliffs Québec Iron Mining Limited of 1% interest in the QMC/CQIM Claims contemplated by the transfer of mining rights dated March 18, 2014 and registered in the PRRIMR under number 55524 on March 24, 2014 is not registered against the QMC/CQIM Claims Land Files. Given that the exemption from registration at the Land Register was abolished effective December 10, 2013, the foregoing purported transfer of 1% interest in the QMC/CQIM Claims must be registered against the QMC/CQIM Claims Land Files in order to be opposable to (perfected against) third parties. The registration of such transfer requires the execution of a transfer deed in a form registrable at the Land Register. Unless such transfer is registered at the Land Register, there is a discrepancy in respect of the holding of the QMC/CQIM Claims as recorded at the PRRIMR and at the RRRSRD. Furthermore, the failure to register such transfer will also affect the opposability (perfection) of any security granted by CQIM on its 1% interest in the QMC/CQIM Claims, such security not being opposable to third parties until CQIM will have recorded its 1% interest in the QMC/CQIM Claims.

Please note that we have conducted a visual search of the Land Files and have not extensively reviewed the deeds referred to thereat.

Our searches at the Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay and at the RRRSRD under the name "CONSOLIDATED THOMPSON IRON MINES LIMITED" on January 15, 2015 described above also disclosed that land files have been opened in the name of CONSOLIDATED THOMPSON IRON MINES LIMITED in respect of 100 additional mining claims. However, our searches at the PRRIMR show that such claims have an "expired" status as of December 17, 2014, and therefore have been omitted from this report.

We have examined on January 16, 2015 the Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay for land files listed under the names Les Mines de Fer Consolidated Thompson, Cliffs Québec Mine de Fer Limitée, Cliffs Quebec Mine de Fer Limitee, Cliffs Quebec Iron Mining Limited, Cliffs Quebec Mine de Fer Limitee Cliffs Quebec Iron Mining Limited and Cliffs Québec Mine de Fer Limitee Cliffs Quebec Iron Mining Limited. Such search revealed no land files opened under these names.

Our searches at the Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay and at the RRRSRD under the name QUINTO MINING CORPORATION on January 15, 2015 also disclosed that land files have been opened in the name of QUINTO MINING CORPORATION in respect of 215 additional mining claims which have been sold by Quinto Mining Corporation, as seller, to Mason Graphite Corp., as purchaser, pursuant to a deed of sale registered at the RRRSRD under number 18 955 913 on April 10, 2012 (the "**Deed of Sale**"). Please note that the Deed of Sale contains a right of resolution of the sale and a hypothec by Mason Graphite Corp. in favour of Quinto Mining Corporation securing the payment of the balance of the purchase price. Please note that the mining claims listed in the Deed of Sale do not appear in the list of claims disclosed at the PRRIMR as being registered in the name of Quinto Mining Corporation.

We have also examined on January 16, 2015 the Directory of Real Rights Holders of the Register of Real Rights of State Resource Development for the Registration Division of Saguenay for land files listed under the names "Ernest Black", "Ernest D. Black" and "Quinto Technology Inc.". Such search revealed no land files opened under these names.

### III. Index of Names

We have searched the on-line Index of Names for the Registration Division of Saguenay ("**Index of Names**"), current at January 16, 2015 at 1:06 pm, for the period from October 14, 2003, being the date of the computerization of the Registry Office for the Registration Division of Saguenay, under the names "Ernest Black", "Ernest D. Black", "Quinto Technology Inc.", "Quinto Mining Corporation/La Corporation Quinto Mining", "Quinto Mining Corporation" and "La Corporation Quinto Mining". Such search revealed no documents registered at the Index of Names under these names.

We have searched the on-line Index of Names, current at January 16, 2015 at 1:06 pm, for the period from October 14, 2003, being the date of the computerization of the Registry Office for the Registration Division of Saguenay, under the names Consolidated Thompson Iron Mines Limited, Les Mines

de Fer Consolidated Thompson, Cliffs Québec Mine de Fer Limitée, Cliffs Quebec Mine de Fer Limitee, Cliffs Quebec Iron Mining Limited, Cliffs Quebec Mine de Fer Limitee Cliffs Quebec Iron Mining Limited and Cliffs Québec Mine de Fer Limitée Cliffs Quebec Iron Mining Limited. Such search revealed no documents registered at the Index of Names under these names in relation to the Claims.

Please note that we have not searched the Index of Names for the Registration Division of Saguenay for any entries in respect of the names mentioned above registered at said Index of Names prior to the computerization of the Registry Office for the Registration Division of Saguenay as set out above.

#### IV. Companies Registers

We have verified the existence at all relevant times of the corporations appearing in the Chain of Title (PRRIMR) set forth in Appendix "C" by searching the computerized records of the Enterprise Registrar (MIRE system – formerly CIDREQ system) and of the Federal Corporations Data On-line from Industry Canada (Strategis system), as the case may be. With respect to the corporate reorganizations of Cliffs Québec Iron Mining Limited analyzed in Section I hereof, we have relied on the corporate search summary in respect of such entity prepared by other members of our firm current to January 19, 2015.

We have not examined the letters patent, articles of incorporation or other corporate documents of the searched corporations to verify if same contained, among others and without limitation, any restrictions as to the acquisition or alienation of mining rights, immovable properties or any other properties or as to the respective capacity of the corporations representatives.

#### V. General

This search memorandum does not constitute a title opinion in regard to the Claims listed in Appendix "A". No opinion whatsoever is expressed in respect of the hypothecs, transfer documents or any other agreements summarized in this search memorandum.

Please also note that our searches do not disclose:

1. any statutory, legal or conventional hypothecs or other liens to which the Claims may be subject and which are not registered in the PRRIMR, the RRRSRD or in any other register searched for the purposes hereof or which are exempt from registration in such registers; in this regard, please be advised that further to the adoption of the *Act to Amend the Mining Act* (S.Q. 2013, c.32) (the "**Mining Act Amendment**") and the changes brought therewith to Article 13 of the Mining Act in force prior to the Mining Act Amendment, effective December 10, 2013 the registrar of the PRRIMR does not accept for registration at said PRRIMR deeds of hypothec or any other "Instruments or Other Related Documents" in respect of mining claims any longer.
2. any personal unregistered rights such as royalties;

3. the rights granted under the Mining Act to third parties which do not require publication or registration in the PRRIMR, the RRRSRD or in any other register searched for the purposes hereof;
4. the surface rights to the parcels of land subject to the Claims. Under Quebec law, land surface rights are distinct property from the mining rights (i.e. the rights to mineral substances beneath the soil) and complex land title searches must be conducted to determine the holder of the rights to the parcels that are the subject of mining rights;
5. the existence of any rights of third parties to bring forth a motion for recognition of ownership based on prescription nor on the existence of any claim which may be brought by third parties for invalidity of the Claims based on no-existent or incorrect staking;
6. any litigation that may exist in respect of the Claims;
7. the aboriginal title or rights that may exist or claimed in respect of the Claims or the parcels of land subject to the Claims.

The information for our searches was obtained through public office records and the searches were conducted by registry employees and /or by using computer systems and we do not warrant the accuracy of the data generated by the computer systems or received from registry employees. MERN is unable to guarantee the complete accuracy or precision of data made available in the on-line PRRIMR, the online directory of real rights holders (holders of mining rights) and the online register of real rights of State resource development of the Land Register we consulted, or the access to all data contained in such registers. MERN disclaims any responsibility for any loss or prejudice that may result from decisions made, interpretation of the data, or any action or failure to act as a result of using the online PRRIMR, the online directory of real rights holders (holders of mining rights) and the online register of real rights of State resource development of the Land Register we consulted.
