OPENING

The meeting chair, Deryck Helkaa of FTI Consulting Canada Inc. announced that he would be acting as chair and secretary of the first meeting of creditors

CALL TO ORDER

Before calling the meeting to Order, Mr. Helkaa advised that pursuant to section 109(1) of the *Bankruptcy and Insolvency Act* a person is not entitled to vote as a creditor unless the person has duly proved a claim and the proof of claim has been duly filed with the trustee before the time appointed for the meeting.

At 11:00 am, Mr. Helkaa declared the meeting properly called and a quorum being present, duly constituted.

AGENDA

Mr. Helkaa outlined the agenda of the meeting as follows:

PURPOSE OF MEETING

Mr. Helkaa announced that this was the first meeting of creditors of the bankrupt and the purpose of the meeting was to:

- Consider the affairs of the bankrupt
- Answer questions from creditors;
- Affirm appointment of trustee or request appointment of another;
- Appoint inspectors; and
- Obtain instructions from the creditors to the trustee.
