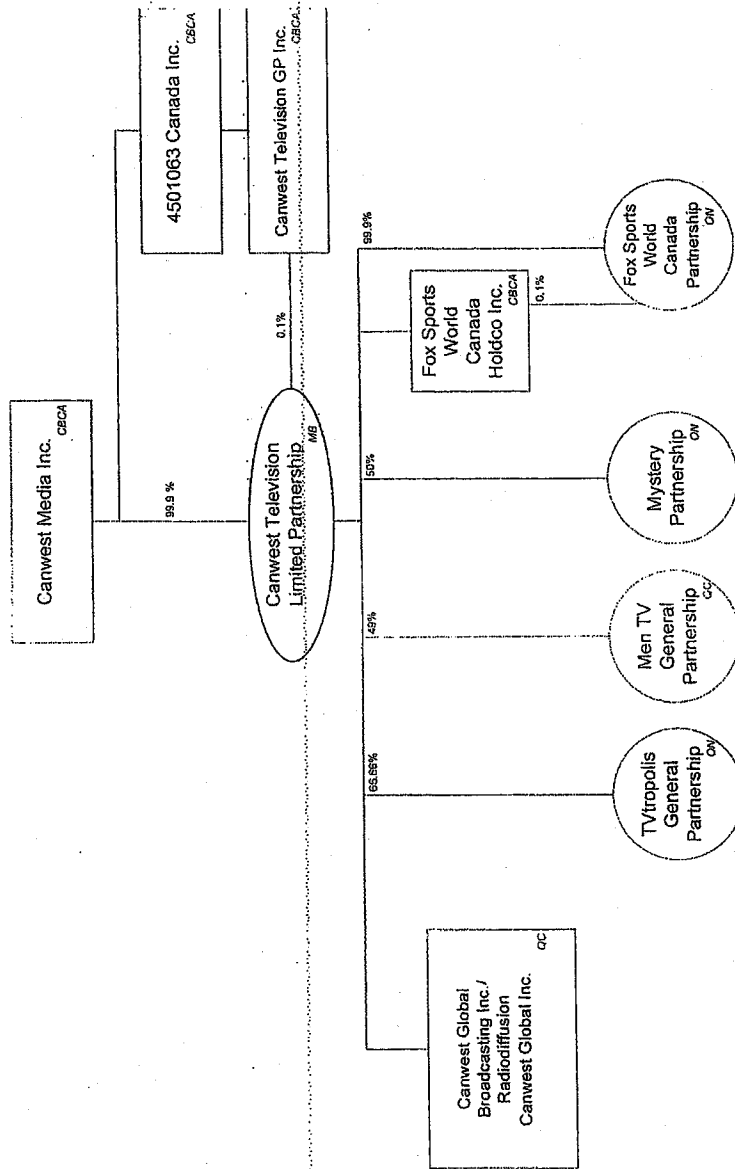

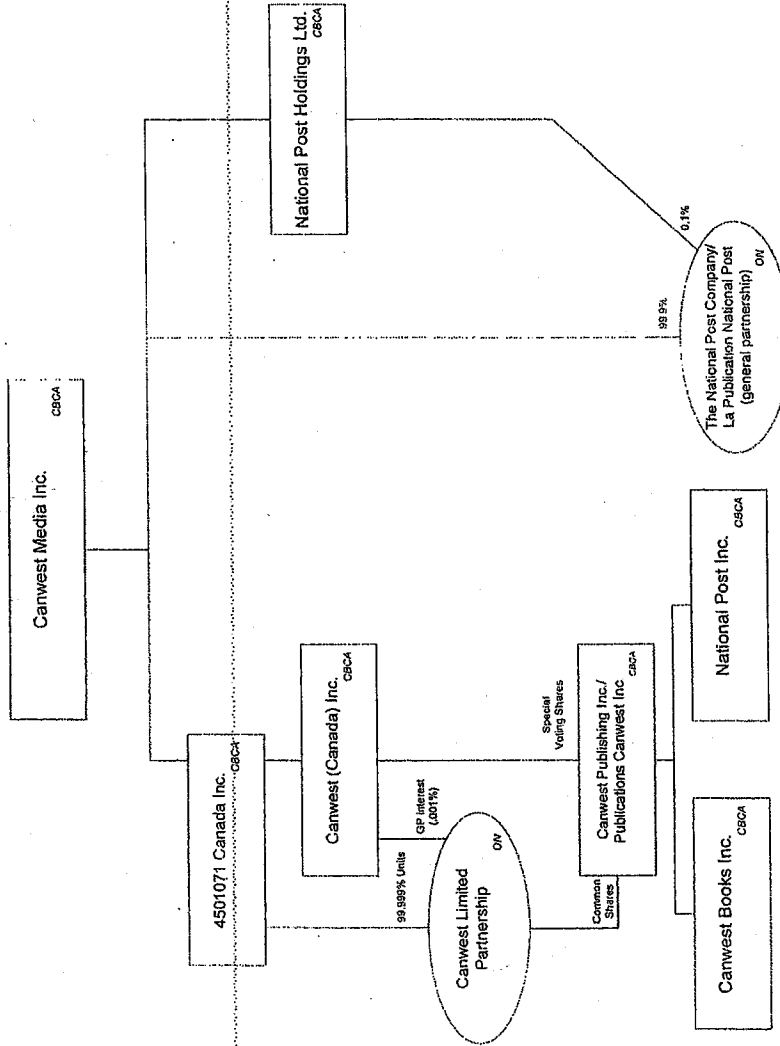

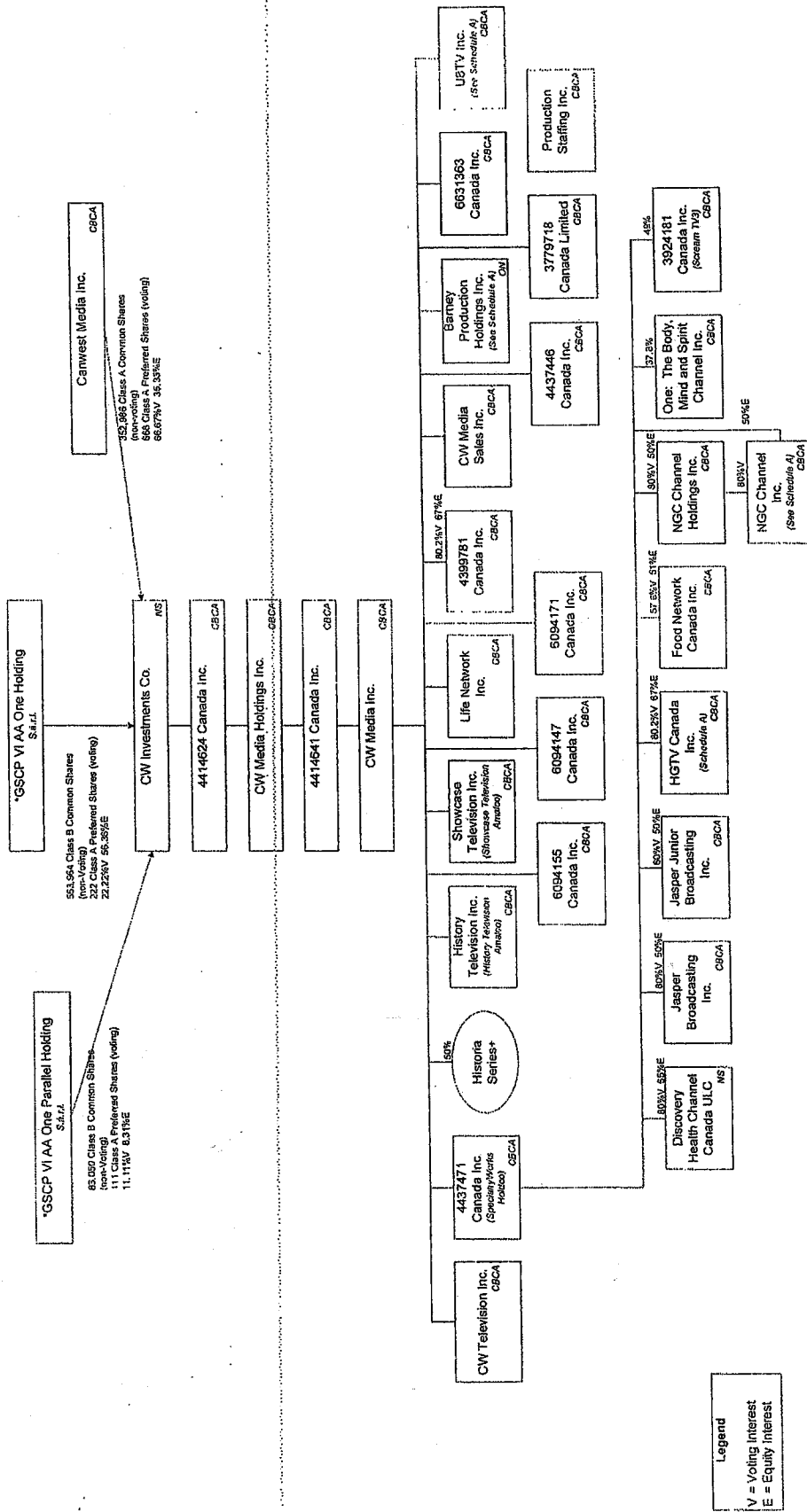

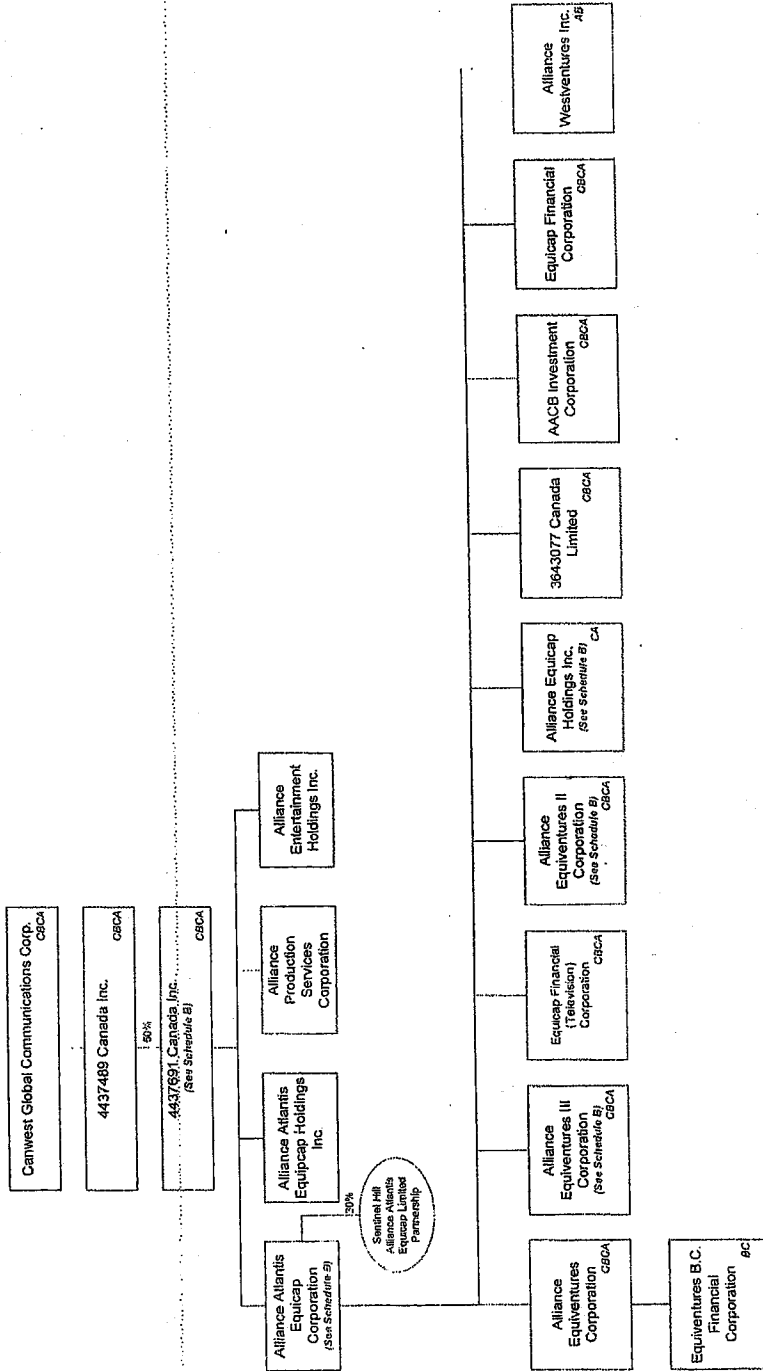

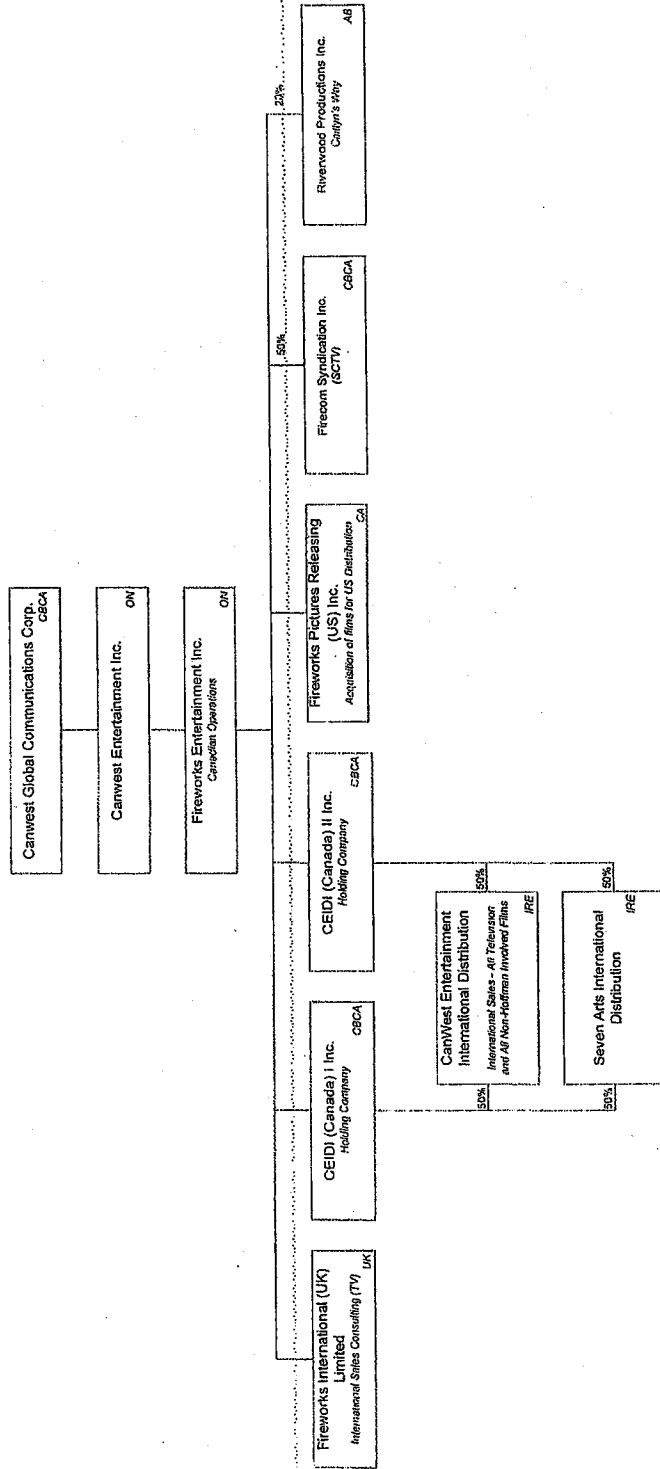

Fireworks Corporate Organization Chart

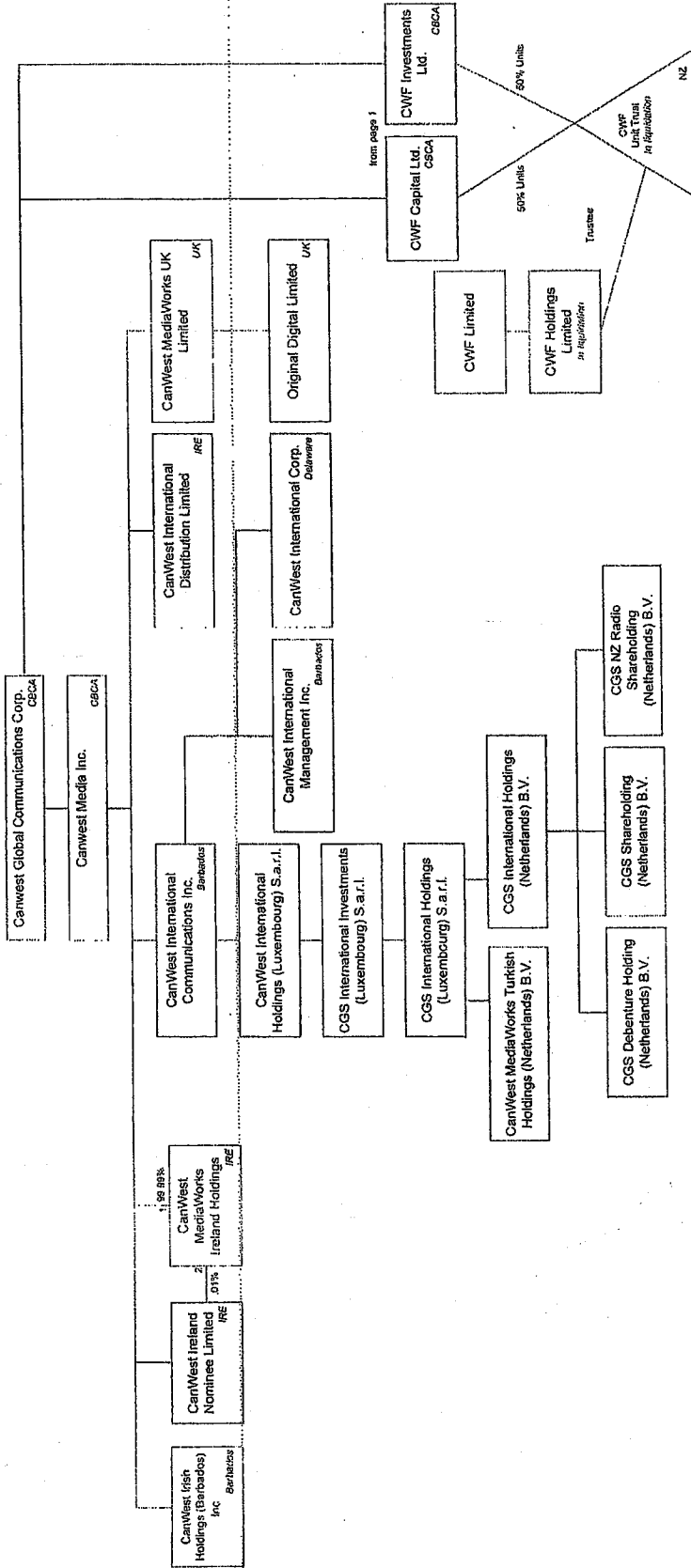
