### Prefiling Claim [1] Timeline:

### Restructuring Period Claim [1] Timeline:

LP Claims Packages are sent to LP Creditors with a Restructuring Claim as soon as practical and no later than 31 Calendar Days before the date of any LP Creditors Meeting.	LP Claims Package is deemed to have been received: (i) 3 Business Days after mailing within Ontario, 5 Business Days after mailing for the rest of Canada, and 10 Business Days after mailing internationally; (ii) if sent by courier or personal delivery, the next Business Day; and (iii) if delivered by facsimile or e-mail by 6 p.m. on the same Business Day	Claims Bar Date for Restructuring Period Claims	Deadline for the LP Entities to revise or reject a Claim and send a Notice of Revision or Disallowance with respect to Restructuring Period Claims	Deadline to file a Notice of Dispute of Revision or Disallowance for LP Creditors with Restructuring Period Claims	Deadline to provide notice of assignment or transfer of a Claim to the Monitor	Court or Claims Officer to notify the LP Entity, the LP Creditor, and the Monitor of the determination of the value of disputed claims sent for adjudication.	Deadline to file a notice of appeal, returnable within 10 Calendar Days

#### Notes

[1] All capitalized terms have meanings as ascribed to them in the LP Claims Procedure Order. Prefiling Claim and Restructuring Period Claim are defined in sections 2(f)(i) and 2(f)(ii) of the LP Claims Procedure Order.

[2] Or 3 weeks after the Monitor posts notice that a determination to proceed with the adjudication of claims has been made.

[3] Or 5 weeks after the Monitor posts notice that a determination to proceed with the adjudication of claims has been made.
