Remedy Claimed or Sought:

- 1. The Applicant, Free Rein Resources Ltd. ("Free Rein") respectfully seeks an Order substantially in the form attached hereto as Schedule "A":
 - (a) abridging the time for service of this Application and the supporting materials and deeming service thereof to be good and sufficient;
 - (b) pursuant to section 50.4 of the *BIA*, extending the period of time within which Free Rein is required to file a proposal to its creditors (the "**Proposal Period**") up to and including December 12, 2023 (the "**Fourth Stay Extension**"); and
 - (c) such further and other relief as may be sought by Free Rein and this Honourable Court may deem appropriate.

Grounds for Making this Application:

- On June 12, 2023, Free Rein filed a Notice of Intention to Make a Proposal (the "NOI") pursuant to section 50.4(1) of the BIA with the Office of the Superintendent of Bankruptcy. FTI is the Proposal Trustee of Free Rein.
- On July 11, 2023, pursuant to the Order of Justice K. Feth, Free Rein obtained an extension to the Proposal Period up to and including August 25, 2023 (the "First Stay Extension").
- 4. On August 25, 2023, Free Rein sought and obtained a second extension to the Proposal Period up to and including October 9, 2023 (the "**Second Stay Extension**").
- 5. Also on August 25, 2023, Free Rein obtained an order approving its sale, refinancing, and investment solicitation process (the "**SISP**").
- 6. On October 5, 2023, Free Rein sought and obtained a third extension up to and including November 23, 2023 (the "**Third Extension**").

Extension of the Proposal Period

7. Free Rein requires the Fourth Stay Extension to continue the restructuring of its business and affairs and to continue implementing the SISP, with the ultimate goal of making a viable proposal to its creditors.

- 8. Since the Third Stay Extension, Free Rein has, among other things:
 - (a) continued its discussions with FTI Consulting Canada Inc. (the "Proposal Trustee"), employees, contractors, vendors, secured creditors, and stakeholders; and
 - (b) continued implementing the SISP.
- 9. Free Rein anticipates that the following milestones will be met if the Fourth Stay Extension is granted:

- 10. The Fourth Stay Extension is appropriate for, among others, the following reasons:
 - (a) Free Rein has acted, and continues to act in good faith and with due diligence;
 - (b) Free Rein will likely be able to make a viable proposal if the Fourth Stay Extension is granted; and
 - (c) no creditor will be materially prejudiced by the requested Fourth Stay Extension.
- 11. The Proposal Trustee supports the Fourth Stay Extension.

- 13. Bench Brief of Free Rein, to be filed;
- 14. Fourth Report of the Proposal Trustee, to be filed; and
