**FOURTH REPORT TO THE COURT OF FTI CONSULTING CANADA INC., IN ITS
CAPACITY AS COURT-APPOINTED RECEIVER OVER THE FCC SECURED
PROPERTY**

INTRODUCTION

1. By order dated May 30, 2024 (the “**Appointment Order**”), on application by Farm Credit Canada (“**FCC**”), FTI Consulting Canada Inc. (“**FTI**”) was appointed receiver (in such capacity, the “**Receiver**”) over the FCC Secured Property (defined below), which included three high-speed ingredient processing and storage facilities in Saskatchewan, located on (i) 100 Elevator Road, Zealandia (the “**Zealandia Lands**”), (ii) R.M. of Lajord No 128, Lajord (the “**Vigro Lands**”, together with Zealandia Lands, the “**Mortgaged Lands**”) and (iii) a leasehold interest in 100 South Railway Avenue, Lajord No. 128, (the “**Leaseholds Lands**” and together with the Mortgaged Lands, the “**Real Property**”) and related equipment located or situated on the Real Property (the “**Equipment**”).
2. Pursuant to a court order dated August 19, 2024, the Receiver, together with FTI Capital Advisors Canada (the “**Sale Agent**”), an affiliate of FTI, undertook a sale and investor solicitation process (the “**SISP**”) in relation to the FCC Secured Property. Transactions were identified in the SISP in respect of the Zealandia Lands and Leasehold Lands and related Equipment for each.

3. On November 12, 2024, the Court approved the transactions for the Zealandia Lands and the Leasehold Lands. The transaction for the Zealandia Lands closed on November 29, 2024, and the transaction for the Leasehold Lands closed on January 30, 2025.
4. No bids were received for the Vigro Lands in the timelines identified in the SISP; however, the Receiver subsequently continued its efforts to solicit interest in the Vigro Lands. In December 2024, the Receiver successfully identified a transaction and entered into an agreement of purchase and sale in respect of the Vigro Lands (the “**Vigro Purchase Agreement**”).
5. On February 4, 2025, the Court approved the transaction for the Vigro Lands and the execution of the Vigro Purchase Agreement by the Receiver (the “**Third Approval and Vesting Order**”). The transaction for the Vigro Lands was completed on March 7, 2025.
6. Given that the Receiver has now successfully closed all sale transactions in relation to the Real Property and related Equipment, the Receiver is of the view that it is appropriate to seek the Distribution, Discharge and Fee Approval Order as defined and described herein.
7. The FCC Secured Property includes certain assets in addition to the Real Property and Equipment (including an insurance policy and intellectual property) (the “**Remaining FCC Secured Property**”). The Receiver continues to undertake efforts to realize on the Remaining FCC Secured Property to the extent reasonably possible and expects to exhaust such efforts prior to its discharge.
8. Accordingly, on this motion, the Receiver seeks among other things, an order approving a distribution to FCC, the fees of the Receiver and its counsel, a termination of these proceedings and a discharge of its duties as Receiver.

Purpose of the Report

9. The purpose of this Fourth Report of the Receiver (this “**Fourth Report**”) is to provide the Court with information regarding:
 - (a) the activities of the Receiver since it issued its Third Report dated January 27, 2025;

- (b) the status of the transaction previously approved by this Court and contemplated by the Vigro Purchase Agreement;
 - (c) the Receiver's cash and disbursements for the period from May 30, 2024 to April 10, 2025;
 - (d) report on the fees of the Receiver and its counsel;
 - (e) the proposed distribution to FCC;
 - (f) the discussions and an agreement with Richter Inc. in its capacity as court-appointed Receiver over certain other assets of the Respondents on an application by Siena Lending Group Canada LLC (the "**Siena Receiver**"); and
 - (g) the termination of these proceedings and proposed discharge of the Receiver.
10. The Fourth Report is filed in support of the Receiver's motion seeking an order (the "**Distribution, Discharge, and Fee Approval Order**"), which, among other things:
- (a) approves a distribution by the Receiver, to FCC, up to the total of \$6,530,000 (plus accrued interest, if any), subject to costs incurred and any necessary or desirable reserves as may be determined by the Receiver;
 - (b) approving the Fourth Report and the conduct and activities of the Receiver described herein;
 - (c) approving the Receiver's statement of receipts and disbursements for the period May 30, 2024 to April 10, 2025;
 - (d) approving the fees of the Receiver in the amount of \$683,548.40 for the period from May 30, 2024 to March 31, 2025, and the fees of the Receiver's counsel in the amount of \$453,367.23 for the period from May 30, 2024 to April 9, 2025;

- (e) terminating these proceedings and discharging the Receiver from the powers, duties and obligations attendant to its appointment as Receiver upon the filing of the Discharge Certificate (defined below); and
- (f) such further and other relief as this Honourable Court may deem just.

Terms of Reference

11. In preparing this Fourth Report, the Receiver has relied upon unaudited financial information provided by Global Food and Ingredients Inc. and GFI Brands Inc. (the “**Debtors**”), including the Debtors’ books and records, certain financial information, forecasts and analysis prepared by the Debtors, and discussions with various parties, including former employees and senior management of, and advisors to, the Debtors (the “**Information**”).
12. Except as otherwise described in this Fourth Report:
 - (a) the Receiver has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would comply with Generally Accepted Assurance Standards pursuant to the Chartered Professional Accountants of Canada Handbook; and,
 - (b) the Receiver has not examined or reviewed financial forecasts and projections referred to in this Fourth Report in a manner that would comply with the procedures described in the Chartered Professional Accountants of Canada Handbook.
13. Future-oriented financial information reported in, or relied on, in preparing this this Fourth Report is based on assumptions regarding future events. Actual results may vary from forecast and such variations may be material.
14. The Receiver has prepared this Fourth Report to assist the Court in deciding whether to grant the Distribution, Discharge, and Fee Approval Order. The Fourth Report should not be relied on for any other purpose.

15. Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian Dollars.

BACKGROUND

16. Each of the Debtors was a member of the GFI group of companies (“**GFI Group**”), Global Food Canada being the purchaser and processor of plant-based foods and ingredients and GFI Brands a brokerage that hired other companies to buy pasta and outsource manufacturing of pasta for the GFI Group.
17. The Receiver was appointed on May 30, 2024 over the FCC Secured Property. On the same day, the Siena Receiver was appointed over certain other assets of the Debtors and Global Food and Ingredients Ltd. constituting ABL Priority Collateral (defined below).
18. Pursuant to an Intercreditor Agreement dated February 1, 2024 between FCC and Siena attached as Exhibit OO to the Affidavit of Jason Inman sworn May 16, 2024 (the “**Inman Affidavit**”) (the “**Intercreditor Agreement**”), FCC and Siena agreed to their respective priorities in respect of their security over the assets of the Debtors. FCC and Siena agreed that FCC would have priority over the “**Term Loan Priority Collateral**” consisting of the following (with capitalized terms as defined in the Intercreditor Agreement):
- (a) all Equipment and fixtures;
 - (b) all Intellectual Property owned by any Loan Party (which includes the Debtors);
 - (c) all Real Property (including the Mortgaged Lands and Leasehold Lands);
 - (d) the insurance policy with respect to the life of David Hanna in the amount of \$1,000,000; and,
 - (e) all books and records relating to the foregoing, all Proceeds of the foregoing, and all collateral security and guarantees given by any Person with respect to the foregoing.
- (collectively, together with any proceeds thereof, the “**FCC Secured Property**”).
- The assets of the Debtors other than the FCC Secured Property are the “**ABL**

Priority Collateral", which includes the Debtors' accounts receivable and inventory. According to the Intercreditor Agreement, FCC has senior priority over the FCC Secured Property and junior priority over the ABL Priority Collateral.

19. The intention of this receivership has been to conduct an orderly liquidation of the FCC Secured Property.

SISP

20. The Receiver obtained an order (the "**SISP Approval Order**") on August 19, 2024 for the sale and solicitation of the FCC Secured Property, which among other things:
 - (a) approved the SISP in the form attached as Schedule "A" to the SISP Approval Order;
 - (b) authorized the Receiver and the Sale Agent to implement the SISP and perform their respective obligations thereunder;
 - (c) approved the Key Consultant Retention Plans ("**KCRP**") in respect of three consultants (the "**Key Consultants**"), and approved the Receiver making payments thereunder; and
 - (d) granted a fixed and specific charge not exceeding an aggregate amount of \$53,450 on the FCC Secured Property for the KCRP (the "**KCRP Charge**").
21. To ensure that time was not lost marketing the property, the Receiver had already started the marketing process, which commenced with the creation of a list of potential bidders and initial reach-outs the week of July 15, 2024.
22. The SISP consisted of a broad marketing process in conjunction with a two-phase process for the solicitation of offers to purchase the FCC Secured Property.
23. The SISP successfully identified proposed transactions for the Zealandia Lands and the Leasehold Lands.

24. The Receiver found a purchaser for the Vigro Lands outside of the SISP, as the Vigro Lands received no bids prior to the conclusion of the SISP.

(i) Zealandia Lands

25. On November 12, 2024, the Receiver brought a motion seeking an approval and vesting order for the Zealandia Lands (the “**First Approval and Vesting Order**”), an approval and vesting order for the Leasehold Lands (the “**Second Approval and Vesting Order**”), and other ancillary relief (the “**Ancillary Relief Order**”) (the “**Sale Approval Motion**”).
26. Harvest Grain Zealandia Ltd. (the “**Zealandia Purchaser**”) submitted an executed copy of a purchase agreement to the Receiver on October 4, 2024, which has since been amended and superseded by an Asset Purchase Agreement dated November 4, 2024 (the “**Zealandia Purchase Agreement**”), between the Receiver, as vendor, and the Zealandia Purchaser, as purchaser.
27. The Zealandia Purchase Agreement was approved by the Court, on November 12, 2024, pursuant to the First Approval and Vesting Order.
28. The Zealandia Purchase Agreement contemplated the purchase, by the Zealandia Purchaser, of the following FCC Secured Property:
- (a) the Zealandia Lands;
 - (b) Books and Records relating to Zealandia Lands; and
 - (c) Equipment and fixtures on the Zealandia Lands,
- (collectively, the “**Zealandia Purchased Assets**”).
29. The Zealandia Purchase Agreement closed as of November 29, 2024 and the Receiver has issued a certificate confirming that all conditions to Closing of the Zealandia Purchase Agreement have all been satisfied by the Zealandia Purchaser and the Receiver.

(ii) Leasehold Lands (Lajord)

30. C2 Farms (the “**Lajord Purchaser**”) submitted an executed copy of a purchase agreement to the Receiver on October 4, 2024, which has since been amended and superseded by an Asset Purchase Agreement dated November 4, 2024 (the “**Lajord Purchase Agreement**”), between the Receiver, as vendor, and the Lajord Purchaser, as purchaser.
31. The Lajord Purchase Agreement was approved by the Court on November 12, 2024, pursuant to the Second Approval and Vesting Order. Among other things, the Second Approval and Vesting Order authorized the Receiver to complete such minor amendments to the Lajord Purchase Agreement as the Receiver may deem necessary, and to take such additional steps and execute such additional documents as may be necessary or desirable for the completion of the transaction under the Lajord Purchase Agreement.
32. The Lajord Purchase Agreement contemplated the purchase, by the Lajord Purchaser, of the following FCC Secured Property:
 - (a) the Leasehold Lands;
 - (b) Books and Records relating to the Leasehold Lands; and
 - (c) Equipment and fixtures on the Leasehold Lands,(collectively, the “**Lajord Purchased Assets**”).
33. At the request of the Lajord Purchaser, the closing conditions for the Lajord Purchase Agreement were amended pursuant to an amending agreement dated January 20, 2025 (the “**Lajord Amending Agreement**”) to, among other things, extend the Outside Date under the Lajord Purchase Agreement from November 15, 2024 to January 31, 2025.
34. The Lajord Purchase Agreement closed as of January 30, 2025, in accordance with the amended Outside Date and the Receiver has issued a certificate confirming that all conditions to closing of the Lajord Purchase Agreement have been satisfied by the Lajord Purchaser and the Receiver.

(iii) Vigro Lands

35. Following the granting of the First Approval and Vesting Order and the Second Approval and Vesting Order, the Receiver continued to advance its discussions with third parties, including those identified by the SISP, to locate a purchaser for the Vigro Lands. The Receiver experienced challenges locating a purchaser due to concerns arising from the potential encroachment of the facility on the Vigro Lands over a neighbouring property.
36. The Receiver continued to engage in discussions and negotiations with third parties to locate a purchaser. In late November 2024, the Receiver received a bid from Foodlife Group Inc. (the “**Vigro Purchaser**”) and entered into a purchase agreement with the Vigro Purchaser on December 2, 2024.
37. On February 4, 2025, the Receiver brought a motion seeking an approval and vesting order for the Vigro Lands (the “**Third Approval and Vesting Order**”) and certain related ancillary relief (the “**Ancillary Relief Order**”).
38. The Vigro Purchase Agreement, contemplated the purchase by the Vigro Purchaser, of the following Vigro Purchased Assets:
 - (a) the Vigro Lands;
 - (b) Books and Records relating to Vigro Lands; and
 - (c) Equipment and fixtures on the Vigro Lands.
39. The Vigro Purchase Agreement closed as of March 7, 2025 and the Receiver has issued a certificate confirming that all conditions to Closing of the Vigro Purchase Agreement have been satisfied by the Vigro Purchaser and the Receiver.
40. The Receiver previously filed a redacted copy of the Vigro Purchase Agreement to protect commercially sensitive information such as the purchase price while the transaction was underway. The Ancillary Relief Order provided that the redacted Vigro Purchase Agreement shall be sealed pending further Order of this Court. At the time the orders were granted, the Siena Receiver requested that the unredacted Vigro Purchase Agreement

become unsealed upon closing of the transaction, the Receiver advised the Court that it would seek to amend the sealing relief at a further motion. As the transaction has now closed, the Receiver has advised the Vigro Purchaser that it intends to seek to unseal the unredacted Vigro Purchase Agreement. As such, the Receiver is requesting that the sealing relief granted in the Ancillary Relief Order now be lifted.

DISTRIBUTION TO SIENA AND FCC

Previous Distribution Relief Sought

41. In the motion record of the Receiver dated January 27, 2025 in support of the Ancillary Relief Order, the Receiver originally requested approval of a distribution to FCC at that time.
42. However, prior to the hearing on February 4, 2025, the Receiver agreed to adjourn its request for approval of the distribution to allow for further discussions with the Siena Receiver in respect of certain amounts claimed by the Siena Receiver. As set out below, the Receiver has now concluded all discussions with the Siena Receiver.

Payment to the Siena Receiver

43. As described above, on May 30, 2024, the Receiver was appointed as receiver over the FCC Secured Property and the Siena Receiver was appointed as receiver over the ABL Priority Collateral.
44. In the course of these two receiverships, the Siena Receiver incurred some general administration costs related to the administration of the Debtors' estate that benefitted both FCC and Siena. For instance, rather than duplicating efforts, the Siena Receiver conducted the *Wage Earner Protection Program Act* remittances in respect of all eligible employees of the Debtors. The Receiver engaged in discussions with the Siena Receiver in respect of these shared costs and other disputed amounts and the two receivers have reached a resolution in respect of the proper sharing of such amounts.
45. In particular, the Receiver has agreed to remit \$34,524 (the "**Shared Receivership Costs**") to the Siena Receiver in respect of shared receivership costs, which amount was paid to the

Siena Receiver on April 2, 2025. On this basis, the Receiver understands that all issues have been resolved with the Siena Receiver and that the Siena Receiver is supportive of the relief sought on this motion.

Proposed Payment to FCC

46. The Receiver received an independent legal opinion from the Receiver's legal counsel, McCarthy Tetrault LLP ("**McCarthys**") with respect to the validity and enforceability of the security granted by the Debtors to FCC. The security opinion indicated that, subject to the customary and standard assumptions, qualifications and limitations contained therein, FCC's security is effective, valid and enforceable against the FCC Secured Property, in accordance with its terms, and is properly registered as against the FCC Secured Property.¹
47. The Receiver is not aware of any pre-filing claims against the FCC Secured Property that rank ahead of FCC.² As outlined in the First Report of the Receiver, while the Receiver determined that there were unearned premiums in respect of terminated insurance policies, it remitted funds to First Insurance Funding of Canada Inc. ("**First**") in respect of the insurance policy that was terminated. All outstanding premiums to First have been paid and, the Receiver is no longer utilizing this policy as the insurance expired on October 1, 2024. Since then, all other insurance policies have been renewed and premiums have been paid upfront (such that no unearned insurance premiums will be included in the amounts to be distributed).³

¹ In providing the security opinion, McCarthys reviewed the security documents provided in the court application materials for the receivership proceeding brought by FCC, prepared by Gowling WLG Canada LLP; McCarthys did not review additional assignments in favour of FCC, guarantees in favour of FCC, or security and mortgage documents relating to real property that is not part of the FCC Secured Property and instead assumes such documents provide additional security to FCC and/or do not limit or impair the FCC Security Documents in any way.

While FCC entered into a Limited Subordination Agreement with 35 Oak Holdings Ltd., this relates to secured property in Alberta that does not form part of the FCC Secured Property.

48. As set out in the Inman Affidavit, as of May 13, 2024, the aggregate outstanding indebtedness owed by the Debtors to FCC was \$15,004,907.17, excluding professional fees, disbursements and accruing interest (the “**Indebtedness**”).
49. Subject to reasonable reserve until its discharge (discussed below), the Receiver requests that the remaining proceeds from the sale of the FCC Secured Property (specifically, proceeds from the Real Property transactions)⁴ after payment of the Shared Receivership Costs, up to the total amount of \$6,530,000 (plus accrued interest, if any) be distributed to FCC (the “**Distribution**”) as partial payment of the Indebtedness, after payment of (i) any administrative costs to be incurred by the Receiver until its discharge, including payment of the Receiver’s borrowings under the Receiver’s Borrowing Charge and (ii) the Receiver’s fees and disbursements and the legal fees and disbursements of the Receiver’s legal counsel.

Remaining FCC Secured Property

50. As mentioned above, the Remaining FCC Secured Property includes certain assets in addition to the Real Property and Equipment, specifically an insurance policy and intellectual property. The Receiver continues to undertake efforts to realize on the Remaining FCC Security Property to the extent reasonably possible and expects to exhaust such efforts prior to its discharge. To the extent that additional proceeds become available, the Receiver will distribute such proceeds as set out in paragraph 49 above.
51. The Receiver does not expect that any additional proceeds obtained from the Remaining FCC Secured Property will result in distributions to FCC greater than \$6,530,000 (plus accrued interest, if any).

⁴ As of May 30, 2024, FCC has the first ranking registered security interest (subject only to court ordered charges made in this receivership proceeding, including the KCRP Charge and Receiver’s Borrowings Charge) against the property that was sold by the Receiver, specifically, the Real Property in Saskatchewan and the personal property located therein. The vehicle leased from De Lage Landen Financial Services Canada Inc. in Saskatchewan was returned and did not form part of the property that was sold. For clarity, none of the sold property consisted of the Debtors’ personal property in Alberta.

RECEIPTS AND DISBURSEMENTS

53. Notes to the Receiver's statements of receipts and disbursements during the Reporting Period are as follows:
- (a) *Proceeds from Sale of FCC Secured Property* includes the proceeds from the Zealandia Purchase Agreement, the Lajord Purchase Agreement, and the Vigro Purchase Agreement, including any GST and PST collected thereon;
 - (b) *Receiver's Certificate Borrowing* includes amounts advanced by FCC pursuant to the Appointment Order, which are secured by the Receiver's Borrowing Charge as

defined therein. These funds were used to fund disbursements required for the administration of the receivership proceedings;

- (c) *Cost Reimbursements* includes amounts received from the purchaser of the Leasehold Lands for costs incurred by the Receiver with respect to the Leasehold Lands;
- (d) *Professional Fees* includes amounts paid to the Receiver and the Receiver's Counsel for the administration of the receivership proceedings;
- (e) *Subcontractors* includes amounts paid to the Key Consultants retained by the Receiver to assist in the administration of the receivership proceedings. This also includes the amounts paid in accordance with the Key Consultant Retention Plans, which are secured by the KCRP Charge, in accordance with the SISP Approval Order;
- (f) *Property Taxes* includes both arrears and current real property taxes paid on the Mortgaged Lands as part of the closings of the sales of the Mortgaged Lands;
- (g) *Insurance* includes amounts paid to First in respect of unearned premiums on certain insurance policies of the GFI Group. This also includes renewal premiums paid to the insurer to ensure appropriate coverage was maintained on the FCC Secured Property;
- (h) *Shared Receivership Costs* includes the amount paid to the Siena Receiver (as discussed above); and
- (i) *Utilities and Repairs and Maintenance* include amounts incurred in the maintenance and upkeep of the FCC Secured Property prior to the sales of the property.

FEE APPROVAL

54. Pursuant to paragraphs 18 and 19 of the Appointment Order, the Receiver and its counsel are to:

- (a) be paid their reasonable fees and disbursements, in each case at their standard rates and charges, whether incurred prior to or subsequent to the date of the Appointment Order; and
 - (b) pass their accounts from time-to-time before the Court.
- 55. Throughout the course of this proceeding, the fees and disbursements of the Receiver have been paid from time-to-time. The Receiver and its counsel have maintained detailed records of their time and disbursements as they relate to this receivership proceeding.
- 56. The Affidavit of Jeffrey Rosenberg sworn April 10, 2025 (the “**FTI Affidavit**”), which is attached as **Appendix “1”** includes at Exhibit “C” thereto, copies of certain invoices rendered by the Receiver in respect of this receivership proceeding.
- 57. For the period from May 30, 2024 to March 31, 2025, the Receiver’s accounts total \$576,608.20 in fees, \$17,781.67 in expenses and disbursements and \$89,158.53 in HST for a total amount of \$683,548.40. At Exhibits “A” and “B” of the Rosenberg Affidavit, there is a summary of the Receiver’s invoices and the personnel, hours and hourly rates charged by the Receiver in respect of the Receivership Proceeding.
- 58. The Receiver estimates that the total fees from April 1, 2025 to the effective date of the Receiver’s discharge will not exceed the amount of \$50,000 excluding taxes barring unforeseen circumstances.
- 59. The Affidavit of Saneea Tanvir, sworn April 10, 2025 (the “**McCarthys Affidavit**”, and together with the FTI Affidavit, the “**Fee Affidavits**”), which is attached as **Appendix “2”**, includes at Exhibit “B” thereto, copies of the invoices rendered by counsel to the Receiver in respect of this receivership proceeding.
- 60. For the period from May 30, 2024 to April 9, 2025, counsel to the Receiver’s accounts total \$390,425.00 in fees, \$10,890.21 in disbursements and \$52,052.02 in HST for a total amount of \$453,367.23. At Exhibit “A” of the McCarthys Affidavit, there is a summary of the Receiver’s invoices and the personnel, hours and hourly rates charged by the Receiver in respect of the Receivership Proceeding.

61. The Receiver's counsel estimates that the total fees from April 1, 2025 to the effective date of the Receiver's discharge will not exceed the amount of \$50,000 excluding taxes barring unforeseen circumstances.
62. The Receiver submits that the fees and disbursements incurred by the Receiver and its counsel, as more particularly described in the Fee Affidavits, are reasonable in the circumstances and have been validly incurred in accordance with the provisions of the Orders issued in respect of this receivership proceeding. The Receiver respectfully requests the approval of the fees and disbursements of the Receiver and its counsel as set out in the Fee Affidavits.

ACTIVITIES OF THE RECEIVER

63. The Receiver's activities, following the issuance of the Third Report, have included, among other things:
 - (a) posting and updating the Receiver's website with all public documents as it relates to the within proceeding;
 - (b) paying the Key Consultants for services provided to the Receiver during the SISP including making payments in accordance with the KCRP;
 - (c) responding to inquiries from various stakeholders;
 - (d) coordinating with the Siena Receiver in respect of various matters and making a payment to the Siena Receiver to cover 50% of its administrative costs as it relates to this Receivership Proceeding;
 - (e) advancing and closing the transaction contemplated by the Vigro Purchase Agreement;
 - (f) attending to other administrative matters relating to these proceedings; and,
 - (g) preparing this Fourth Report and the corresponding motion materials.

DISCHARGE OF THE RECEIVER

64. The Receiver's remaining activities and duties include:

- (a) filing of the Receiver's final report and final statement of receipts and disbursements pursuant to section 246(3) of the *BIA* with the Office of the Superintendent of Bankruptcy;
 - (b) exhausting efforts to realize on the Remaining FCC Secured Property;
 - (c) issuing the Distribution to FCC;
 - (d) filing any required tax returns;
 - (e) such further and other administrative and ancillary matters as may be necessary to complete the administration of the receivership up to the Receivership Termination Date (defined below); and,
 - (f) filing a certificate certifying completion of the administration of the receivership with the Court (the "**Discharge Certificate**"),
- (collectively, the "**Remaining Activities**").

65. Following the proposed Distribution to FCC, subject to this Court's approval, the Receiver will have substantially completed the administration of the receivership, subject to the completion of the balance of the Remaining Activities.

66. Upon completion of the Remaining Activities, the Receiver will file the Discharge Certificate (the "**Receivership Termination Date**"), whereupon the termination of the receivership proceeding and the discharge of the Receiver, and the release of the Receiver, will become effective.

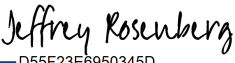
RECOMMENDATION

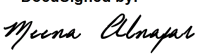
