## **ENDORSEMENT**

- [1] This matter concerns the ongoing insolvency proceedings involving JTI-Macdonald Corp. ("JTI"), Imperial Tobacco Canada Limited and Imperial Tobacco Company Limited (collectively, "Imperial") and Rothmans Benson & Hedges Inc. ("RBH") collectively, the "Tobacco Companies"). This endorsement relates to all three Tobacco Companies.
- [2] The motion proceeded unopposed.
- [3] The Quebec Class Action Plaintiffs bring this motion for a Signing Authorization Order authorizing (i) Quebec Class Counsel to execute and deliver on behalf of the Quebec Class Action Plaintiffs, (ii) PCC Representative Counsel to execute and deliver on behalf of the Pan-Canadian Claimants, (iii) Knight Class Counsel to execute and deliver on behalf of the Knight Class Action Plaintiffs, and (iv) Counsel for the Tobacco Producers to execute and deliver on behalf of the Tobacco Producers and Ontario Flue-Cured Tobacco Growers' Marketing Board, any and all documents as they consider advisable to give effect to the implementation of the CCAA Plans including, as applicable and without limitation, the following documents:
  - a. Claimant Contractual Releases;
  - b. Plan Implementation Certificates;
  - c. Collateral Agency Agreements; and
  - d. Flow of Funds Agreement.
- [4] The CCAA plans relating to each of the Tobacco Companies were sanctioned on March 6, 2025, with reasons reported at 2025 ONSC 1358. Plan Implementation is expected to take place on August 29, 2025.

- [5] It appears to be necessary to grant this relief prior to Plan Implementation.
- [6] Having reviewed the record and hearing submissions, I am satisfied that it is appropriate to grant the requested relief in the form requested. The motion is granted and the order has been signed in the form submitted.
