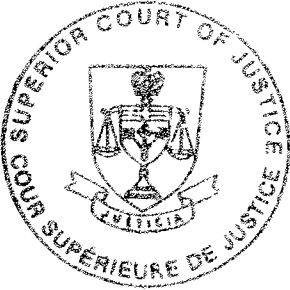



AND WHEREAS Kiameh intends to add Indalex's insurer as a party to the action commenced by Kiameh as against Indalex, et al as Court File No. 05-CV-291742PD1;

AND UPON BEING ADVISED THAT the DIP Agent does not take a position on the within motion;

ON UPON READING the Consent of Kiameh, Indalex and the Monitor, filed,

1. THIS COURT ORDERS AND DECLARES that the stay of proceedings against Indalex is hereby lifted and does not operate in respect of the continuation of the action commenced by Kiameh as against Indalex, in Court File No. 05-CV-291742PD1; provided however that the validity and quantum of Kiameh's claim against Indalex for purposes of any distribution made pursuant to the CCAA remains subject to the Claims Procedure..
