Remedy claimed or sought:

- 1. The Applicants, JMB Crushing Systems Inc. ("JMB Crushing") and 2161889 Alberta Ltd. ("2161889", and together with JMB Crushing, "JMB") seek an order pursuant to the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36, as amended, (the "CCAA") substantially in the form attached as Schedule "A" hereto:
 - (a) Abridging the time for service of this Application to the time actually given, if necessary;
 - (b) Deeming service of this Application good and sufficient;
 - (c) Extending the Stay Period, as defined in the Initial Order granted in these proceedings by the Honourable Justice K.M. Eidsvik on May 1, 2020 (the "**Initial Order**") up to a date determined by the Court; and
 - (d) Such further and other relief as counsel requests and this Honourable Court may grant.

Grounds for making this application:

- 2. On May 1, 2020, the Applicants were granted the Initial Order under the CCAA, among other things:
 - (a) Declaring that the Applicants are companies to which the CCAA applies;
 - (b) Granting a stay of proceedings up to and including May 11, 2020 (the "Stay Period");
 - (c) Approving a sale and investment solicitation process (the "SISP"); and
 - (d) Appointing FTI Consulting Canada Inc. as monitor of the Applicants in these proceedings (in such capacity, the "Monitor").
- 3. Since May 11, 2020, the Applicants have sought and obtained extensions of the Stay Period, which now expires as of September 25, 2020.
- 4. There are currently two bids received pursuant to Phase 2 of the SISP being negotiated by the Monitor, one of which is for the purchase of certain equipment and personal property of JMB Crushing, and the other is for the purchase of substantially all of the core assets of the Applicants (the "Core Asset Bid", and with the first bid, the "Bids").

- 5. Certain secured creditors of the Applicants, the Monitor and the potential purchaser under the Core Asset Bid have been and are continuing to negotiate key issues arising as part of the Core Asset Bid and to prepare the necessary documentation to complete the transaction.
- 6. The Applicants require an extension of the Stay Period to continue to:
 - (a) Finalize terms of the transactions contemplated by each of the Bids (collectively, the "**Transactions**") and bring applications before this Honourable Court for the approval of the Transactions and the transfer and vesting of the assets contemplated thereby;
 - (b) Distribute the proceeds of such Transactions to creditors of the Applicants in accordance with applicable law;
 - (c) Allow additional time to finalize the allocation of the costs of these CCAA proceedings with the Applicants' secured creditors; and
 - (d) Advance potential restructuring alternatives.
- 7. The Applicants have acted and continue to act in good faith and with due diligence.
- 8. No creditor will suffer any material prejudice if the Stay Period is extended as requested.
- 9. Such further and other grounds as counsel may advise and this Honourable Court may deem just.

- 10. Affidavits of Jeff Buck sworn April 16 and April 30, 2020, filed;
- 11. Affidavit of Byron Levkulich sworn September 23, 2020, to be filed;
- 12. Fifth Report of the Monitor dated September 10, 2020, filed;
- 13. Pleadings in the within Action; and
- 14. Such further and other materials or evidence as counsel may advise and this Honourable Court may permit.
