(Stay Extension [and Appointment of Claims Officer](#))

THIS MOTION, made by the Applicants pursuant to the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the “**CCAA**”), for an order extending the Stay Period (as defined in paragraph 17 of the Second Amended and Restated Initial Order, granted May 26, 2021) [and appointing the Honourable Justice Dennis O’Connor as Claims Officer for the disputed Claims described below in accordance with the Claims Procedure Order](#)

[granted by this Court on September 15, 2021 \(the “Claims Procedure Order”\)](#) was heard this day by judicial video conference via Zoom in Toronto, Ontario due to the COVID-19 pandemic.

ON READING the Notice of Motion of the Applicants, the Affidavit of Michael Carter sworn March 1, 2022, including the exhibits thereto (the “**Eighth Carter Affidavit**”) and the Sixth Report of FTI Consulting Canada Inc., in its capacity as monitor (the “**Monitor**”), filed March 2, 2022 (the “**Sixth Report**”), and on hearing the submissions of respective counsel for the Applicants, the Monitor, and such other counsel as were present, no one else appearing although duly served as appears from the Affidavit of Service of [Emily Paplawski](#), affirmed March 1, 2022, filed:

SERVICE

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion Record herein is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further service thereof.

STAY EXTENSION

2. **THIS COURT ORDERS** that the Stay Period is hereby extended until and including March 25, 2022.

APPOINTMENT OF JUSTICE O’CONNOR

3. **THIS COURT ORDERS** that the Honourable Justice Dennis O’Connor is hereby appointed as Claims Officer for purposes of adjudicating the disputed Claims (as defined in the Claims Procedure Order) filed by Trevor Jordet, as proposed class representative in *Trevor Jordet v. Just Energy Solutions, Inc.*, Case No. 2:18-cv-01496-MMB (PC-11175-1), and by Fira Donin and Inna Golovan, as proposed representative plaintiffs in *Fira Donin and Inna Golovan*

[v. Just Energy Group Inc. et al., Case No. 1:17-cv-05787-WFK-SJB \(PC-11177-1\) in accordance with the Claims Procedure Order.](#)

APPROVAL OF MONITOR'S REPORT

4. ~~3.~~ **THIS COURT ORDERS** that that the activities and conduct of the Monitor prior to the date hereof in relation to the Applicants and these CCAA proceedings are hereby ratified and approved.

8. ~~7.~~ **THIS COURT HEREBY REQUESTS** the aid and recognition of any court, tribunal, regulatory or administrative body, having jurisdiction in Canada or in the United States of America to give effect to this Order and to assist the Applicants, the Monitor and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Applicants and to the Monitor, as an officer of this Court, as may be necessary or desirable to give effect to this Order, to grant representative status to the Monitor in any foreign proceeding, or to assist the Applicants and the Monitor and their respective agents in carrying out the terms of this Order.
