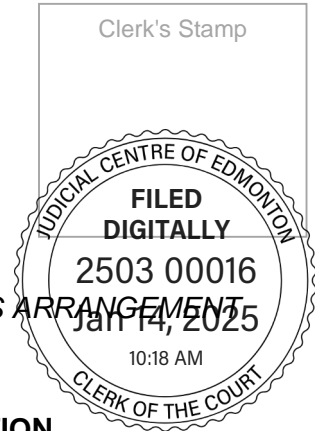

UPON THE APPLICATION of KMC Mining Corporation for an Order sealing the Confidential Supplementary Affidavit of Bryn Jones sworn December 31, 2024 (the "**Confidential Affidavit**"); AND UPON HAVING READ the Confidential Affidavit, and the Affidavit of Service; AND UPON NOTING the Sealing Order granted by Justice J.T. Neilson on December 20, 2024 ("**Dec 20 Sealing Order**") with respect to a Confidential Affidavit of Daniel Klemke sworn December 19, 2024 ("**Dec 19 Confidential Affidavit**") in Court Action #24-3162620 ("**NOI Proceedings**"); AND UPON noting Exhibit "I" of the Affidavit of Daniel Klemke sworn December 6, 2024 ("**Dec 6 Affidavit**") in the NOI Proceedings; UPON HEARING the submissions of counsel for KMC and any other affected parties that may be present; **IT IS HEREBY ORDERED THAT AND DECLARED THAT:**
