TAKE NOTICE that on September 26, 2016, the Applicants sought and obtained an initial order (the “**Initial Order**”) from the Court of Queen’s Bench of Alberta (the “**Court**”) pursuant to the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the “**CCAA**”). The Initial Order provides, among other things, a stay of proceedings in favour of the Applicants until and including October 26, 2016 (the “**Stay Period**”), which may be extended by the Court from time to time. Pursuant to the Initial Order, FTI Consulting Canada Inc. was appointed as monitor (the “**Monitor**”) of the Applicants. In accordance with section 23(1)(a) of the CCAA and paragraph 45 of the Initial Order, a copy of the Initial Order is available on the Monitor’s website at <http://cfcanada.fticonsulting.com/Lightstream>.

During the CCAA proceedings, the Lightstream Group, with the assistance of the Monitor, will be continuing with its previously announced sale process seeking one or more purchasers, investors or financiers in or for the Lightstream Group or the Lightstream Group’s business, properties or assets.

During the course of the CCAA Proceedings, the Lightstream Group’s operations are continuing in the normal course pursuant to the terms of the Initial Order.

Pursuant to the Initial Order, all Persons having oral or written agreements with the Lightstream Group or statutory or regulatory mandates for the supply of goods and/or services are prohibited from discontinuing, altering, interfering with or terminating the supply of goods or services as may be required by the Lightstream Group. The Lightstream Group is entitled to continued use of such services, provided in each case that the normal prices or charges for all such goods or services received after the date of the Initial Order are paid by the Lightstream Group in accordance with the Lightstream Group’s contractual payment terms or normal practices or such other practices as may be agreed upon by the supplier or service provider and the Lightstream Group, in consultation with the Monitor.

The Initial Order provides that the Applicants may make payment of certain pre-filing amounts that, in consultation with the Monitor, are necessary to facilitate the Applicants' ongoing operations.
