#### AFFIDAVIT OF LARS DE PAUW SWORN FEBRUARY 26, 2025

I, Lars De Pauw, of the City of Calgary, in the Province of Alberta, MAKE OATH AND SAY:

1. I am the President of the Applicant, the Orphan Well Association ("OWA"), and as such, I have personal knowledge of the facts and matters deposed to herein, except where facts and matters are stated to be from other sources, in which case I believe those facts and matters to be true.

#### Purpose of this Affidavit

2. I am swearing this Affidavit in support of an Application by the OWA for an Order, among other things, appointing PricewaterhouseCoopers Inc. as receiver and manager (the "Receiver"), pursuant to section 13(2) of the *Judicature Act*, RSA 2000, c J-2, section 99(a) of the *Business Corporations Act*, RSA 2000, c B-9 and section 106.1 of the *Oil and Gas Conservation Act*, RSA 2000, c O-6 (the "OGCA"), without security, of the current

- and future assets and undertakings and properties of every nature and kind whatsoever, including all proceeds thereof, located in Alberta (collectively, the "**Property**") of Long Rung Exploration Inc. ("**Long Run**" or the "**Debtor**").
- The OWA seeks to appoint the Receiver pursuant to its delegated power under the *Orphan Fund Delegated Administration Regulation*, Alta Reg 45/2001 (the "**Regulation**"), which is a regulation enacted under the OGCA. Subsection 3(1) of the Regulation states that the powers, duties and functions of the Alberta Energy Regulator (the "**AER**") to appoint a receiver under section 106.1 of the OGCA are delegated to the OWA.

#### **Background**

- 4. The OWA is an independent, non-profit organization that operates under the delegated legal authority of the AER. The mandate of the OWA is to safely decommission orphaned oil and gas wells, pipelines and production facilities where the owners of such wells, pipelines and production facilities lack the financial ability to do so (or in other words, are insolvent). The OWA is charged with restoring the land on which these assets are located as close to the original state as possible.
- 5. The primary purpose of the OWA is to conduct decommissioning or site reclamation activities on specific properties designated by the AER as "orphans" pursuant to section 70(2) of the OGCA. These include upstream oil and gas wells, pipelines, facilities and their associated sites where the licensee is insolvent or defunct, or is dissolved or struck as a corporation.
- 6. The OWA is overseen by a board of directors made up of appointees from members of the OWA, including the Canadian Association of Petroleum Producers, the Explorers and Producers Association of Canada and the AER.
- 7. In Alberta, there is no industry safeguard beyond the OWA for addressing decommissioning and reclamation of sites left behind by insolvent licensees. Without the OWA, responsibility for such decommissioning and reclamation activities would fall to the Alberta government and ultimately, to the Alberta taxpayer.

- 8. The OWA's position is that licensees are statutorily obligated to fulfill all applicable regulatory responsibilities to address decommissioning, remediation and reclamation obligations associated with their licensed assets.
- 9. To the best knowledge of the OWA, Long Run is a corporation incorporated pursuant to the laws of the Province of Alberta, and carries on business therein as an oil and gas company. Attached hereto and marked as Exhibit "A" is a copy of an Alberta Corporate Registry Search for Long Run dated February 25, 2025.
- 10. The OWA has been advised by the Alberta Energy Regulator (the "AER") that Long Run holds licenses issued by the AER for 4,794 wells, 523 facilities, and 744 pipelines (collectively, the "Licensed Assets"). The OWA has also been advised by the AER that the AER estimates the deemed liability of those Licensed Assets to be \$476,834,036.95.

#### **CCAA Proceedings**

- 11. On July 4, 2024, upon the application of China Construction Bank Toronto Branch ("CCBT"), the Honourable Justice K.M. Horner granted an initial order (the "Initial Order") pursuant to the Companies' Creditors Arrangement Act, RSC 1985, c C-36 (the "CCAA") in respect of Long Run and Calgary Sinoenergy Investment Corp. ("CSIC" and together with Long Run, the "Debtors") which, among other things, imposed an initial stay of proceedings against the Debtors and their assets and appointed FTI as the monitor of the Debtors (in such capacity, the "Monitor").
- 12. Pursuant to the Initial Order, the Monitor was granted enhanced powers including, among other things, the power to:
  - (a) take actions and steps to manage, operate, and carry on the business of the Debtors;
  - (b) preserve, protect and exercise control over the Property (as defined in the Initial Order) of the Debtors;
  - (c) report to, meet, discuss, and share information with affected persons on all matters relating to the Debtors' Business (as defined in the Initial Order) and Property; and

- (d) oversee and direct the preparation and dissemination of financial and other information of the Debtors, including cash flow statements.
- On July 12, 2024, the Honourable Justice J.S. Little granted an Amended and Restated Initial Order (the "ARIO"), which, among other things: (i) extended the stay of proceedings under the Initial Order to July 31, 2024; and (ii) approved an increase to the Administration Charge (as defined in the Initial Order) from \$250,000 to \$500,000.
- 14. On July 30, 2024, the Honourable Justice J.S. Little granted a Second Amended and Restated Initial Order (the "SARIO"), which, among other things:
  - (a) extended the stay of proceedings to October 31, 2024;
  - (b) approved an interim financing term sheet, dated July 23, 2024, between the Debtors and Hiking Group Shandong Jinyue In't Trading Corporation, or an affiliate thereof, (the "Interim Lender"), in the amount of up to \$7,000,000 (the "Term Sheet") and an equivalent charge as security for advances made by the Interim Lender pursuant to the Term Sheet (the "Interim Financing Charge");
  - (c) approved a stalking horse subscription agreement between the Debtor, Long Run Exploration Ltd. ("LRE") and Hiking Group Shandong Jinyue Int't Trading Corporation or its nominee (the "Stalking Horse Purchaser"), dated July 23, 2024 (the "Stalking Horse Bid"); and
  - (d) approved a sale and investment solicitation process in relation to the assets, property, undertakings, and or/business operations of the Debtors (the "SISP").
- On October 14, 2024, the Honourable Justice J.S. Little granted an Order which, among other things: (i) extended the stay of proceedings to December 31, 2024 and the Outside Date (as defined in the Term Sheet) was extended to November 30, 2024 or such further or other date as the Interim Lender and the Monitor may agree to (which was subsequently extended by agreement to January 31, 2025).
- 16. On November 21, 2024, the Honourable Justice D. Mah granted an Approval and Reverse Vesting Order (the "ARVO") approving the transaction contemplated by an amendment of

- the Stalking Horse Subscription Agreement (the "**Transaction**"), with an anticipated closing date of January 31, 2025.
- 17. On December 12, 2024, Henenghaixin Corp. ("H Corp.") applied for leave to appeal the ARVO. The application for leave to appeal the ARVO was dismissed by the Court of Appeal.
- 18. On December 18, 2024, the Honourable Justice P.R. Jeffrey, granted an Order extending the stay of proceedings to January 31, 2025.
- 19. On January 24, 2025, the Honourable Justice J.T. Neilson granted an Order extending the stay of proceedings to February 28, 2025.
- 20. The OWA understands that prior to the expiration of the current stay of proceedings, the Monitor intends to bring an Application to extend the stay of proceedings briefly to allow the OWA to bring its Application to appoint a Receiver over Long Run.

#### Financial Circumstances of Long Run

- 21. I have been advised by the Monitor that there have been delays to the closing of the Transaction due to challenges faced by the Stalking Horse Purchaser transferring money out of China due to regulations of the Chinese State Administration of Foreign Exchange. As of the date of this Affidavit, I understand from discussions with the Monitor that despite attempts to formulate a plan to facilitate the transfer of the funds to allow the Transaction to proceed, it is unlikely that the Transaction will close prior to the expiration of the stay of proceedings, or at all.
- 22. I am further advised by the Monitor that additional funding required and requested by the Monitor under the Term Sheet has not been received and those funds will be required to continue Long Run's operations after the expiration of the stay of proceedings if the Transaction does not close.
- 23. To the best of the OWA's knowledge, Long Run has a number of creditors that with statutory charges, writs of enforcement, and lien regisstrations. Attached hereto and marked as Exhibit "B" is a copy of the Alberta Personal Property Registry (the "PPR")

search results for Long Run, dated February 21, 2025. Creditors with registrations at the PPR against Long Run include the following, in the total amount of \$1,070,540.44:

- (a) Her Majesty the Queen in Right of Alberta in the amount of \$113.40; and
- (b) Municipal District of Smoky River No. 130 in the amount of \$1,070,427.04.
- 24. Based on my review of the Monitor's Fifth Report, dated October 30, 2024, I understand that Long Run has outstanding surface lease rentals owing to various parties that have not been paid in the estimated amount of approximately \$6,500,000.

#### **Necessity of Appointing a Receiver**

- 25. In addition to the reasons outlined above, I believe it is imperative and in the interests of public safety that a receiver and manager be appointed to ensure that Long Run's Licensed Assets are properly cared for, maintained, and shut-in where necessary, given that:
  - (a) the stay of proceedings in the CCAA proceedings is currently set to expire on February 28, 2025;
  - (b) Long Run does not appear to have the financial resources to continue to operate its assets in compliance with the applicable legislative and regulatory obligations, including providing emergency response, if necessary, past February 28, 2025;
  - (c) Long Run has been unable to close the Transaction contemplated by the ARVO;
  - (d) Long Run has had significant time to try and liquidate its business or to obtain funding to continue its operations and has provided no evidence to date that it has any financial operational resources available to it, absent the Interim Financing facility in the CCAA proceedings, for which the Monitor has been unable to access the necessary funds under to continue Long Run's operations;
  - (e) in the event the assets are abandoned and it is necessary for the OWA to provide reasonable care and measures respecting the Licensed Assets, the OWA does not have the power to sell or dispose of Long Run's Property to fund the operation,

abandonment, reclamation, and remediation of the Licensed Assets where necessary; and

- (f) the Licensed Assets post a serious hazard to the public and significant environmental risk if the assets are not properly cared for.
- 26. A receiver is necessary and best suited to oversee the sale of any assets to fund any abandonment and remediation costs associated with the Licensed Assets and to transfer the operational assets to responsible operators.
- 27. I believe the appointment of PwC as Receiver of the Property of Long Run is just and convenient and in the best interest of Long Run's stakeholders and the public generally.
- 28. I make this Affidavit on behalf of the OWA in support of an application for an Order appointing PwC as Receiver over the Licensed Assets of Long Run.
