### **AFFIDAVIT**

I, HEIN FREY, of the City of Paarl, Western Cape, South Africa, AFFIRM THAT:

- 1. I am the Head of North American Mining Operations of Myra Falls Mine Ltd. (referred to in this affidavit as the "Company" or "MFM"). I have been involved in the financial and operational management of the Company since May of 2023. As a result, I have personal knowledge of the matters to which I hereinafter depose save and except where I refer to matters based on information and belief, in which case I verily believe that information to be true.
- 2. Capitalized terms used in this affidavit and not otherwise defined herein have the meaning given to them in my seventh Affidavit affirmed on October 23, 2024 (the "Seventh Affidavit"), or the Order of this Honourable Court granted on December 28, 2023 (the "ARIO").

# Relief Being Sought

- 3. This affidavit is being filed in support of an application by the Company pursuant to the Companies' Creditors Arrangement Act (Canada) (the "CCAA"), for Orders, in the forms to be filed with the Court, among other things:
  - (a) granting a further extension of the Stay Period up to, and including, April 4, 2025;

- (b) authorizing MFM to borrow up to an additional amount of \$3 million (for an aggregate principal amount of \$37 million) pursuant to the terms of the DIP Term Sheet (as amended, including pursuant to the Fourth DIP Amendment (as defined below)), and granting a corresponding increase in the amount of the Interim Lender's Charge, bringing such charge to \$37 million (plus accrued and unpaid interest, fees and expenses);
- (c) approving an auction and liquidation services agreement (the "Auction Agreement") between MFM and Maynards Industries II Canada Ltd. ("Maynards") for the auctioning of certain redundant assets located at the Mine as described in Schedule "A" to the Auction Agreement (collectively, the "Auctioned Assets"), and providing a mechanism for vesting MFM's rights, title and interest in and to the Auctioned Assets when sold to third party purchasers (the "Purchasers"), free and clear of claims and encumbrances (the "Auction Agreement Approval and Vesting Order");
- (d) ordering a mandatory Mediation with respect to the Mediation Objectives (all as defined and set out in more detail below) (the "Mediation Order"); and
- (e) appointing William Kaplan, K.C. ("**Mr. Kaplan**"), as an officer of this Honourable Court (in such capacity, the "**Mediator**") to act as a neutral third party to mediate the Mediation Objectives.

### **Activities Since Prior Court Appearance**

- 4. Since the Company last appeared before this Honourable Court on October 30, 2024, the Company has in good faith and with due diligence:
  - (a) completed its statutorily required care and maintenance plan and submitted it to the Ministry of Mining and Critical Minerals on December 17, 2024;
  - (b) hosted an in-person meeting with the Independent Tailings Review Board (ITRB) in December 2024. The board members commended the Company on the high standard of monitoring during care and maintenance, as well as the significant improvements to site housekeeping standards relative to the previous site tour of July 2023;

- held a semi-annual meeting with the Life of Mine Committee to discuss activities and results of the site environmental monitoring since the previous meeting. The Life of Mine Committee includes delegates from the Company, We Wai Kai, Wei Wai Kum, K'omoks, and Mowachaht Muchalaht First Nations, as well as delegates from various ministries, including the Ministry of Water, Land and Resources Stewardship, Ministry of Environmental and Climate Change Strategy, and the Ministry of Energy, Mines and Low Carbon Innovation. The next meeting is tentatively scheduled for April 2025;
- (d) held five formal meetings with the First Nations Impact Benefit Agreement ("IBA") implementation, socio-economic, and environment committees to discuss environmental monitoring, cultural awareness training development, and the implementation budget. The purpose of the meetings focused on the mutual development of training modules, the development of the joint "Environmental Management Plans", and other business as agreed upon in the IBA:
- (e) maintained ongoing stakeholder engagement with the Campbell River Environment Committee ("CREC") and the Strathcona Park Public Advisory Committee to assure stakeholders of environmental compliance and adequate site management while the operation is in care and maintenance. A total of six meetings (both formal and informal) were held;
- (f) engaged with the regional emergency response coordinator of Strathcona
  Area D and continued discussions on mutual aid. This engagement is focused
  on the regional scale risks and hazards associated with the Mine site and the
  highway access for large scale disaster response planning;
- (g) concluded discussions with the First Nations regarding opportunities to sub-let the main warehouse and the maintenance shop located at the Discovery Terminal. Following these discussions, the Company entered into two subleases with entrepreneurial companies thereby offsetting costs of the terminal facility;
- (h) completed an inspection from an external geotechnical consultant from MineIT of the underground rehabilitation work that was completed in 2024. The

inspection was scheduled in compliance with the Mine's existing permits and as a due diligence exercise to ensure all primary accesses are in good condition and as a general review of Mine stability. No concerns or critical recommendations were reported as a result of the inspection;

- completed three inspections from the Inspector of Mines. Four previously issued dangerous occurrence orders were lifted, with no critical or significant new orders issued as a result of these inspections;
- completed the majority of the transactions required to correct prior DC Plan contributions errors;
- (k) communicated with suppliers and certain lien holders with respect to pre-filing payments owing to them; and
- (I) responding to a letter from the Union with respect to multiple pre-filing grievances, by advising them of the Stay of Proceedings.

## **Auction Agreement**

- 5. On August 2, 2024, this Honourable Court authorized the Tender Process pursuant to the Omnibus Approval Order. The Company, in consultation with the Monitor, designed the Tender Process to broadly canvass the market for interest in various mining equipment and parts referred to as "Assets" in the Tender Process.
- 6. When the Company designed the Tender Process, it anticipated that a large pool of Assets would be offered for sale. However, once the Company completed its comprehensive equipment and inventory part classification (details of which are contained in my Seventh Affidavit), the Company found a number of assets to be of higher value to the Company and potentially needed for a strategic quick restart of mining operations. As such, the Company decided on a narrower list of Assets to be monetized pursuant to the Tender Process.
- 7. The Tender Process launched on October 18, 2024. The deadline for interested parties to submit offers (the "Bid Deadline") was set for November 29, 2024.
- 8. I understand that the sixth report of the Monitor to be filed in connection with this Application will contain further details of the activities of the Company and the Monitor in

carrying out the Tender Process and as such, I only include here information relating to the selection of the Maynards Offer (as defined below) following the conclusion of the Tender Process.

- 9. The Company and the Monitor received offers from three bidders by the Bid Deadline (the "Offers").
- 10. Following the Bid Deadline, the Company, in consultation with the Monitor, reviewed the Offers, deemed all Offers to be "Qualified Offers", and determined that an offer submitted by Maynards (the "Maynards Offer"), which forms the basis of the Auction Agreement, was the best offer received under the Tender Process.
- 11. The Maynards Offer does not contemplate a sale of "Assets" to Maynards. Rather, it contemplates Maynards providing auctioneer services to the Company with respect to the Auctioned Assets, in exchange for a fee and the reimbursement of certain expenses.
- 12. Following negotiations between the Company (assisted by the Monitor) and Maynards, the Company and Maynards entered into the Auction Agreement. A copy of the Auction Agreement is attached hereto and marked as **Exhibit "A"**.
- 13. The main terms of the Auction Agreement are reproduced below:
  - (a) Maynards is to market the Auctioned Assets and carry out an auction (the "Auction") by no later than March 14, 2025, unless otherwise agreed by the parties in writing;
  - (b) Maynards will charge Purchasers, and retain, an 18% buyer's premium with respect to the sale of the Auctioned Assets whether sold individually, collectively, partially, en bloc or otherwise (the "Buyer's Premium"); in addition, the Company will reimburse Maynards for expenses in connection with the Auction (the "Costs") up to an amount of \$25,000;
  - (c) within ten business days following the conclusion of the Auction, Maynards will pay the proceeds of sale of the Auctioned Assets, less the Buyer's Premium, the Costs, applicable taxes and any merchant banking charges (collectively, the "Net Sale Proceeds"), to the Company; and

- (d) the obligations of the parties to the Auction Agreement and the engagement of Maynards by the Company are subject to the approval of this Honourable Court.
- 14. I believe the terms of the Auction Agreement are fair and commercially reasonable and were arrived at in a commercially reasonable manner.
- 15. Considering all Qualified Offers received in the Tender Process, I believe that the Auction Agreement provides the Company with the best opportunity to attain the highest value for the Auctioned Assets.
- 16. I understand that the Monitor supports the approval of the Auction Agreement and the transactions contemplated therein.
- 17. The Interim Lender also supports the approval of the Auction Agreement.
- 18. Since the structure of the Auction Agreement differs from the type of transactions contemplated by the Omnibus Approval Order (i.e. outright sales to the offerors), the Company is seeking the Auction Agreement Approval and Vesting Order.
- 19. I believe that the Auction Agreement Approval and Vesting Order will provide comfort to Purchasers with respect to the quality of the title to the Auctioned Assets that they are purchasing, therefore assisting the Company and Maynards in maximizing the value of the Auctioned Assets.
- 20. The Company is unaware of any secured creditors, except for those with court-ordered charges, who have an interest in the proceeds from any sale of Auctioned Assets. The Company intends to use the proceeds from the sales to fund its operations.

# Appointment of Mediator to Facilitate Union Discussions

21. As noted in my first Affidavit in these proceedings affirmed on December 12, 2023, the Company employs approximately 265 unionized employees who are represented by UNIFOR Local 3019 (the "Union"). The unionized employees, MFM, and the Union are party to a collective bargaining agreement (the "Collective Bargaining Agreement"). The Collective Bargaining Agreement expired in September 2023. The Company and the Union previously engaged in bargaining negotiations to renew the Collective Bargaining Agreement but did not reach an agreement.

- 22. As I stated in my Seventh Affidavit, if the Company is to have a chance to emerge from these proceedings as a financially viable going-concern business, the Company requires, in addition to favourable economic conditions, temporary relief from certain of its Collective Bargaining Agreement obligations, which can only be achieved through negotiations with the Union and its representatives.
- 23. Following the conclusion of the SISP in April 2024, the Company reached out to the Union to set up a meeting to discuss adjusted costs and productivity levels. The Union initially suggested dates for a virtual meeting in June, however, due to scheduling conflicts, the parties ultimately set the meeting date for July 4, 2024 (the "Initial Meeting").
- 24. At the Initial Meeting, the Company delivered a presentation (the "Initial Presentation") providing a life of mine update and explaining the productivity and costs challenges that the Company is facing. At the Initial Meeting, the Company offered to engage a third-party accountant to perform a review of, and provide a report on, historical information of MFM for the 2019-2023 fiscal years (the "Grant Thornton Report"), which report the Company could share with the Union.
- 25. At the Initial Meeting, the Company also asked the Union to provide proposals based on the information received at the meeting as well as that contained in the Grant Thornton Report. The Union declined to put forward any proposals but agreed to further meetings with MFM later in the summer. At the time, the Company had suggested meeting during the week of August 19, 2024.
- 26. On or about July 29, 2024, the Company retained Grant Thornton LLP ("**Grant Thornton**") to produce the Grant Thornton Report, which was ultimately issued by Grant Thornton on October 8, 2024, and delivered to the Union on October 21, 2024.
- 27. On or about August 23, 2024, following negotiations, MFM and the Union entered into a non-disclosure agreement (the "**NDA**") regarding information to be provided to the Union at future meetings.
- 28. In light of (i) the timing of signing the NDA and the hope to deliver the Grant Thornton Report in advance of the next meeting, and (ii) travel requirements of key MFM participants in Union negotiations, after the Initial Meeting, the Company suggested that the next in-person meeting take place one week after the initially suggested week of August 19, 2024. To attend

in-person meetings with the Union, certain key representatives of MFM must fly to Campbell River from Switzerland and South Africa.

- 29. The Union representatives expressed disappointment and frustration at the delay of the meeting originally proposed for the week of August 19<sup>th</sup> and indicated that they could not attend during the week of August 26<sup>th</sup> as suggested by the Company. Ultimately, the parties did agree to meet again, in person, in Campbell River on October 3, 2024 (the "Second Meeting"). At the Second Meeting, the Company presented detailed financial information on the historic operations and losses experienced at MFM and comparative information illustrating the productivity levels and costs challenges at the Mine compared to industry and contractor proposals.
- 30. At the conclusion of the Second Meeting, the Company disclosed in general terms the type of concessions it was hoping to negotiate in order to address the ongoing operating and financial challenges at Myra Falls Mine, and requested a third meeting (the "Third Meeting") to present the Grant Thornton Report and commence negotiations for concessions that would allow for the resumption of mining operations, assuming favourable commodity prices.
- 31. The Third Meeting was scheduled to take place on November 6, 7 and 8, 2024, in person, in Campbell River, though the parties only met on the 6<sup>th</sup> and briefly on the 7<sup>th</sup>. At the Third Meeting, the Company presented a draft Memorandum of Agreement (the "**MOA**") that outlined proposed changes to the Collective Bargaining Agreement that would among other things,: (i) alter the recall obligations with respect to the current priority given to returning workers by seniority; (ii) entitle the Company to use non union labour in certain areas of the Mine's operations; and (iii) create new categories for miners based on industry standard miner classification. The negotiating committee for the Union reviewed the proposal and several hours of discussion ensued about the MOA and the proposed amendments to the Collective Bargaining Agreement.
- 32. After the Company's presentation on November 6<sup>th</sup>, the negotiating committee for the Union expressed a desire to meet privately to discuss the proposed changes to the MOA and no further discussions were held that day.
- 33. The parties met briefly on the morning of November 7<sup>th</sup> at which time the Union expressed a number of concerns about the MOA. Nevertheless, the Union team retired to the local Union Hall to consider the Company proposals again and did submit several

questions to the Company via text and email. Subsequently, the Union team confirmed that, in their view, further discussions would not be fruitful in finding an acceptable path forward.

- 34. The Company did not hear back from the Union following the Third Meeting. On December 27, 2024, in a further attempt to engage with the Union, the Company, through its counsel, provided the Union with a revised MOA including a proposed Collective Bargaining Agreement (the "December Proposal"). Attached and marked as **Exhibit "B"** is a copy of this correspondence, excluding email attachments (the "December Email"). In the Company's view, the December Proposal attempted to address the concerns raised by the negotiating committee for the Union including outlining the temporary nature of the MOA and the Company's commitment to better training programs for Union members.
- 35. In its December Email, labour counsel for the Company, Mr. David McDonald ("Mr. McDonald") of the Fasken firm, asked the Union to confirm whether it had an interest in further meetings (either in person in Vancouver or Campbell River, or virtually) in January to discuss a path forward. Mr. McDonald also asked the Union to provide feedback on the December Proposal in writing.
- 36. On January 7, 2025, the Union provided a brief response to the December Proposal indicating that it was only willing to "roll-forward" the existing Collective Bargaining Agreement for two years, which is not a viable option for the Company. As such, I believe that the discussions between the Company and the Union are at an impasse.
- 37. Absent certain concessions from the Union and an improvement in commodity prices for zinc and copper, the Company will not be able to emerge from these proceedings as an operating Mine but will instead remain on care and maintenance. The Company has been unsuccessful in engaging the Union in meaningful negotiations and the parties are in a deadlock. The Company believes that a neutral Court-appointed mediator and a Court-ordered mediation (the "Mediation") will assist the parties in their discussions by focusing their efforts, minimizing delays in these proceedings, and materially increasing the chances of reaching an agreement.
- 38. I am of the view that the Mediation will foster open dialogue and create a structured and efficient environment for future negotiations.

- 39. The outcome of the Union negotiations will directly impact the Company's ability to resume mining operations and secure additional investments from the Trafigura Group to implement an exit plan from this CCAA proceeding, which will be beneficial to all stakeholders. The Company is of the view that, at this point, the only route to proceed with the negotiations with the Union is through the Mediation.
- 40. Other than the costs related to the Mediation, which the Company proposes to share equally with the Union, I do not believe that there is any prejudice to the Union or the Company participating in the Mediation. The alternative is that the Company's mining operations will remain on care and maintenance for the foreseeable future.
- 41. The Company is seeking the appointment of Mr. Kaplan as a neutral third-party court-appointed mediator. The proposed mandate of the Mediator would be to assist the parties with the negotiations related to the MOA and Collective Bargaining Agreement amendments, and any other matters that are related to or connected with these agreements that are referred to the Mediator by the Company, the Union, the Monitor, or this Court (the "Mediation Objectives"). The Company proposes that the Mediation be mandatory, confidential, and non-binding. All statements, discussions, and documents produced during the Mediation shall remain confidential and not subject to disclosure, except for written settlements reached. If an agreement is reached, it will become binding, subject to Court approval if necessary or advisable.
- 42. Mr. Kaplan has consented to act as a Mediator. I understand that in addition to having years of experience in the restructuring and insolvency industry, Mr. Kaplan also has extensive experience in labour negotiations. As such, I believe that Mr. Kaplan is uniquely positioned among practicing mediators in British Columbia to assist the parties in the Mediation. Attached and marked as **Exhibit "C"** is a copy of Mr. Kaplan's *curriculum vitae*.
- 43. The Company's counsel advised the Union of the Company's intention to seek the Mediation Order on January 15, 2025, with the Union providing a brief response later the same day. On January 17, 2024, Company's counsel provided the Union with the name of the proposed Mediator and the dates for the Mediation. Attached and marked as **Exhibit "D"** is a copy of this correspondence.
- 44. I understand the Monitor and the Interim Lender support the Mediation Order being sought by the Company.

# Increasing the DIP Facility and the Interim Lender's Charge

- 45. On December 17, 2023, the Company entered into the DIP Term Sheet with the Interim Lender. The Initial Order approved the DIP Term Sheet, with a borrowing limit of up to \$4 million. The Initial Order also granted the Interim Lender's Charge to secure the obligations of the Company to the Interim Lender under the DIP Term Sheet to a maximum amount of \$4 million (plus accrued and unpaid interest, fees and expenses).
- 46. The ARIO was granted on December 28, 2023, and, among other things, approved an increase to the borrowing limit under the DIP Term Sheet up to the principal amount of \$21 million, and an increase to the Interim Lender's Charge accordingly.
- 47. The Court approved two additional increases in the borrowing limit, most recently to \$34 million pursuant to the Stay Extension and Additional Relief Order granted on August 2, 2024.
- 48. The Company prepared updated cash flow forecasts through to April 4, 2025 (the "Updated Cashflows"), copies of which will be appended to the Monitor's sixth report to be filed in connection with this application. The Updated Cashflows demonstrate that the Company will require approximately \$3 million of DIP funding during the Stay extension, if extended.
- 49. The Company and the Interim Lender have entered into a fourth amendment to the DIP Term Sheet (the "Fourth DIP Amendment") pursuant to which the Interim Lender has agreed to extend the "Maturity Date" of the DIP Facility to April 4, 2025, and increase the "Maximum Amount" to \$37 million, subject to the conditions contained therein including this Honourable Court's approval. I understand that a copy of the Fourth DIP Amendment will be appended to the Monitor's sixth report, to be filed in connection with this Application.
- 50. As such, the Company now seeks authority to increase its borrowing limit by \$3 million for an aggregate borrowing limit of \$37 million and a corresponding increase to the Interim Lender's Charge.
- 51. The Company relies principally on interim financing to fund its care and maintenance operations and the costs of these proceedings. Though the Company has continued to limit its borrowings under the DIP Facility by cutting costs and monetizing non-core assets, the Company does not have sufficient resources to discharge all of its obligations absent an

increase in the DIP Facility. The Company intends to utilize the additional borrowings, if authorized, in accordance with the Cashflow Statements.

# Stay Extension

- MFM is asking this Honourable Court to extend the Stay Period until April 4, 2025. 52.
- As set out in detailed above, the Company requires additional time to carry out the 53. Mediation, if ordered, and the Auction Agreement, and implement a restructuring transaction, the substance of which depends predominantly on the outcome of the Mediation. The Company continues to work in good faith to advance these proceedings and hopes to emerge from CCAA protection in the coming months as a restructured and viable mining company.
- Should this Honourable Court approve the increased borrowing limit, the Company will 54. have sufficient funds to discharge its obligations during the extension, as per the Updated Cashflows.
- The Interim Lender and the Monitor are supportive of the stay extension. 55.

# **Conclusion**

The Company's actions and efforts detailed herein continue to reflect a deliberate and 56. responsible approach to the Company's financial and operational restructuring, guided by good faith and diligence. The relief being sought by the Company is directly relevant to the success of these proceedings and sustaining care and maintenance operations in accordance with applicable permits and legislation.

### **AUCTION AND LIQUIDATION SERVICES AGREEMENT**

THIS Auction and Liquidation Services Agreement (the "Agreement") dated for reference the \_\_\_\_\_ day of January, 2025,

MADE BETWEEN:

### MYRA FALLS MINE LTD.

(hereinafter referred to as "Myra")

OF THE FIRST PART

AND:

### MAYNARDS INDUSTRIES II CANADA LTD.

(hereinafter referred to as "Maynards" or the "Auctioneer")

OF THE SECOND PART

### WHEREAS:

- A. Pursuant to an order of the Supreme Court of British Columbia (the "Court") made August 2, 2024, Myra is liquidating surplus equipment located at the Myra Falls Mine located in the Strathcona Provincial Park in British Columbia:
- B. The Auctioneer submitted a proposal to Myra dated November 29, 2024 to liquidate the assets listed in Schedule "A" hereto (the "Assets"); and
- C. Myra wishes to retain the Auctioneer to sell the Assets, subject to the approval of the Court and the terms and conditions hereof.

NOW THEREFORE THIS AGREEMENT WITNESSETH that Myra and the Auctioneer agree as follows:

### 1. RETENTION OF THE AUCTIONEER

- 1.1 Myra hereby retains the Auctioneer to carry out, and the Auctioneer hereby agrees to carry out, an auction (the "Auction") with respect to the Assets on the terms and conditions as set forth in this Agreement.
- 1.2 Myra and the Auctioneer covenant and agree with each other to carry out their respective obligations under this Agreement, including without limitation the obligations as set forth in Schedule "B" to this Agreement.
- 1.3 The Auctioneer will not, and has no authority to, incur any liability or obligation on behalf of Myra, unless otherwise specifically authorized and approved by Myra.
- 1.4 Myra and the Auctioneer hereby agree and acknowledge that the parties' obligations hereunder are subject to Court approval of, among other things, the engagement of the Auctioneer and this Agreement. Upon execution of this Agreement by both parties, Myra agrees to recommend the engagement of the Auctioneer and this Agreement to the Court and seek the Court's approval thereof.

### 2. THE AUCTION

- 2.1 The Auctioneer shall have the right to charge the buyers of the Assets an eighteen percent (18%) buyer's premium with respect to the sale of the Assets whether sold individually, collectively, partially, *en bloc* or otherwise (the "Buyer's Premium").
- 2.2 The Auctioneer shall be reimbursed by Myra for expenses related to the Auction (the "Costs") incurred by the Auctioneer, including advertising, set-up, lotting, legal, travel, and checkout costs, up to twenty-five thousand (\$25,000).
- 2.3 The Auctioneer shall carry out the Auction by no later than March 14, 2025, or such other date as agreed by the parties in writing.
- 2.4 Within ten (10) business days following the conclusion of the Auction, the proceeds of sale of the Assets, less the Buyer's Premium, the Costs, applicable taxes and any merchant banking charges (collectively, the "Net Sale Proceeds"), shall be paid by the Auctioneer to Myra in a manner agreed upon by the parties.
- 2.5 The Auctioneer shall, promptly following the conclusion of the Auction, provide Myra with a detailed written accounting describing each Asset sold and the purchase price attributed thereto and the applicable Net Sale Proceeds, in a form satisfactory to Myra acting reasonably.

### 3. REPRESENTATIONS, WARRANTIES AND COVENANTS WITH RESPECT TO THE ASSETS

- 3.1 Myra shall deliver to the Auctioneer a copy of all pertinent documents that are in the possession of Myra, if any, relating to the Assets, including, without limitation, all documents of title, operating manuals, warranties, and all documents respecting registrations.
- 3.2 Myra shall provide, or make commercially reasonable efforts to provide, to the Auctioneer and its agents, employees and representatives, access to the Assets located at Westmin Rd, Comox-Strathcona, BC for the purpose of this Auction (the "Premises") until an agreed upon date by the parties hereto (the "General Deadline"), for the purposes of showing the Assets to prospective purchasers, preparing for and conducting the auctions, completing all sales, and removing the Assets upon their sale. Myra agrees to pay, until the General Deadline at its sole cost, all applicable rent and shall be responsible for the continued supply of all utilities to the Premises including, without limitation, gas, water, heat and hydro, and for the maintenance of insurance coverage on the Premises and Assets (the "Occupancy Costs"). Myra shall provide, and upon reasonable request by the Auctioneer, do, execute and deliver all further assurances, acts and documents for the purpose of conveying right, title, and interest of the Assets to any purchaser contemplated herein.
- 3.3 The Auctioneer shall sell the Assets on an "as is, where is" basis and neither Myra, nor the Auctioneer shall make, vis-à-vis, any third-party purchasers, any representations, conditions or warranties, and there are no representations, conditions or warranties. - 3.4 The Auctioneer has conducted its own due diligence, independent inspection, and investigation respecting the Assets and is satisfied with the Assets in all respects.
- 3.5 Upon completion of the Auction contemplated hereby, the Auctioneer with assistance from Myra shall oversee the removal or preparation of the removal of the Assets from the Premises. The Auctioneer shall otherwise have the right to abandon any remaining or unsold Assets. Any third-party costs or expenses incurred in connection with the clean-up of the Premises to leave in a broom swept condition or storage of

  - (g) provide administrative services relating to the transfer of ownership of Assets to purchasers such that Myra's rights, title and interest in and to the Assets can be conveyed to the purchasers;
  - (h) allow representatives of Myra to be present at any pre-inspections of the Assets, set-up related to the Auction, the Auction and to have access to all of the Auctioneer's records concerning the sale of the Assets;

collect, report and remit any applicable taxes on or with respect to any sale of any Assets by the Auctioneer pursuant to this Agreement, in all applicable jurisdictions;

- (e) the Auctioneer has not jointly elected with Myra pursuant to section 177(1.3) of the Excise Tax Act (Canada); and
- (f) the Auctioneer holds all required permits and licenses required to perform its obligations under this Agreement.

The representations, warranties and covenants of the Auctioneer set forth in this Agreement will survive completion of the transactions contemplated by this Agreement.

# SCHEDULE "B" MYRA AND AUCTIONEER'S RESPONSIBILITIES

The following sets out Myra's and Auctioneer's respective responsibilities with respect to the disposition of the Assets. The parties acknowledge and agree that:

### General

- 1. The Auctioneer is acting only in its capacity as an independent contractor dealing with Myra and is otherwise not a Myra employee or assign, nor is it assuming the legal responsibilities, duties or obligations of Myra or of a "Secured Party".
- 2. The Auctioneer will carry out the Auction in an orderly and professional manner, in accordance with industry practices.
- 3. The Auctioneer will determine the best way of selling the Assets at the Auction. Any offers presented or received prior to the Auction will be discussed with Myra.
- 4. The Auctioneer will not be responsible for the following costs, claims, or liabilities, even if such are payable:
  - (a) lease payments to third parties under any leases of the Assets;
  - (b) any pre-existing environmental costs;
  - (c) any legal costs associated with dealing with liens against the Assets; and,
  - (d) any product warranties, conditions, or liabilities, including without limitation those set forth in the *International Sale of Goods Contracts Convention Act* (Canada).

### Taxes

- 5. The Auctioneer shall collect, and promptly pay to the applicable authority and confirm such payment to Myra, all social services tax, provincial sales tax (if applicable), goods and services tax and any other tax resulting from any sale transaction entered into by the Auctioneer with respect to any of the Assets.
- 6. The Auctioneer shall indemnify and hold Myra harmless from any and all demands, liabilities or claims, including, but not limited to, fines, penalties, losses, costs and expenses, which Myra may sustain, incur or be subject to, arising out of, or by reason of, any failure by the Auctioneer to collect, pay or remit any applicable taxes under, or in accordance with, the provisions of the *Excise Tax Act* (Canada) in relation to the sale of the Assets in accordance with the Auction (including without limiting the generality of the foregoing in respect of the Buyer's Premium described in Section 2.1 of this Agreement).

### Insurance

- 7. The Auctioneer will maintain insurance, and will provide to Myra proof of insurance, with respect to any public liability which could flow from the Auctioneer's activities, naming Myra as beneficiary of such insurance, providing for coverage of not less than \$5,000,000 per occurrence and otherwise in a form satisfactory to Myra acting reasonably.
- 8. Proceeds received on any insurance claim in respect of any insured Assets that otherwise would have been sold during the Auction shall be considered Net Sale Proceeds.
