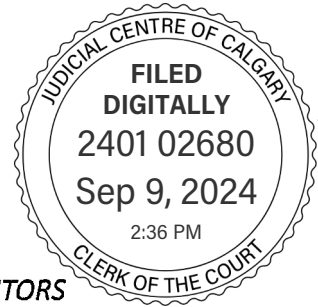

**AFFIDAVIT OF SHELLY WIEBE**

SWORN on the 9 day of September, 2024.

I, Shelly Wiebe, of Valleyview, Alberta, MAKE OATH AND SAY THAT:

1. I am the Taxation and Assessment Coordinator for the Municipal District of Greenview in the Province of Alberta, and as such I have personal knowledge of the matters deposed to herein.
2. Razor Energy Corp. ("**Razor**") is the "assessed person" pursuant to section 304 of the *Municipal Government Act*, RSA 2000, c M-26 (the "*MGA*") in respect of a number of assessable properties located in the MD of Greenview.

3. On May 17, 2024, the MD of Greenview sent its property tax notices to all assessed persons within the County, including to Razor, pertaining to property taxes levied for the 2024 taxation year. In total, Razor owes \$262,809.45 in property taxes to the MD of Greenview in respect of the 2024 taxation year (the “**2024 Property Taxes**”).
4. The deadline for Razor to pay the 2024 Property Taxes was July 2, 2024. Razor failed to pay its 2024 Property Taxes by the deadline.
5. Pursuant to the MD of Greenview’s Tax Penalty Bylaw, a further penalty of \$21,024.77 was imposed on Razor on July 3, 2024 to account for its failure to pay the 2024 Property Taxes by the deadline (the “**2024 Penalties**”).
6. Attached at **Exhibit A** to this affidavit is a spreadsheet which summarizes Razor’s unpaid property tax obligations to the MD of Greenview as of September 5, 2024.
7. To date, Razor has made no payments towards the 2024 Property Taxes and 2024 Penalties.
8. Pursuant to sections 348 and 348.1 of the *MGA*, the 2024 Property Taxes and 2024 Penalties are secured by special liens which attach to any land and improvements to the land for property taxes levied in respect of assessable property other than linear property or machinery and equipment, and to all of Razor’s assessable property located within the municipality, including any assessable improvements to that property for property taxes levied in respect of linear property and machinery and equipment. These special liens take priority over the claims of every person except the Crown.
9. I make this affidavit on behalf of MD of Greenview to oppose the application filed by Conifer Energy Inc. (“**Conifer**”) to require Razor to pay to Conifer any post-filing indebtedness owed to Conifer by September 20, 2024, and to grant Conifer a secured charge over all of Razor’s property, in addition to other relief.
