NOTICE OF MOTION (returnable April 18<sup>th</sup>, 2018)

FTI Consulting Canada Inc., in its capacity as Court-appointed monitor (the "Monitor") in the proceedings of the Applicants pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. c-36, as amended (the "CCAA") will make a motion to a Judge of the Ontario Court of Justice (Commercial List), on Wednesday, April 18<sup>th</sup>, 2018, at 10 a.m. or as soon after that time as the motion can be heard, at the courthouse located at 330 University Avenue, Toronto, Ontario.

**PROPOSED METHOD OF HEARING:** The motion is to be heard orally.

THE MOTION IS FOR:

1 An Order, substantially in the form attached as Schedule "A" hereto (the "Interim Stay Extension and Second Fee Approval Order"):

- (a) abridging the time for service of this Notice of Motion and the seventeenth report of the Monitor dated April 11, 2018 (the "Seventeenth Report"), and dispensing with service on any person other than those served;
- (b) extending the Stay Period (defined below) from April 27, 2018 until and includingMay 11, 2018; and
- (c) approving the fees and disbursements of the Monitor for the period between January 1, 2018 and March 31, 2018 and its counsel, Norton Rose Fulbright Canada LLP ("NRFC") for the period between December 18, 2017 and March 18, 2018 (such periods together, the "Approval Periods").
- 2 Such further and other relief as this Court may deem just.

### THE GROUNDS FOR THE MOTION ARE:

- 1 On June 22, 2017, the Applicants in these proceedings sought and obtained an initial order (as amended and restated on July 13, 2017, the "**Initial Order**") under the CCAA;
- The Initial Order, among other things, appointed FTI Consulting Canada Inc. as Monitor of the Applicants;

### **Stay Extension**

- The Initial Order granted a stay of proceedings until July 22, 2017, or such later date as this Court may order (the "**Stay Period**");
- The Court has since extended the Stay Period until and including April 27, 2018;
- Subject to confirmation of court availability, the Applicants intend to return to Court in early May to provide a further update to the Court on the proposed path forward for these

proceedings, and seek an extension to the Stay Period that will reflect such proposed path forward. The proposed path forward will be informative when determining the required duration of any further stay extension that may be granted at that time;

- In the interim, the Monitor is seeking a brief extension of the Stay Period to May 11, 2018;
- While the Applicants may be in a position to provide such information by the expiry of the current Stay Period on April 27th, 2018, the Monitor understands that it will not be possible to schedule a hearing in connection with these matters at that time;
- 8 The Applicants require the continued stability provided by the Court-ordered stay of proceedings in order to pursue the proposed path forward;
- 9 The Monitor believes that the Applicants have acted and continue to act in good faith and with due diligence and that circumstances exist that make an extension of the Stay Period appropriate;

### **Second Fee Approval**

- The Monitor's Seventeenth Report and the fee affidavits appended thereto in connection with this motion include detailed information on the fees and disbursements of the Monitor and NRFC during the Approval Periods;
- The Monitor believes that the Monitor's and its counsel's fees and disbursements are reasonable in the circumstances and have been validly incurred in accordance with the provisions of the orders issued in these CCAA proceedings.

### **Other Grounds**

- The provisions of the CCAA, including section 11 thereof, and the inherent and equitable jurisdiction of this Court;
- 13 Rules 1.04, 1.05, 2.03, 3.02, 16 and 37 of the *Rules of Civil Procedure*, R.R.O 1990, Reg. 194, as amended; and
- 14 Such other and further grounds as counsel may advise and this Court may permit.

THE FOLLOWING DOCUMENTARY EVIDENCE will be used at the hearing of the motion:

- 1 The Seventeenth Report of the Monitor; and
- 2 Such further and other evidence as counsel may advise and this Court may permit.
