Remedy claimed or sought:

- 1. Sunterra Canada applies for an order, substantially in the form attached as Schedule "A": hereto, which if granted would:
 - (a) Declare that Laurent Ferreira, Chief Executive Officer, and Alexandre Leblanc, Vice President Special Loans (the "Named Witnesses") have detailed knowledge of:
 - a. Internal decision-making policies relating to fraud and specifically, such allegations as they related to current clients
 - The ability of the NBC Officers to opine on approvals and policies with respect to NBC's regulatory obligations;
 - c. Internal policies concerning the use and approval of cheques;

- d. The internal reporting structure within NBC;
- e. Policies and rules respecting the interactions between NBC and other banks;
- f. Policies and rules relating to clearing house rules; and
- g. Oversight of NBC regarding issues raised between NBC and Sunterra in these proceedings.
- That the Named Witnesses are compellable to be questioned as witnesses by Sunterra
 in connection with Sunterra v NBC Claim pursuant to Schedule "A" of the Consent Order
 granted by the Honourable Justice Lema herein on July 24, 2025, filed September 12,
 2025, and pursuant Rules 5.17, 5.18, and 6.8, which are expressly incorporated into that
 Consent Order;
- 3. Order the attendance of the **Named Witnesses** to be questioned under Rule 6.8 pursuant to the declaration sought above.
- 4. Direct that NBC deliver such written instructions and waivers reasonably required by the Named Witnesses, within five (5) days of the date of the Order, and to cooperate in scheduling Named Witnesses' questioning on or before a date to be determined by the Court and provide such other directions regarding the timetable in Schedule "A" to the Consent Order.
- 5. Order any other such relief this court deems to be appropriate

Grounds for making this application:

- 2. The Named Witnesses are corporate officers of NBC and therefore by virtue of their positions have, within Sunterra's view, interactions, roles, and responsibilities which would provide them with additional relevant and material knowledge related to Sunterra's claim. Specifically, the Named Witnesses would have, or appear to have, first hand knowledge of:
 - a. Internal decision-making policies relating to fraud and specifically, such allegations as they related to current clients

- The ability of the NBC Officers to opine on approvals and policies with respect to NBC regulatory obligations;
- c. Internal policies concerning the use and approval of cheques;
- d. The internal reporting structure within NBC;
- e. Policies and rules respecting the interactions between NBC and other banks;
- f. Policies and rules relating to clearing house rules; and
- g. Oversight of NBC regarding issues raised between NBC and Sunterra in these proceedings.
- 3. As a consequence of their positions within NBC, the **Named Witnesses** would have additional firsthand knowledge above that which was provided by NBC previous affiants.
- 4. Pursuant to the Consent Order, Sunterra is granted express permission to identify and have produced for questioning any two additional employees from within NBC in addition to those affiants already produced in this claim.
- 5. The Consent Order expressly provides that "The Defendants in the Action shall file and serve their defences to the Statement of Claim filed in the Action and any (...) by September 5 2025, and [Sunterra] shall advise NBC of the names of any two additional individuals who are current or former NBC employees, officers or directors within the scope of Rules 5.17 and 5.18 associated with NBC.
- 6. Rules 5.17 of the Alberta Rules of Court provides that:

A party is entitled to ask the following persons questions under oath about relevant and material records and relevant and material information:

if the party adverse in interest is a corporation, one or more officers or former officers of the corporation who have or appear to have relevant and material information that was acquired because they are or were officers of the corporation

- 7. The consent order further expressly provides that those individuals to be questioned would be "those identified by the Sunterra Parties as falling within the scope of Rules 5.17 and 5.18".
- 8. The Named witnesses are officers of NBC.

- 9. Sunterra has further determined and identified that the Named Witnesses have or appear to have relevant and material information in relation to this claim
- 10. NBC refused to produce the Named Witnesses on the basis that the Names Witnesses would not have relevant or material information despite not being the party expressly granted authority to make such a determination in the consent order.
- 11. The terms of the proposed order are compliant with Rule 6.8, which governs questioning of witnesses
- 12. The relief requested in proportionate and necessary to ensure both a fair and efficient trial and Sunterra's full realization of the scope of its claim.

Material or evidence to be relied on:

- 13. The Affidavits of Arthur Price, sworn September 18 2025 and October 8, 2025;
- 14. The Consent order of Justice Lema, filed on September 11, 2025
- 15. Such Further materials that material as counsel for NBC may advise and this Honourable Court may permit

Applicable rules:

- 16. Alberta Rules of Court, Alta Reg. 124/2010, rr. 5.1, 5.2, 5.17(1)(a)(ii), 6.8.
- 17. Such further and other rules as counsel for Sunterra may advise and this Honourable Court may permit.

- 18. Companies' Creditors Arrangement Act, RSC 1985, c. C-36, sections 11, 19, and 20.
- Such further and other acts and regulations as counsel for NBC may advise and this Honourable Court may permit
