Remedy claimed or sought: National Bank of Canada ("**NBC**") applies for an Order, substantially in the form attached as Schedule "**B**" hereto:

- 1. Declaring that the time for service of this application (the "**Application**") and the materials in support thereof is abridged to the date of actual service, if necessary, that service of the Application and materials in support thereof on the service list maintained by the Monitor in these proceedings (the "**Service List**") is good and sufficient, and that no persons other than those on the Service List are entitled to service of the Application and materials in support thereof or any orders resulting therefrom;
- 2. Amending the Definition of Compeer v NBC Claim contained in Schedule "A" of the Consent Order (Scheduling) granted in the within action by the Honourable Justice M.J. Lema on July 24, 2025 to add "Compeer Financial" after "Sunterra US Entities" such that the definition of Compeer v. NBC Claim will read:
 - "Compeer v. NBC Claim" means every claim Compeer has or may have against National Bank of Canada (as amalgamation successor to Canadian Western Bank) that is related to, arises from or is in anyway connected to Canadian Western Bank dishonoring cheques issued by Sunterra Farms Ltd. or Sunwold Farms Limited in favour of the Sunterra US Entities or Compeer Financial, PCA.
- 3. Requiring Compeer Financial, PCA ("Compeer") to file an election (the "Compeer Election"), on or before September 30, 2025 (the "Compeer Claims Bar Date"), in which Compeer: (i) indicates whether it intends to advance a claim against NBC in respect of any facts, circumstances or matters that give rise to the Compeer v. National Bank of Canada claim and, if Compeer indicates that it intends to advance a claim, requiring Compeer to: (a) outline the bases of such claim; and (b) provide a range of the quantum of such claim.

- 4. A declaration that if Compeer does not file the Compeer Election on or before the Compeer Claims Bar Date, that Compeer will, subject to further order of this Court, be forever barred, estopped and enjoined from asserting or enforcing the Compeer v. NBC Claim against NBC.
- 5. Such further and other relief as counsel for NBC may advise and this Honourable Court may permit.

Grounds for Making this Application:

- 6. Capitalized terms used herein and not otherwise defined shall have the same meaning(s) as are ascribed to such terms in the Affidavit of Raymond Pai, sworn on August 25, 2025.
- 7. This Application concerns the information that will be available to the Court at the hearings that have been scheduled for December 4 and 5, 2025 to determine aspects of the claims NBC has against the debtor entities and certain of its officers and directors that are the subject of these CCAA proceedings.
- 8. Among the claims that the Court will be called upon to determine at the December hearing are the claims of NBC that it is entitled to indemnification from the debtors and certain of its officers and directors in respect of any claims that Compeer may advance against NBC in connection with Canadian Western Bank (NBC's predecessor) dishonoring cheques issued by Sunterra Farms Ltd. or Sunwold Farms Limited in favour of certain Sunterra US entities or to Compeer for deposit/credit to the accounts of those Sunterra US entities or Compeer. This aspect of the December hearings is partly addressed by this Court's orders granted July 24, 2025.¹
- 9. While the NBC Claims Procedure contemplates that NBC's claims against the Canadian Sunterra Entities for indemnification or contribution "arising out of or in any way connected to the Compeer v. NBC Claim" will be determined as part of the process, there is presently no mechanism by which the Compeer v. NBC Claim may be identified and articulated. The absence of this information is the narrow issue which this Application seeks to remedy.
- 10. Although it is possible to determine and value the NBC v. Sunterra Claim in the absence of such details, the process would benefit from, and would be significantly more efficient and efficacious following, confirmation regarding the scope of the underlying Compeer v. NBC Claim.

- 11. Claims procedure orders are designed to create processes under which all of the creditors of an applicant and its directors and officers can submit their claims for recognition and valuation.²
- 12. The overriding concern of the court at the December application should be to ensure that any claims procedure process is both fair and reasonable.³
- 13. Granting the order requested herein will promote the efficiency and effectiveness of the CCAA process and in particular assist the Court in making its determinations of the claims of NBC vis-à-vis the debtor Sunterra parties at the application scheduled for December 4 and 5, 2025.
- 14. At the same time, there is no prejudice to Compeer in requiring it to:
 - (a) confirm whether it intends to advance a claim against NBC in respect of any facts, circumstances or matters that give rise to the Compeer v. NBC claim and, if so;
 - (b) outline the bases of such claim; and
 - (c) provide a range of the quantum of such claim.
- 15. The relief sought by NBC is narrow in scope, does not require Compeer to *advance* its claims against NBC, nor will it require the Court to *determine* the Compeer v. NBC Claim as part of the Claims Procedure.
- 16. Conversely, if the order is not granted:
 - (a) The Court will lack important information and be hampered in making its determination at the December;
 - (b) NBC may be prejudiced by the lack of information; and
 - (c) The Sunterra parties may be prejudiced as their ability to restructure may be impeded.
