RE: Sunterra Food Corporation, Trochu Meat Processors Ltd., Sunterra Quality Food Markets Inc., Sunterra Farms Ltd., Sunwold Farms Limited, Sunterra Beef Ltd., Lariagra Farms Ltd., Sunterra Farm Enterprises Ltd., Sunterra Enterprises Inc. (collectively, the “Sunterra Group” or the “Applicants”)

On April 22, 2025, the Sunterra Group sought and obtained an order (the “**Initial Order**”) from the Court of King’s Bench of Alberta (the “**Court**”) authorizing that the NOI Proceedings which were commenced on March 24, 2025, be continued under the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the “**CCAA**”). FTI Consulting Canada Inc. was appointed as monitor (the “**Monitor**”) of the Applicants. The Initial Order provides, among other things, a stay of proceedings until April 28, 2025 (the “**Stay Period**”) and may be extended by the Court from time to time. A comeback hearing (the “**Comeback Hearing**”) is scheduled to be heard on April 28, 2025, whereby the Applicants intend to request an extension of the stay of proceedings until July 31, 2025. A copy of the Initial Order and copies of the materials publicly filed in the CCAA proceedings may be obtained at <https://cfcanada.fticonsulting.com/sunterra/>. The Applicants are continuing operations pursuant to the terms of the Initial Order. Please check the Monitor’s website to confirm if the Applicants request for an extension of the stay of proceedings to July 31, 2025, was granted at Comeback Hearing.

Pursuant to the Initial Order and during the Stay Period, all Persons having statutory or regulatory mandates for the supply of goods and/or services or oral or written agreements or arrangements with the Applicants or any of them, including without limitation all computer software, communication and other data services, centralized banking services, payroll services, insurance, transportation, services, utility or other services to the Applicants or any of them are hereby restrained until further order of this Court from discontinuing, altering, interfering with, suspending or terminating the supply of such goods or services as may be required by the Applicants or any of them or exercising any other remedy provided under such agreements or arrangements. The Applicants shall be entitled to the continued use of their current premises, telephone numbers, facsimile numbers, internet addresses and domain names, provided in each case that the usual prices or charges for all such goods or services received after the date of this Order are paid by the Applicant(s) as applicable in accordance with the payment practices of the Applicants, or such other practices as may be agreed upon by the supplier or service provider and each of the Applicants and the Monitor, or as may be ordered by this Court. Please contact the Monitor if you have questions regarding the terms of the Initial Order.

During the Stay Period, no person shall be prohibited from requiring immediate payment for goods, services, use of leased or licensed property or other valuable consideration provided on or after the date of the Initial Order, nor shall any person, be under any obligation on or after the date of this Order to advance or re-advance any monies or otherwise extend any credit to the Applicants.

A list of known creditors of the Applicants as at the date of the Initial Order, including the outstanding balances, has been prepared and is posted on the Monitor's website at under "Other Documents & Notices".

No claims procedure has been approved by the Court and creditors therefore are not required to file a proof of claim at this time.
