### RECEIVER'S MEMORANDUM RESPONDING TO DOCKET No. 22

FTI Consulting Canada Inc., ("the Receiver") through undersigned counsel, provides the following information as required by this Court's Order for Receiver to Identify Alaska Equipment, Lienors, and Lessors with Particularity ("Docket No. 22").

**Description of the Alaska Equipment.** The equipment located in Alaska that is to be transferred to Ritchie Bros. under the Approval and Vesting Order ("Vesting Order") is set out in Schedule A.1 to the Asset Purchase and Sale Agreement<sup>1</sup> and is

Docket No. 8 herein is the Affidavit of Nigel D. Meakin. Exhibit C to that affidavit is the Approval and Vesting Order entered January 15, 2013, approving the Asset Purchase and Sale Agreement. The agreement is attached to that order.

referred to in this motion as "Alaska Equipment." Schedule A.1 lists all of the equipment being sold in Canada and Alaska. Attached as Exhibit A to this Memorandum is an extract of that Schedule A.1 showing only the Alaska Equipment being sold. Exhibit A hereto shows the year, make, model, description, serial number, and allocated price, and a summary of the lien information. The total allocated price for all of the Alaska Equipment is \$7,971,700, out of a total stated purchase price of \$12,043,000.

Ownership of the Alaskan Equipment. The only information that has been filed with the Canadian Court to date with respect to the ownership of the Alaska Equipment is contained in the Chambers Affidavit.<sup>3</sup> As described in paragraph 31 of the Chambers Affidavit, (i) all of the Alaska Equipment is owned by Tercon Equipment Alaska Partnership ("TEAP"); (ii) TEAP acquired ownership of the assets from Tercon Equipment Ltd. ("TEL") in March 2012, but title was not formally transferred at that time; and (iii) on December 6, 2012, TEAP and TEL executed an agreement of purchase and sale effective as of March 1, 2012.

The effect, if any, of the circumstances regarding transfer of title to the Alaska Equipment will be resolved by the Canadian Court. Pending that resolution, all of the sale proceeds of the Alaska Equipment are being escrowed, as described below. To the Receiver's knowledge, no other Tercon entity owns any equipment or other assets in Alaska.

The Asset Purchase and Sale Agreement uses the term "US Equipment," but all the assets sold in the United States are located in Alaska.

See Exhibit A to Docket No. 8.

Some of the Tercon entities leased or rented equipment for use in Alaska on a short term basis from various third party lessor/owners, but all of that equipment has been, or is being, returned to the lessor/owner of that equipment, 4 except for one truck that the Receiver is considering buying out from the lessor. None of that equipment is being sold to Richie Bros. pursuant to the Asset Purchase and Sale Agreement.

**DMV titled equipment.** The only item on the list of Alaska Equipment covered by a Department of Motor Vehicles title is item PU245, a pickup with an allocated value of \$8,500.

**Secured creditors.** Apart from lessors who filed precautionary UCC-1's and whose equipment is being returned to them, there are three creditors with UCC-1's filed in Alaska against any of the Tercon entities:

- Royal Bank of Canada ("RBC") has a broad-form UCC-1 against TEL. RBC claims to be owed approximately \$3.8 million.
- HSBC has broad form UCC-1's against TEAP and Tercon Alaska Ltd. HSBC is the major creditor in the case, and is owed in excess of \$70 million.
- Dumas Holdings, Inc. and HSBC Bank, as Administrative Agent, filed UCC-1's on January 26, 2013, and January 28, 2013, respectively against TEL.

E.g., (1) NC Machinery, lessor of a 303-3280 18 CYD Bucket Loader, on which NC Machinery filed a UCC-1 against TEAP on October 23, 2012; and (2) Emeco Canada, Ltd, lessor of a 2004 Caterpillar Wheel Loader against which Emeco filed a precautionary UCC-1 against TEL on June 21, 2012.

**Statutory Lien creditors**. NC Machinery Co. and Ranier Equipment, Inc. have each filed numerous Alaska statutory liens under AS 34.35.130 and AS 34.35.070 respectively.

NC Machinery's liens are each against an individual item of Alaska Equipment, and the amount of the lien is the repair work performed by NC Machinery on the specific piece of machinery described in the lien. Those liens total \$497,781.60, as summarized on Exhibit B.

Ranier Equipment's liens are also each against individual items of Alaska Equipment, but the amount of each lien appears to be the total amount claimed for hauling all of the Alaska Equipment, namely \$72,907.40. Ranier Equipment's liens are summarized on Exhibit C.

Integrated Distribution Systems LP o/a Wajax Industries and Finning

International have each filed individual liens under Canadian statutory law against individual pieces of Alaska Equipment, as summarized on Exhibit A. Those liens total \$259,230.63.

**Distribution of Proceeds.** The *Distribution Order* entered by the Canadian Court on January 21, 2013, and attached to Docket No. 16 in this case, provides for a regime of various reserves, i.e. funds set aside from the sale proceeds for

various purposes. Section 3(a) of the *Distribution Order* provides for an "Equipment Lien Reserve" to reserve against the claims of statutory lienholders; section 3(b) provides for a "Priority Claims Reserve" for secured creditors; section 3(c) provides for an "APA Reserve" for funds that may need to be returned to the purchaser; section 3(f) provides for a "Possessory Claim Reserve" for holders of possessory liens; and section 3(g) provides for a "Receivership Reserve" for the Receiver's costs. Section 3(h) further provides for a "TEAP Reserve" equal to the balance of the net sale proceeds of the Alaska Equipment, less the amount of the Equipment Lien Reserve held on account of the Alaska Equipment. The Receiver treats the NC Machinery lien claims, and the Ranier Equipment lien claims, as "Registered Liens," and has included the amounts of those liens in the Equipment Lien Reserve.

discretion to distribute money from time to time out of net sale proceeds, excluding the funds set aside in the Reserves. Section 7 of the *Distribution Order* provides that, notwithstanding sections 5 and 6, the TEAP Reserve may not be paid to HSBC, the dominant secured creditor, without further order of the Canadian Court. Section 16 of the *Distribution Order* provides that the Receiver is authorized to bring a motion before the Canadian Court to determine the entitlement of any and all claimants to the Equipment Lien Reserve after the expiration of the Reserve Bar Date. The Reserve Bar Date for filing Claims relating to Registered Liens and Secured Claims is February 15, 2013. Section 17 of the *Distribution Order* provides that the Receiver is authorized, without further order of the Canadian Court, to make disbursements from the Equipment

Lien Reserve to any claimants to the Equipment Lien Reserve that have priority to the dominant secured creditors with their consent or pursuant to a further order of the Canadian Court.

The amounts of the various reserves are subject to constant adjustment as creditors amend their claims and new information comes to the Receiver. However, because the TEAP Reserve, which constitutes the bulk and balance of the net sales proceeds, are being held subject to further Canadian Court order, the only reserves that could potentially be drawn upon without further order of the Canadian Court are the Receivership Reserve for the Receiver's costs, and the payments of accepted claims against the Equipment Lien Reserve.

**Service of this memorandum.** This memorandum is being served to the same creditors previously served with Docket No. 22 on February 8, 2013.
