

3 and Equity Act, R.S.B.C. 1996 C. 253, as amended. The Supreme Court of British Columbia  
4 appoint FTI Consulting Canada, Inc., as Receiver with respect to eleven respondents, who are the  
5 named debtors in the eleven Chapter 15 proceedings commenced in the United States Bankruptcy
