I, PETER A.M. KALINS, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY:

- 1. I am the President, General Counsel and Corporate Secretary of the Applicant Timminco Limited ("Timminco") and the President, General Counsel and Corporate Secretary, as well as a director of the Applicant Bécancour Silicon Inc. ("BSI" and, together with Timminco, the "Timminco Entities") and as such have knowledge of the matters to which I hereinafter depose, except where otherwise stated.
- 2. This affidavit is supplementary to my affidavit sworn May 7, 2012 (the "May 7 Affidavit") and is sworn:
 - (a) In support of a motion by the Timminco Entities for an order declaring that Timminco's obligations under the Agreement (as defined below) constitute pre-filing obligations which are stayed by the Initial Order (as defined below); and
 - (b) In response to a motion brought by J. Thomas Timmins pursuant to s. 32(2) of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as

amended (the "CCAA"), seeking an order that the Agreement not be disclaimed or resiliated.

3. Attached hereto as **Exhibit "A"** is a copy of the Statement of Pension, Retirement, Annuity, and Other Income ("**T4A Form**") (redacted for certain personal information) filed by Timminco with the Canada Revenue Agency in connection with the payments made by Timminco to Mr. Timmins in 2002 (the "**2002 T4A Form**") which, among other things, lists the amount of \$249,999.96 as "Non-eligible retiring allowances".

4. I am advised by Mr. Paul Switzer, an external tax consultant to Timminco, that T4A Forms and/or, following Mr. Timmins becoming a non-resident of Canada in 2008, Statements of Amounts Paid or Credited to Non-Residents of Canada ("NR4 Forms") listing similar amounts under the category of "Retiring Allowances" have been filed by Timminco in respect of Mr. Timmins in each year from 2002 through to 2011.

5. I am also advised by Mr. Switzer, Heidi Koch, Timminco's Corporate Securities Clerk & Office Manager, and Lisa Girard, Timminco's Accounts Payable Analyst and Payroll Clerk, that Mr. Timmins did not at any time request Timminco to amend or refile the 2002 T4A Form or any of the other T4A Forms filed by Timminco since 2002.

6. This affidavit is sworn in respect of the motions described in paragraph 2 hereof and for no improper purpose.
