Remedy claimed or sought:

1. FTI Consulting Canada Inc., in its capacity as Court-appointed receiver and manager (the "Receiver") of the assets, undertakings and properties (the "Property") of Wolverine Energy and Infrastructure Inc., Wolverine Equipment Inc., Wolverine Construction Inc., HD Energy Rentals Ltd., BHW Employment Services Inc., Flo-Back Equipment Inc., Liberty Energy Services Ltd. and Western Canadian Mulching Ltd. (collectively, the "Wolverine Group" or the "Debtors"), seeks an Approval and Vesting Order substantially in the form attached as Schedule "C" to this Application:

- (a) declaring that the time for service of the within Application and supporting materials be abridged if necessary, that the Application is properly returnable on the scheduled date and that service of the Application on the Service List attached hereto as **Schedule "B"** is validated and deemed to be good and sufficient, and that further service of the Application be dispensed with;
- (b) approving a transaction that would authorize the Receiver to sell approximately 873,015 common shares in Fleet Energy Ltd. (the "Fleet Energy Shares") held by the Debtors, to Fleet Energy Ltd. (the "Purchaser"), as set out and described in the sixth report of the Receiver, dated February 11, 2025 (the "Sixth Report"), and vesting title in the Fleet Energy Shares in the Purchaser;

- (c) approving the actions, conduct and activities of the Receiver in respect of the administration of the Debtors' receivership estate, and the fees and disbursements of the Receiver and its legal counsel, as set out and reported in the Sixth Report;
- (d) approving an interim distribution to Fiera Private Debt Fund V LP and Fiera Private Debt Fund VI LP ("**Fiera**") of the Purchase Price for the Fleet Energy Shares;
- (e) approving the Proposed Second Interim Distribution to Canadian Western Bank ("CWB") and Fiera, as that term is described and defined in the Sixth Report; and
- (f) granting leave to the Receiver to apply or reapply to this or any court or administrative body in any province of Canada for advice, assistance and directions as may be necessary to carry out the terms of the Order sought.
- 2. A Restricted Court Access Order in substantially the same form as that attached as Schedule "D" (the "Restricted Court Access Order") to this Application, providing the following relief:
 - (a) directing the limited sealing of Confidential Appendix "A" to the Sixth Report of the Receiver (the "Confidential Appendix").
- 3. A Bankruptcy Order in substantially the same form as that attached as Schedule "E" to this Application, declaring and adjudging that:
 - (a) each of Wolverine Energy and Infrastructure Inc., Wolverine Equipment Inc., Wolverine Construction Inc., HD Energy Rentals Ltd., Flo-Back Equipment Inc., Liberty Energy Services Ltd. and Western Canadian Mulching Ltd. (collectively, the "Proposed Bankrupts"), being corporations incorporated pursuant to the laws of the Province of Alberta, be adjudged bankrupt and that a Bankruptcy Order be made in respect of the property of the Proposed Bankrupts; and
 - (b) FTI Consulting Canada Inc. ("**FTI**") be appointed as trustee in bankruptcy of each of the Proposed Bankrupts.
- 4. Such further and other relief, advice and directions as counsel may advise and this Honourable Court may deem just and appropriate.

Grounds for making this Application:

Background

- 5. Pursuant to a Consent Receivership Order granted on December 8, 2023, as amended on December 22, 2023 (the "Receivership Order"), the Receiver was appointed as the receiver and manager of the Property of the Debtors and was tasked with amongst other things, identifying, securing, arranging for sale and monetizing the Property the Debtors.
- 6. Pursuant to the terms of the Receivership Order, and in particular subparagraph 3(k) thereof, the Receiver was empowered and authorized to market any or all of the Debtors' Property, including advertising and soliciting offers in respect of the Debtors' Property or any part or parts thereof and negotiating such terms and conditions of sale as the Receiver, in its discretion, may deem appropriate.
- 7. Pursuant to subparagraph 3(l) of the Receivership Order, the Receiver was empowered and authorized to sell, convey, transfer, lease or assign the Debtors' Property or any part or parts thereof out of the ordinary course of business, with or without approval of the Court, dependent on whether certain monetary thresholds are met.

Sale of Fleet Energy Shares

- 8. The Receiver currently holds the Fleet Energy Shares as part of the Property of the Debtors.
- 9. The Receiver, in consultation with Fiera, has considered various options to market and sell the Fleet Energy Shares. To this end, the Receiver has expended a considerable amount of time and effort in order to assess the best approach to realize on the Fleet Energy Shares.
- 10. For the reasons summarized in the Receiver's Sixth Report, including consideration of the results of an independent valuator report (the "Valuation Report"), the Receiver has determined that the appropriate course of conduct in the circumstances is the sale of the Fleet Energy Shares to Fleet Energy Ltd. Furthermore, Fiera is the fulcrum creditor in these receivership proceedings and stands to suffer a substantial loss upon completion of the proceedings, as such they are the only party with a financial interest in the sale of the Fleet Energy Shares. Fiera is supportive of the proposed sale of the Fleet Energy Shares.

- 11. It is proposed that the Purchase Price for the Fleet Energy Shares be distributed in full to Fiera, as the secured creditor over the Fleet Energy Shares.
- 12. The sale of the Fleet Energy Shares to the Purchaser at this time would be appropriate, and in the best interest of the receivership estate.
- 13. The terms as set out in the proposed form of Approval and Vesting Order attached hereto as Schedule "C" are necessary to effect the sale of the Fleet Energy Shares to the Purchaser, and the approval of the Receiver's and its counsel's actions, conduct and activities.

Restricted Court Access Order

- 14. The Confidential Appendix contains the Valuation Report, which includes matters and commentary of a sensitive commercial nature, including certain valuation information relating to the Fleet Energy Shares (the "Confidential Information").
- 15. The publication or dissemination of the Confidential Information could result in prejudice to the sale of the Fleet Energy Shares, and diminished recovery to the Company's stakeholders, should the transaction not close. It may also result in prejudice to Fleet Energy Ltd.
- 16. The Restricted Court Access Order sought is the least restrictive and prejudicial alternative to prevent the dissemination of the commercially sensitive Confidential Information, such that is fair and just in the circumstances to restrict public access to the Confidential Information.
- 17. The terms as set out in the proposed form of Restricted Court Access Order attached hereto as Schedule **Error! Reference source not found.** are necessary to effect the sealing of the Confidential Appendix.

Proposed Second Interim Distribution

- 18. CWB and Fiera each hold valid and enforceable senior ranking security in respect of the Property of the Debtors.
- 19. The Receiver currently holds approximately \$8.4 million in funds that have been obtained from the realizations on the Debtors' Property.

20. The Receiver is of the view that an interim distribution in the approximate amount of \$4.0 million to CWB, and \$4.2 million to Fiera, is appropriate at this time, and is in the best interest of the receivership estate and the stakeholders affected thereby.

Approval of Actions, Conduct and Fees

- 21. The actions, conduct and activities of the Receiver to date in respect of the administration of the Debtors' receivership estate, and the fees and disbursements of the Receiver and its legal counsel, as set out and reported in the Sixth Report, have been reasonable, appropriate, and necessarily incurred in the course of these receivership proceedings.
- 22. CWB and Fiera, as the senior secured creditors of the Debtors, support the Application of the Receiver.

Bankruptcy Order

- 23. The Proposed Bankrupts are each insolvent persons within the meaning of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3, as amended, and has at some time during the year immediately preceding the filing of this Application resided or carried on business in the City of Calgary, in the Province of Alberta. The Proposed Bankrupts are within the jurisdiction of this Honourable Court, and their registered addresses are as follows:

- 24. Pursuant to the terms of the Receivership Order, and in particular subparagraph 3(q) thereof, the Receiver is authorized and empowered to enter into agreements with a trustee in bankruptcy appointed in respect of the Debtors. Pursuant to paragraph 29 of the Receivership Order, nothing in the said Receivership Order shall prevent the Receiver from acting as a trustee in bankruptcy of the Debtors.

- 25. The Wolverine Group receivership proceedings remain ongoing as at the present date.
- 26. As at February 11, 2025, the Proposed Bankrupts are collectively justly and truly indebted to its creditors in the approximate sum of \$73.4 million, plus interest and costs continuing to accrue.
- 27. Within the 6 months preceding the filing of this Application for Bankruptcy Order, the Proposed Bankrupts have each failed to meet their liabilities generally as they become due, and such obligations exceed \$1,000.
- 28. There are no remaining directors within the Proposed Bankrupts and all of the employees, including senior management of the Proposed Bankrupts, have been terminated.
- 29. A bankruptcy process with respect to the remaining property of the Proposed Bankrupts will allow for an efficient and orderly winding down of the estate, and will allow for an alignment of priority claims and the crystallizing of various creditor claims.
- 30. Deryck Helkaa of FTI Consulting Canada Inc. ("FTI"), of the City of Calgary, in the Province of Alberta, confirms that FTI is a person qualified to act as trustee in bankruptcy (the "Proposed Trustee") of the property of the Proposed Bankrupts, and has agreed to act as such.
- 31. The terms as set out in the proposed form of Bankruptcy Order attached hereto as Schedule "**D**" are necessary to effect the bankruptcy of the Proposed Bankrupts, as contemplated by the Receiver.
- 32. CWB and Fiera support the proposed Bankruptcy Order and support FTI to act as the Proposed Trustee.
- 33. Such further and other grounds as counsel may advise and this Honourable Court may permit.

UPON THE APPLICATION of FTI Consulting Canada Inc. ("FTI"), having an office at 1610, 520, 5th Ave SW, Calgary, AB T2P 3R7, in its capacity as the Court-appointed receiver and manager (the "Receiver") of the assets, properties and undertakings of Wolverine Energy and Infrastructure Inc., Wolverine Equipment Inc., Wolverine Construction Inc., HD Energy Rentals Ltd., BHW Employment Services Inc., Flo-Back Equipment Inc., Liberty Energy Services Ltd. and Western Canadian Mulching Ltd.; AND UPON having read the Consent Receivership Order granted on December 8, 2023, as amended on December 22, 2023; AND UPON having read the Receivership Order filed December 8, 2023, as amended on December 22, 2023, the Application filed February 10, 2025 and the sixth report of the Receiver dated February 11, 2025 (the "Sixth Report") and Confidential Appendix "A" to same; AND UPON having read the Affidavit of Service of Samantha Hawley, sworn and filed February __, 2025; AND UPON hearing from counsel to the Receiver, counsel to Canadian Western Bank, counsel to Fiera Private Debt Fund V LP and Fiera Private Debt Fund VI LP and from any other interested parties who may be present; AND UPON it appearing that all interested and affected parties have been served with notice of this Application; AND UPON it appearing to the Court that the following acts of bankruptcy have been committed by the Debtor:

- (a) the debts owing by each of Wolverine Energy and Infrastructure Inc., Wolverine Equipment Inc., Wolverine Construction Inc., HD Energy Rentals Ltd., Flo-Back Equipment Inc., Liberty Energy Services Ltd. and Western Canadian Mulching Ltd. (collectively, the "**Debtors**") exceed \$1,000; and
- (b) within the 6 months preceding the date of filing of the Application for Bankruptcy Order, each of the Debtors ceased to meet their liabilities generally as they became due.

IT IS HEREBY ORDERED AND DECLARED THAT:

- 1. Service of the notice of this Application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this Application, and the time for service of this Application is abridged to that actually given.
- 2. FTI is permitted and authorized to be appointed as trustee in bankruptcy of the estate of each of the Debtors, without security.

- 3. FTI is permitted and authorized, upon attending to the necessary filings with the Office of the Superintendent of Bankruptcy, to assign the Debtors or any of them, each corporations incorporated pursuant to the laws of the Province of Alberta, into bankruptcy.
- 4. FTI, and any other interested party, shall be at liberty to apply for further advice, assistance and directions as may be necessary in order to give full force and effect to the terms of this Order.
- 5. This Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals regulatory and administrative bodies are hereby respectfully requested to make such orders as to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
- 6. Service of this Order shall be deemed good and sufficient by:
 - (a) Serving the same on:
 - (i) the persons listed on the service list created in these proceedings;
 - (ii) any other person served with notice of the application for this Order;
 - (iii) any other parties attending or represented at the application for this Order; and

and service on any other person is hereby dispensed with.
