

**NAME OF JUSTICE WHO MADE THIS ORDER:** The Honourable Justice C.D. Simard

**UPON THE APPLICATION** by FTI Consulting Canada Inc. in its capacity as the licensed insolvency trustee (the "Trustee") of the bankrupt estates of Wolverine Energy and Infrastructure Inc. ("WEI"), Wolverine Equipment Inc., Wolverine Construction Inc., Western Canadian Mulching Ltd., HD Energy Rentals Ltd., and Liberty Energy Services Ltd. for an order (among other things) declaring that certain transactions totaling \$1,011,950.35 from WEI to 1586329 Alberta Ltd. and Wolverine Management Services Inc. (the "**Douglas Corporations**") be set aside and are void against the Trustee, and therefore the Douglas Corporations and Jesse Douglas ("Mr. Douglas", and collectively with the Douglas Corporations, the "Respondents") are directed to repay \$1,011,950.35 to the Trustee on behalf of the estate, plus costs; AND UPON HAVING READ the First Report of the Trustee, filed August 29, 2025 (the "First Report"); AND UPON HAVING READ the Brief of Law of the Trustee filed August 29, 2025; AND UPON HAVING READ the Brief of Law of the Respondents filed October 30, 2025; AND UPON HAVING READ the Affidavit of Jesse Douglas filed October 28, 2025; AND UPON HAVING READ the Affidavit of Nikolaus Kiefer filed October 28, 2025; AND UPON HAVING READ the Reply Brief of the of the Trustee filed on November 3, 2025; AND UPON HEARING the submissions of counsel for the Trustee, Jesse Douglas, and such other parties present at the hearing of this Application; AND UPON **PROVIDING AN ORAL DECISION** on November 1, 2025;

## IT IS HEREBY ORDERED THAT:

- 1. Capitalized terms used but not otherwise defined in this Order shall have the meaning given to such terms in the First Report of the Trustee.
- 2. Service of notice of this Application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this Application and time for service of this Application is abridged to that actually given.
- 3. The Impugned Transactions were:
  - (a) transfers at undervalue pursuant to paragraph 96(1)(b) of the BIA;
  - (b) preferences under the FPA; and
  - (c) transfers under the SOE.

- 4. Wolverine Management Services Inc. must repay \$486,950.00 to FTI.
- 5. 1586329 Alberta Ltd. must repay \$525,000.00 to FTI.
- 6. FTI is awarded costs in the amount of \$5,735.00.
- 7. Mr. Douglas is personally liable to FTI for the amounts set out in paragraphs 4-6.
- 8. The remainder of the relief sought by FTI not specifically ordered herein is dismissed.
- 9. Service of this Order shall be deemed good and sufficient by:
  - (a) Serving the same on:
    - (i) the persons listed on the service list created in these proceedings;
    - (ii) any other person served with notice of the application for this Order;
    - (iii) any other parties attending or represented at the Application for this Order; and
    - (iv) Posting a copy of this Order on the Trustee's website at:

and service on any other person is hereby dispensed with.
